Notice is hereby given that application has been made to the Board of Trade for an alteration of the following proviso to No. B (6) of the Regulations which have been made by the Board of Trade for ensuring a proper and sufficient supply of energy, viz.:—

"Provided that no change shall be made in the pressure of the supply to any premises which, at the date of these Regulations, are supplied with energy by the Undertakers, except with the consent of the Consumer."

The alteration applied for is, that for the words "with the consent of the Consumer" there should be substituted the words "on such terms and conditions as may be agreed upon between the Undertakers and the Consumer, or failing agreement, as may be settled by an Arbitrator appointed by the Board of Trade," or words to that effect.
