This Officer went out on five different occasions and assisted to bring in two guns and three limbers, one of which he, Captain Humphreys, and some Gunners, dragged in by hand.  He also went out with Captain Humphreys and Lieutenant Stirling to try to get the last gun in, and remained there till the attempt was abandoned.  During a previous Campaign (the Chitral Expedition of 1895) Lieutenant Maxwell displayed gallantry in the removal of the body of Lieutenant-Colonel F. D.
