# CORONATION OF THEIR MAJESTIES.

# COURT OF CLAIMS.

THE Right Honourable the Commissioners appointed by His Majesty to hear and determine all Claims of Services to be performed at the time of the ensuing Coronation (except those dispensed with by His Majesty's Royal Proclamation of the 26th day of June last), and of fees to be received for the same, at their last meeting held at the Council Office, Whitehall, on the 17th day of July last, resolved as follows:—

- 1. All Claims must be made by Petition. Petitions may be sent under cover to the Clerks of the Court of Claims, Privy Council Office, Whitehall.
- 2. Petitioners are not required to appear in person before the Court, unless summoned.
- 3. Petitioners may appear by Solicitors, Agents, or Counsel.
- 4. If a Claim was admitted in 1838, the Court will forthwith admit such Claim, provided the Commissioners are satisfied that the present Petitioner represents the person whose Claim was admitted in 1838, and that there is no counter-claim.
- 5. Petitioners to be requested to present their Claims on or before the 31st day of October 1901.

The Court stood adjourned till some day in the month of November next, of which notice will be given in the London Gazette.

The Commissioners are required by the Proclamation to exclude from their consideration such Claims as may be submitted to them in respect of rights or services connected with the parts of the Ceremonial heretofore performed in Westminster Hall and with the Procession, the Ceremony being confined to Westminster Abbey.

The Earl Marshal's Order concerning the Robes, Coronets, &c., which are to be worn by the Peers at the Coronation of Their Most Sacred Majesties King Edward the Seventh and Queen Alexandra.

These are to give notice to all Peers who attend at the Coronation of Their Majesties, that the robe or mantle of the Peers be of erimson velvet, edged with miniver, the cape furred with miniver pure, and powdered with bars or rows of ermine (*i.e.*, narrow pieces of black fur), according to their degree, viz. :--

Barons, two rows.

Viscounts, two rows and a half.

Earls, three rows.

Marquesses, three rows and a half.

Dukes, four rows.

The said mantles or robes to be worn over full Court dress, uniform, or regimentals.

The coronets to be of silver gilt; the caps of crimson velvet turned up with ermine, with a gold tassel on the top; and no jewels or precious stones are to be set or used in the coronets, or counterfeit pearls instead of silver balls.

The coronet of a Baron to have, on the circle or rim, six silver balls at equal distances.

The coronet of a Viscount to have, on the circle, sixteen silver balls.

The coronet of an Earl to have, on the circle, eight silver balls, raised upon points, with gold strawberry leaves between the points.

The coronet of a Marquess to have, on the circle, four gold strawberry leaves and four silver balls alternately, the latter a little raised on points above the rim.

The coronet of a Duke to have, on the circle, eight gold strawberry leaves.

The Earl Marshal's Order concerning the Robes, Coronets, &c., which are to be worn by the Peeresses at the Coronation of Their Most Sacred Majesties King Edward the Seventh and Queen Alexandra.

These are to give notice to all Peeresses who attend at the Coronation of Their Majesties, that the robes or mantles appertaining to their respective ranks are to be worn over the usual full Court dress.

That the robe or mantle of a Baroness be of crimson velvet, the cape whereof to be furred with miniver pure, and powdered with two bars or rows of ermine (*i.e.*, narrow pieces of black fur), the said mantle to be edged round with miniver pure two inches in breadth, and the train to be three feet on the ground; the coronet to be according to her degree, viz. :--a rim or circle with six pearls (represented by silver balls) upon the same, not raised upon points.

That the robe or mantle of a Viscountess be like that of a Baroness, only the cape powdered with two rows and a half of ermine, the edging of the mantle two inches as before, and the train a yard and a quarter; the coronet to be according to her degree, viz. :—a rim or circle with. pearls (represented by silver balls) thereon, sixteen in number, and not raised upon points.

That the robe or mantle of a Countess be as before, only the cape powdered with three rows of ermine, the edging three inches in breadth, and the train a yard and a half; the coronet to be composed of eight pearls (represented by silver balls) raised upon points or rays, with small strawberry leaves between, above the rim. That the robe or mantle of a Marchioness be

That the robe or mantle of a Marchioness be as before, only the cape powdered with three rows and a half of ermine, the edging four inches in breadth, the train a yard and three quarters; the coronet to be composed of four strawberry leaves and four pearls (represented by silver balls) raised upon points of the same height as the leaves, alternately, above the rim.

That the robe or mantle of a Duchess be as before, only the cape powdered with four rows of ermine, the edging five inches broad, the train two yards; the coronet to be composed of eight strawberry leaves, all of equal height, above the rim.

And that the caps of all the said coronets be of crimson velvet, turned up with ermine, with a tassel of gold on the top.

Note.—Only those Peers and Peeresses who reply to the above intimation before the first day of January 1902, will receive the Royal Command to attend the Ceremony of the Coronation.

It is to be understood that the above Orders refer to all English, Scottish, and Irish Peers (except Peers who are minors, and Irish Peers who have seats in the House of Commons), Peeresses in their own right, the widows of Peers, and the wives of living Peers, including the wives of Irish Peers who have seats in the House of Commons.

With respect to such widows of Peers who have remarried under the rank of the Peerage, they, according to former precedent, are considered as not entitled to such summons.

As to widows of Peers who have remarried with a Peer of lower degree, their precedence, according to precedent, is that of their last husband.

Peers and Peeresses in their own right, whose highest dignity is in the Peerage of Scotlarid or Ireland, will wear robes and coronet of such dignity, as also the wife or widow of such Peer.

#### Alteration of Parish Areas.

# ORDER No. XLIII.

# PARISHES OF KIRKCALDY, DYSART, ABBOTS-HALL, AND KINGHORN (NEW PARISH OF KIRKCALDY AND DYSART).

W HEREAS it was recently represented to me by the Parish Council of Kirkcaldy that I should issue an Order, under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act 1894, forming the present Parishes of Kirkcaldy, Dysart, and Abbotshall, together with the portion of the Parish of Kinghorn which lies within the Burgh of Kirkcaldy, and also a portion of the Landward part of the last-mentioned Parish specified in the Representation, into one Parish:

And whereas, after consulting the various authorities interested, and causing a local inquiry to be held, I am of opinion that it is expedient to give effect to the said Representation, except in so far as the inclusion in the new Parish of any portion of the Landward part of the Parish of Kinghorn is concerned:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, K.T., His Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order and direct as follows :---

1. From and after the third day of December 1901 (hereinafter termed the date of transfer), the portion of the Parish of Kinghorn which lies within the police boundary of the Burgh of Kirkcaldy shall cease to be part of the Parish of Kinghorn, and shall form part of the new Parish constituted by this Order.

2. The now existing Parish of Kirkcaldy, the now existing Parish of Dysart, and the now existing Parish of Abbotshall, along with the aforesaid portion of the Parish of Kinghorn, shall from and after the date of transfer be united into and form one Parish, to be called the Parish of Kirkcaldy and Dysart.

3. The Parish Wards presently existing within the area included in the Parish constituted by this Order shall be held and deemed to be Parish Wards of said new Parish, but that without prejudice to the power of the County Council of Fifeshire, and the Town Councils of Kirkcaldy and Dysart, at any time after the date of this Order to redivide the portions of said new Parish in which they are respectively interested into such and so many Parish Wards as they may respectively, by Order under their seal, determine, and to assign the number of Parish Councillors to be elected by the Parish electors in each Parish Ward, provided always that no alteration of Parish Wards shall have effect at the first election of a Parish Council for said new Parish unless it has been made prior to the 1st day of November next.

4. At the next general election of Parish Councils under the provisions of the Local Government (Scotland) Act, 1894, a Parish Council shall be elected for the Parish constituted by this Order, consisting of such number of Councillors as may, with the approval of the

Local Government Board for Scotland, be fixed by the County Council of Fifeshire and the Town Councils of Kirkcaldy and Dysart at a joint meeting to be held by these three bodies, or by Committees of their number appointed for the purpose, on such day not being more than fourteen days after the date of this Order, and at such place as may be selected by the Clerk to the said County Council, upon whom the duty of summoning said joint meeting is hereby laid. The proportion of Councillors to be elected for the Landward part and for each of the two Burghal parts of said new Parish shall also be determined at said joint meeting; and, failing agreement thereat, the number of Councillors to be elected for said Parish, and the proportions in which they are to be elected by the different parts thereof, shall be fixed by the Local Government Board for Scotland.

5. For the purpose of receiving the Parish Council Register prior to the election of a Parish Council for the Parish constituted by this Order, and summoning the first statutory meeting of the said Parish Council, the Inspector of Poor of the present Parish of Kirkcaldy shall be deemed to be the Inspector of Poor of the Parish constituted by this Order.

6. The Parish Council of Kirkcaldy, the Parish Council of Dysart, and the Parish Council of Abbotshall shall cease and determine, and their whole powers, rights, duties, property, habilities, debts, officers, and servants shall be transferred to the Parish Council of the Parish constituted by this Order.

7. The Parish Council of the Parish constituted by this Order shall assume responsibility for, and shall relieve the Parish Council of the Parish of Kinghorn of all advances which the last-mentioned body may be called upon to make for or on account of, any pauper whose claim is derived (a) from birth in the portion of the Parish of Kinghorn transferred to the Parish constituted by this Order prior to the date of transfer hereinbefore mentioned, or (b) from residence for the statutory period in the said transferred portion prior to the said date.

. 8. From and after the date of transfer, there shall be elected for the Landward area of the Parish constituted by this Order one and only one School Board, subject to the provisions following :---

- (1) The School Board shall be elected at such date prior to the date of transfer as shall be fixed by the Scotch Education Department, and in such manner and in accordance with such regulations as the said Department shall determine.
- (2) The School Board so to be elected shall not take office until the date of transfer, and shall hold office only for the unexpired period of office of the now existing School Boards of Kirkcaldy (Landward), and Abbotshall, and Dysart (Landward).
- (3) So soon as the School Board so to be elected shall take office, but not sooner, the said existing School Boards shall cease and determine, and their whole powers, rights, duties, property, liabilities, debts, officers, and servants shall be transferred to the School Board so to be elected.

9. Nothing herein contained shall affect the rights of creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.

10. This Order shall take effect immediately for all purposes connected with elections, and on the 3rd day of December 1901 for all other purposes.
