#### CORONATION OF THEIR MAJESTIES.

#### COURT OF CLAIMS.

THE Right Honourable the Commissioners appointed by His Majesty to hear and determine all Claims of Services to be performed at the time of the ensuing Coronation (except those dispensed with by His Majesty's Royal Proclamation of the 26th day of Juue last), and of fees to be received for the same, at their last meeting held at the Council Office, Whitehall, on the 17th day of July last, resolved as follows:--

- 1. All Claims must be made by Petition. Petitions may be sent under cover to the Clerks of the Court of Claims, Privy Council Office, Whitehall.
- 2. Petitioners are not required to appear in person before the Court, unless summoned.
- 3. Petitioners may appear by Solicitors, Agents, or Counsel.
- 4. If a Claim was admitted in 1838, the Court will forthwith admit such Claim, provided the Commissioners are satisfied that the present Petitioner represents the person whose Claim was admitted in 1838, and that there is no counter-claim.
- 5. Petitioners to be requested to present their Claims on or before the 31st day of October 1901.

The Court stood adjourned till some day in the month of November next, of which notice will be given in the London Gazette.

The Commissioners are required by the Proclamation to exclude from their consideration such Claims as may be submitted to them in respect of rights or services connected with the parts of the Ceremonial heretofore performed in Westminster Hall and with the Procession, the Ceremony being confined to Westminster Abbey.

The King's Most Excellent Majesty having been pleased to command me, as Earl Marshal of England, forthwith to prepare and countersign letters to be passed under the Royal Sign Manual, requiring the attendance of the Peers and Peerceses of Great Britain at the solemnity of the Royal Coronation of His Majesty and of Her Majesty the Queen, and the King having been further pleased to command me to prepare such letters also for those Peers of that part of the United Kingdom of Great Britain and Ireland, called Ireland, whose right to vote at the election of a representative Peer for Ireland has, on claim made on their behalf, been admitted by the House of Lords of the United Kingdom, and who are not now Members of the House of Commons of the United Kingdom, I do hereby request that all those Peers who, in conformity to the above regulations, are entitled to assist at the solemnity of the Royal Coronation of Their Majesties, will be pleased to transmit their respective addresses to me, at this office, and that the Dowager-Peeresses and Peeresses who may claim to attend at the said Coronation, will be also pleased to transmit their respective Christian names and addresses to me, in order that their letters of summons may be prepared without delay.

# EARL MARSHAL'S OFFICE, NORFOLK HOUSE, ST. JAMES' SQUARE, S.W., October 1, 1901.

The Earl Marshal's Order concerning the Robes, Coronets, &c., which are to be worn by the Peers at the Coronation of Their Most Sacred Majesties King Edward the Seventh and Queen Alexandra.

These are to give notice to all Peers who attend at the Coronation of Their Majesties, that the robe or mantle of the Peers be of crimson velvet, edged with miniver, the cape furred with miniver pure, and powdered with bars or rows of ermine (*i.e.*, narrow pieces of black fur), according to their degree, viz. :--

Barons, two rows.

Viscounts, two rows and a half.

Earls, three rows.

Marquesses, three rows and a half. Dukes, four rows.

The said mantles or robes to be worn over full Court dress, uniform, or regimentals.

The coronets to be of silver gilt; the caps of crimson velvet turned up with ermine, with a gold tassel on the top; and no jewels or precious stones are to be set or used in the coronets, or counterfeit pearls instead of silver balls.

• The coronet of a Baron to have, on the circle or rim, six silver balls at equal distances.

The coronet of a Viscount to have, on the circle, sixteen silver balls.

The coronet of an Earl to have, on the circle, eight silver balls, raised upon points, with gold strawberry leaves between the points.

The coronet of a Marquess to have, on the circle, four gold strawberry leaves and four silver balls alternately, the latter a little raised on points above the rim. The coronet of a Duke to have, on the circle,

The Earl Marshal's Order concerning the Robes, Coronets, &c., which are to be worn by the Peeresses at the Coronation of Their Most Sacred Majesties King Edward the Seventh and Queen Alexandra.

These are to give notice to all Peeresses who attend at the Coronation of Their Majesties, that the robes or mantles appertaining to their respective ranks are to be worn over the usual full Court dress.

That the robe or mantle of a Baroness be of crimson velvet, the cape whereof to be furred with miniver pure, and powdered with two bars or rows of ermine (*i.e.*, narrow pieces of black fur), the said mantle to be edged round with miniver pure two inches in breadth, and the train to be three feet on the ground; the coronet to be according to her degree, viz. —a rim or circle with six pearls (represented by silver balls) upon the same, not raised upon points.

That the robe or mantle of a Viscountess be like that of a Baroness, only the cape powdered with two rows and a half of ermine, the edging of the mantle two inches as before, and the train a yard and a quarter; the coronet to be according to her degree, viz. —a rim or circle with pearls (represented by silver balls) thereon, sixteen in number, and not raised upon points.

That the robe or mantle of a Countess be as before, only the cape powdered with three rows of ermine, the edging three inches in breadth, and the train a yard and a half; the coronet to be composed of eight pearls (répresented by silver balls) raised upon points or rays, with small strawberry leaves between, above the rim.

That the robe or mantle of a Marchioness be as before, only the cape powdered with three rows and a half of ermine, the edging four inches in breadth, the train a yard and three quarters; the coronet to be composed of four strawberry leaves and four pearls (represented by silver balls) raised upon points of the same height as the leaves, alternately, above the rim.

That the robe or mantle of a Duchess be as before, only the cape powdered with four rows of ermine, the edging five inches broad, the train two yards; the coronet to be composed of eight strawberry leaves, all of equal height, above the rim.

And that the caps of all the said coronets be of crimson velvet, turned up with ermine, with a tassel of gold on the top.

NOTE.—Only those Peers and Peeresses who reply to the above intimation before the first day of January 1902, will receive the Royal Command to attend the Ceremony of the Coronation.

It is to be understood that the above Orders refer to all English, Scottish, and Irish Peers (except Peers who are minors, and Irish Peers who have seats in the House of Commons), Peeresses in their own right, the widows of Peers, and the wives of living Peers, including the wives of Irish Peers who have seats in the House of Commons.

With respect to such widows of Peers who have remarried under the rank of the Peerage, they, according to former precedent, are considered as not entitled to such summons.

As to widows of Peers who have remarried with a Peer-of lower degree, their precedence, according to precedent, is that of their last husband.

Peers and Peeresses in their own right, whose highest dignity is in the Peerage of Scotland or Ireland, will wear robes and coronet of such dignity, as also the wife or widow of such Peer.

#### TREASURY, October 14, 1901.

Prohibition, under Section 5 of "The Customs and Inland Revenue Act, 1888," of the use in Beer of certain substances.

Whereas it appears to the satisfaction of the Lords Commissioners of His Majesty's Treasury that Glucose containing Arsenic, and Invert Sugar containing Arsenic, are substances which are capable of being used in the manufacture and preparation for sale of Beer, and that the said substances are of a noxious and detrimental nature.

Now, the said Lords Commissioners, under the power conferred upon them by Section 5 of "The Customs and Inland Revenue Act, 1888," do hereby prohibit the use in the manufacture and preparation for sale of Beer of any Glucose or Invert Sugar containing Arsenic.

Dated this 10th day of October 1901. N.B.—A penalty of £50 is imposed by the said Section for any breach of this prohibition.

# ZETLAND (STRANGLES) REVOCATION **ORDER OF 1901.**

The Board of Agriculture, by virtue and inexercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1895, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :-

1. The Order described in the Schedule to this Order is hereby from and after the commencement of this Order revoked : Provided that such revocation shall not invalidate or make unlawful anything done under the Order hereby revoked, or affect any licence or authority granted, or any right, title, obligation, or liability accrued thereunder before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the Order hereby revoked before the commencement of this Order.

2. This Order shall come into operation on the nineteenth day of October one thousand nine hundred and one.

3. This Order may be cited as the ZETLAND (STRANGLES) REVOCATION ORDER OF 1901.

(Confirmation of Agreement between the Trustees of the Clyde Navigation and the Town Council of Renfrew for the Purchase of Renfrew Harbour Undertaking; Vesting of Harbour Undertaking in Trustees; Amendment of Provisions relating to Tidal Dock and Graving Dock; Power to Sell, Feu, or Lease Graving Dock or Lands for Construction of same or similar Works; Purchase of Lands by Agreement; Tolls, Rates, and Charges; Watching, Lighting, and Cleansing of Harbour Undertaking; Power to the Trustees to Borrow; Amendment of Constitution of Clyde Trust; Extension of Times for Compulsory Purchase of Lands for and for Construction of Harbour Works; Incorporation, Amendment, or Repeal of Acts; other Purposes.)

OTICE is hereby given that application is intended to be made to the Secretary for Scotland on or before the 17th day of December next, by the Provost, Magistrates, and Councillors of the Royal Burgh of Renfrew (hereinafter called "the Town Council") for a Provisional Order (hereinafter called "the Order") to be confirmed by Parliament in the ensuing Session, for effecting the following or some of the following objects and purposes, that is to say :—

1. To confirm an agreement entered into and executed by and between the Trustees of the Clyde Navigation (hereinafter called "the Trustees' ) of the one part, and the Town Council of the other part, dated the 5th and 11th days of February 1901, whereby the Town Council agreed to sell to the Trustees, and the Trustees agreed to purchase from the Town Council, the Harbour Undertaking of the Town Council, including the whole of the wharfs, quays, jetties, cranes, tramways, and works, lands, machinery, tools, stores, and plant belonging to the Town Council in connection with their Harbour Undertaking as at the date of the vesting thereof in the Trustees, and also including the whole lands, wharfs, quays, and others shown within the boundaries coloured red on the plan subscribed as relative to the said agreement, and also their whole ancient rights of Harbour, and the whole rights, powers, and privileges (hereinafter called "the statutory rights") conferred upon the Town Council under the Burghs Harbours (Scotland) Act, 1853, and under Parts III. IV. and V. of the Renfrew Burgh and Harbour Extension Act, 1899 (hereinafter called "the Act of 1899"), but not including cash in hand or with their bankers or sums due to them in respect of Harbour dues and rates as at the date of vesting (all hereinafter called "the Harbour Undertaking"), at the price and for the considerations, and under the terms and conditions set forth in the said agreement; or otherwise to carry out and give full effect to the said agreement, and the sale and transfer of the Harbour Undertaking thereby provided for, on the terms and conditions therein mentioned.

2. To vest the Harbour Undertaking in the Trustees at the price and for the considerations, and under and subject to the terms and conditions set forth in the said agreement, and to provide that for all purposes the Harbour Undertaking shall be and form part of the undertaking of the Trustees under the Clyde Navigation Acts, 1858 to 1899 (hereinafter called "the Clyde Acts").

3. To make provision for the transfer to and taking over by the Trustees of all or some of the debts, obligations, liabilities, contracts, and engagements of the Town Council in connection

with the Harbour Undertaking and the statutory rights, and to make provision with respect to any such debts, obligations, liabilities, contracts, and engagements as may not be taken over, and to release the Harbour Undertaking so far as transferred to the Trustees therefrom.

4. To amend the provisions of the Act of 1899 as to the construction of the tidal dock, graving dock, and other works, or any of them, within the authorised limits of deviation thereby authorised therefor, and to make other provisions respecting the same.

5. To authorise the Trustees to sell, feu, or lease to the Town Council or other parties the graving dock authorised by the Act of 1899 when constructed, or lands for the construction of the same, or for the construction of another graving dock, with all necessary rights and powers for the construction, maintenance, and user of such graving dock, and to authorise the Town Council to purchase or feu such graving dock, or the land required therefor, or to take the same in lease, or grant leases of the same for the construction of a graving dock, and to borrow money for these purposes, and to levy rates or rents in respect of the use of such graving dock. 6. To authorise the Trustees to purchase, take,

6. To authorise the Trustees to purchase, take, and acquire by agreement, lands, houses, and other property which will or may be required for the Harbour Undertaking and for the general purposes of the Trustees' Undertaking, or rights of easement or servitude, or other rights, in or over such lands, houses, and other property.

7. To authorise the Trustees to exercise all the powers, rights, and privileges of the Town Council with respect to the levying and recovery of, and to levy and recover tolls, rates, rents, dues, duties, and charges for or in respect of the Harbour Undertaking and the statutory rights, or either of them; to repeal or to extinguish, alter, or vary any existing tolls, rates, rents, dues, duties, and charges; and to confer, vary, or extinguish exemptions from the payment of any such tolls, rates, rents, dues, duties, and charges, and to confer on the Trustees such further and other powers, rights, and privileges for the purpose of carrying on the Harbour Undertaking, or otherwise as the Order may prescribe.

8. To provide for the watching, lighting, and cleansing by the Trustees, by themselves or by agreement with the Corporation of the City of Glasgow (hereinafter cailed "the Corporation"), the Town Council, or other local authority, or otherwise, of the quays, wharfs, sheds, ware-houses, stores, railways, tramways, roads, and streets (with the exception of public roads and streets) connected with the Harbour Undertaking, and for the use by the Trustees or other persons at the said works, or the shipping therein or thereat, of the fire-extinguishing appliances and staff of the Corporation; for fixing the amount of abatement of the assessment or charges for those purposes leviable by the authorities within whose jurisdiction such works are situated respectively upon the said works; for determining the time and manner in which the amount of such abatement shall be allowed or paid by such authorities to the Trustees, the Corporation, or other local authority, or otherwise, in respect of the said services, and to confirm any agreements which may be entered into in relation thereto.

9. To authorise the Trustees from time to time to borrow and re-borrow, on the security of their 2

Undertaking under the Clyde Acts, lands, property, and works already acquired and constructed or to be acquired and constructed, and of the tolls, rates, rents, dues, duties, and charges which are or may be leviable by them, additional money for the purposes of the Order, for the purchase of lands, houses, and other property acquired and taken, or to be acquired and taken, under the authority of the Clyde Acts or of the Order, and for the general purposes of their Undertaking, and to apply their existing funds and revenues, and any moneys which they now have or may have power to borrow, for or towards these purposes.

10. To repeal, alter, or amend all or some of the provisions of the Clyde Acts relating to the constitution, number, election, and qualification of the Trustees; and to provide for the Provost of Renfrew for the time being, and one other Member of the Town Council, being appointed Trustees of the Clyde Navigation; and to make all necessary provisions for effecting those objects.

11. To extend the times limited by the Act of 1899 for the compulsory purchase of lands for and for the construction of the Works by that Act authorised.

12. To incorporate with and make applicable to the Order, with such additions and subject to such alterations or modifications as may be provided therein, all or some of the provisions of the Clyde Acts and the Acts recited in and incorporated with the said Acts, or any of them, and any other Acts relating to or affecting the Clyde Navigation or the Trustees.

13. To incorporate with the Order, subject to such alterations or modifications as may be provided therein, all or some of the provisions of the Lands Clauses Acts; the Harbours, Docks, and Piers Clauses Act, 1847; the Railways Clauses Consolidation (Scotland) Act, 1845; the Railways Clauses Act, 1863; and any Acts amending the said Acts, or any of them.
