1887 AND 1896.

THE METALLIFEROUS MINES REGULATION ACTS,  
1872 AND 1875.

THE QUARRIES ACT, 1894.

I HEREBY order and direct that, for the purposes of inspection under the Coal Mines Regulation Acts, 1887 and 1896, the Metalliferous Mines Regulation Acts, 1872 and 1875, and the Quarries Act, 1894, the United Kingdom shall be divided into the following districts:—

No. 1, or East Scotland District, consisting of the Counties of Aberdeen, Banff, Berwick, Caithness, Clackmannan, Edinburgh, Elgin, Fife, Forfar, Haddington, Inverness, Kincardine, Kinross, Linlithgow, Nairn, Orkney and Shetland, Peebles, Perth, Ross and Cromarty, Roxburgh, Selkirk, Sutherland, and the eastern portion of the County of Stirling (namely, the Parishes of Airth, Larbert, Falkirk, and Slamannan, and all Parishes to the east thereof), and the eastern portion of the County of Lanark (namely, the Parishes of New Monkland, Shotts, Dalziel, Cambusnethan, Carluke, Lanark, Carmichael, Douglas, and Crawfordjohn, and all Parishes to the east thereof).
