Cape Police	Sergeant-Major Alexander Young	Towards the close of the action at Ruiter's Kraal on the 13th August 1901, Sergeant-Major Young, with a handful of men, rushed some kopjes which were being held by Commandant Erasmus and about 20 Boers. On reaching these kopjes the enemy were seen galloping back to another kopje held by the Boers. Sergeant-Major Young then galloped on some 50 yards ahead of his party, and closing with the enemy shot one of them and captured Commandant Erasmus, the latter firing at him three times at point blank range before being taken prisoner.

## COATBRIDGE GAS.

(Additional Capital and Borrowing Powers; Alteration and Reduction of the Illuminating Power of Gas; Incorporation, Amendment, or repeal of Acts.)
