Ind: Imp:" and for the reverse the respective figures " 4 ," " 3 ," " 2 ," " 1 " (according to the denomination or value of the piece) in the centre, with the date of the year placed across the figure, and encircled with an oak wreath surmounted by the Royal Crown, with a plain edge.
Given at Our Court at Saint James', this thirteenth day of January, in the year of our Lord one thousand nine huadred and two, and in the first year of Our Reign.

[^0]:    * Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial busbel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
