FISHERY BOARD FOR SCOTLAND.

BYE-LAWS made by the Fishery Board for Scotland under the same **D** Scotland under the powers conferred by the Sea Fisheries Regulation (Scotland) Act, 1895 :--

(1) These Bye-Laws shall extend and apply to the territorial waters on the Scottish side of the Solway Firth, between the River Sark and Abbey Head, in Kirkcudbrightshire.

(2) No person shall adopt any practice known as bunching or tying round the net, or use any artifice or device so as practically to diminish the size of the mesh of any net, except the net or trawl used solely for the purpose of taking shrimps or prawns.

(3) No person shall use, in fishing for sea fish other than shrimps, prawns, mackerel, herrings, eels, or sparlings (otherwise known as "smelts"), any net having a mesh through which a square gauge of 1³/₄ inches, measured across each side of the square, or 7 inches measured round the four sides, will not pass without pressure when the net is wet. Provided that between the 1st day of July and the 15th day of October following, both inclusive, to the west and south of a line drawn from Bow House Point, near Caerlaverock, on the Scottish side of the Firth, to Skinburness on the English side, it shall be lawful to use a trawl net having a mesh through which a square gauge of 11 inches, measured across each side of the square, or 6 inches measured round the four sides, will pass without pressure when the net is wet.

(4) No person shall fish for sparlings (otherwise known as "smelts") between the 1st day of February and the 1st day of September following, both inclusive.

(5) No person shall fish for mussels except-

(a) By hand, or

(b) With a rake not exceeding 3 feet in width, and used only from a boat, and when the mussel bed is covered with at least four feet of water, provided that the use of a dredge shall be allowed when the bed is covered with at least 20 feet of water.

(6) No person shall take mussels during the months of May, June, July, or August in any year.

(7) No person shall remove from a fishery any mussel less than 2 inches in length.

(8) Any person who takes any shell fish, the removal of which from a fishery is prohibited by any Bye-Law in force in the waters affected by these Regulations, or the possession of which is prohibited by any Act of Parliament, shall forthwith re-deposit the same without injury as nearly as possible in the place from which they were taken, and in re-depositing cockles in accordance with this Bye-Law, shall spread them thinly and evenly over the beds.

(9) Any person not in the service or possessing the written authority of the Board, under the hand of the Secretary thereof, who shall commit a breach of any of the foregoing Bye-Laws, shall be liableto a penalty not exceeding, for any one offence, the sum of twenty pounds; and in the case of a continuing offence, the additional sum of ten pounds for every day during which the offence continues, and in any case to forfeiture of any fishing instru-ment used, or sea fish taken in contravention of, or found in the possession of, a person contravening.

such Bye-Law. Provided that in any case in which a prosecution is instituted for taking sea fish with a net or instrument the use of which, for the capture of any particular kind of sea fish, would constitute a breach of any of the foregoing Bye-Laws, not being a Bye-Law prescribing a close season, a person shall not be deemed to have committed such breach if he proves, to the satisfaction of the Court, that he was bona fide fishing only for the particular kind of sea fish permitted to be captured with the net or instrument he was then using, and that he forthwith returned to the water, with the least possible injury, all soles and plaice under 10 inches in length, if any such were taken by such net or instrument.

(10) These Bye-Laws shall come into force from and after the date of their confirmation by the Secretary for Scotland.
