The KING's Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it was enacted that it should be lawful for His Majesty from time to time, by Order in Council, upon the Representation

of the Secretary for Scotland, that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said first-named Act had been received, in pursuance thereof, to order that no new burial ground should be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland or as the case might require) that after a time mentioned in such Order burials within certain linits, or in certain burial grounds or places of burial, should be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council should thereupon have like force and effect as if the same were embodied in the said Act: Provided always that notice of such Representation, and of the time it should please His Majesty to order the same to be taken into consideration by the Privy Council, should be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same should be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such Representation, one mouth before such Representation was so considered:

And whereas the Secretary for Scotland made a Representation stating that he had received a copy of an Interlocutor by the Sheriff-Substitute of Lanarkshire at Hamilton, finding that the Burial Ground known as Windmillhill Old Burial Ground, situated in or near Windmillhill Street, Motherwell, in the Parish of Dalziel and County of Lanark, was overcrowded and in a condition dangerous to health, and offensive and contrary to decency:

And whereas in the said Representation it was recommended that the said Burial Ground should be closed:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order

as follows, viz. :-

That burials be forthwith discontinued in the Burial Ground known as Windmillhill Old Burial Ground, situated in or near Windmill-Street, Motherwell, in the Parish of Dalziel and County of Lanark.

LOCAL GOVERNMENT (SCOTLAND) ACTS. COUNTY COUNCIL ELECTORAL DIVISIONS OF RENFREWSHIRE.

PARISH OF RENFREW.

ORDER by the Secretary for Scotland.

WHEREAS since the date of the Order of the Boundary Commissioners for Scotland forming Electoral Divisions for the County of Renfrew a material change of circumstances has occurred in respect of the population and annual value of the Renfrew Electoral Division in the said County;

And whereas the County Council of the County of Renfrew have represented to me that it is desirable to detach a portion of the said Renfrew Electoral Division therefrom, and to constitute the detached portion into a new Electoral Division, and accordingly to alter the number of County Councillors;

And whereas I am of opinion that it is expedient to give effect to the proposal of the

said County Council:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, K.T., His Majesty's Secretary for Scotland, do, in virtue of the powers conferred on me by Section 51 of the Local Government (Scotland) Act, 1889, order as follows:

1. The number of County Councillors for the County of Renfrew shall be increased from fortythree to forty-four.

2. The Renfrew Electoral Division, as defined by the Order of the Boundary Commissioners for Scotland, dated 29th September 1891, shall be divided into two County Council Electoral Divisions, having the following names and contents, that is to say :-

Name of Division,	Contents of Division.
1. Scotstoun.	Commencing at the point in the centre of the River Clyde at which the boundaries of the Burgh of Partick and of the County of Renfrew meet, thence north-eastwards, eastwards, and northwards along the eastern boundary of the County of Renfrew to the point at which said boundary is intersected by the line of the Glasgow, Yoker, and Clyebank Railway, belonging to the North British Railway Company, thence westward along the southern boundary of the said line to the centre of Victoria Drive, thence southward along the centre of Victoria Drive and of Balmoral Street, and in a straight line therewith to the centre of the River Clyde, thence south-eastward along the boundary line between the County of Renfrew and the County of Lanark to the point of commencement.
2. Renfrew.	The remainder of the Parish of Renfrew, exclusive of the portion included within the limits of the Burgh of Renfrew.

- The County Councillor elected to represent the Renfrew Electoral Division at the election held in December 1901 shall, during the remainder of his term of office, represent the Electoral Division of Renfrew constituted by this
- 4. The County Council of the County of Renfrew shall appoint a County Councillor to represent the Electoral Division of Scotstoun constituted by this Order, in the manner provided by Section 33 of the Local Government (Scotland) Act, 1889, for the filling up of casual
- 5. The foregoing provisions shall come into effect as from the date of this Order.

^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

INEBRIATES ACT, 1898. LICENSING ACT, 1902.

Regulations made by the Secretary of State for the Home Department, in pursuance of section 20 of the Inebriates Act, 1898, respecting the detention of Inebriates committed to a Retreat under section 5 of the Licensing Act, 1902.

I, the Right Honourable Aretas Akers-Douglas, one of His Majesty's Principal Secretaries of State, do hereby, by virtue of section 20 of the Insbriates Act, 1898, make the following regulations for carrying into effect the provisions of section 5 of the Licensing Act, 1902, respecting the detention of Insbriates committee to Retreats:—

1. Before applying under section 12 of the Habitual Drunkards Act, 1879, for a Justice's Order for the discharge of a patient committed to the Retreat under section 5 of the Licensing Act, 1902, the Licensee shall give notice of his intention seven full days previously to the Secretary of State, and shall specify the reasons for his application, and the name and address of the Justice to whom it is to be made.

2. The Licensee shall give immediate notice to the Secretary of State of any visit and examination, pursuant to section 18 of the Habitual Drunkards Act, 1879, of any patient committed under section 5 of the Licensing Act, 1902.
