Alteration of Parish Areas.

ADJUSTMENT ORDER No. XXX.

DUNDEE COMBINATION PARISH AND PARISH OF LIFF AND BENVIE.

WHEREAS a new Parish, called the Parish of Liff and Benvie, was constituted on the 3rd day of December 1901, by the Order of the Secretary for Scotland, published in the Edinburgh Gazettee of the 6th September 1901 (No. XLII.):

And whereas the Parish Council of the Dundee Combination Parish, in concurrence with the Parish Council of Liff and Benvie, has made a representation to me that I should, under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, issue an Order, as hereinafter contained, for the adjustment of the liabilities of the said Parish of Dundee and the said Parish of Liff and Benvie:

And whereas a Minute of Agreement has been duly executed between the said Parish Council of the Dundee Combination Parish and the said Parish Council of Liff and Benvie, dated 23rd day and 27th day of September 1902, and has been signed by me with reference to this Order:

And whereas I am of opinion that it is expedient to give effect to the said representation by confirming the said Agreement:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, K.T., His Majesty's Secretary for Scotland. do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order as follows:—

To provide for the management of the Corporation and the Fund by directors and officers elected by the Corporation and the Church Council, or either of them, or partly by the one and partly by the other of them, and to make provisions as to the election, retirement, suspension, or removal of the Presidents, Vice-Presidents, Directors, Officers, and Servants of the Corporation; the meetings of directors and members of the Corporation; the voting of members; the audit of accounts; the periodical investigation of the affairs of the Corporation; the investment of its funds; and the borrowing of money for the purposes of the Corporation.
