Gentlemen who come in attendance on their families are not expected to pass the Presence.

A Lady who makes a presentation to Their Majesties must be personally acquainted with and responsible for the Lady she presents. She must herself attend the Court, and cannot present more than one Lady in addition to her daughter or daughter-in-law.

If it should not be convenient for a Lady to attend or be presented at the particular Court to which she is invited, it will be open to her to make her excuses to the Lord Chamberlain in writing, when her name can, if desired, and if possible, be transferred to another List.

The Courts will be held in the evening.  
The Dress Regulations are:—Ladies—Full Court dress with feathers and trains. Gentlemen—Full Court dress.

A further notice will be published as to the dates, the issue of Presentation Cards, and other arrangements.

**T**HE King has been graciously pleased to ordain and declare the following Special Statute of the Most Exalted Order of the Star of India:—

EDWARD THE SEVENTH, by the Grace of God of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India, and Sovereign of the Most Exalted Order of the Star of India, To all whom these Presents shall come, Greeting!

Whereas in and by certain Letters Patent under the Great Seal bearing date the twenty-eighth day of March one thousand eight hundred and sixty-six, and the Statutes for the government of the Most Exalted Order of the Star of India made in pursuance of the said Letters Patent, full power and authority is reserved to Us to increase the number of Members of any of the Classes of the said Order, and to assign a place in any such Class to any person whom We might think fit to admit into the same.

And whereas by a Special Statute, bearing date the tenth day of June one thousand eight hundred and ninety-seven, and now in full force for the regulation of the Order, it is ordained and declared that the First Class or Knights Grand Commanders of the Order shall not exceed thirty-six in number; that the Second Class or Knights Commanders shall not exceed eighty in number; and that the Third Class shall not exceed one hundred and sixty in number.

And whereas We deem it expedient further to increase the number of the Members of the Second and Third Classes of Our said Order.

Now, therefore, in pursuance and in exercise of the power so reserved to Us by the aforesaid Letters Patent and the Statutes made in pursuance thereof, We are pleased by this Special Statute of Our said Most exalted Order to increase the number of the Second and Third Classes, and to enable Us to carry this Our Royal Will and Pleasure into effect, We do hereby increase the total number of Companions or Members of this Order from two hundred and seventy-six to two hundred and ninety-one; and We do further, in exercise of the power aforesaid, alter and dispense with so much of the aforesaid Statutes of Our said Order as may be necessary for the purposes hereinafter declared, and the said Statutes are altered and dispensed with accordingly, and in lieu thereof We have made, ordained, and established, and by these Presents sealed with the Seal of the Order, do make, ordain, and establish the following Statutes, viz:—

I. It is ordained that the Second Class or Knights Commanders shall not exceed eighty-five in number.

II. It is ordained that the Third Class or Companions shall not exceed one hundred and seventy in number.

And it is Our Will and Pleasure that this Special Statute sealed with the Seal of the said Order be taken and received as part and parcel of the Statutes thereof.

Given at Our Court at Buckingham Palace under Our Sign Manual, and the Seal of Our said Order, this twenty-first day of October, in the second year of Our Reign and the year of our Lord one thousand nine hundred and two.

EDWARD THE SEVENTH, by the Grace of God of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India, and Sovereign of the Most Eminent Order of the Indian Empire, To all whom these Presents shall come, Greeting!

Whereas in and by certain Letters Patent under the Great Seal bearing date the second day of August one thousand eight hundred and eighty-six, and the Statutes for the government of the Most Eminent Order of the Indian Empire made in pursuance of the said Letters Patent, full power and authority is reserved to Us to increase the number of Members of any of the Classes of Knights Grand Commanders, Knights Commanders, and Companions of our said Order, and to assign a place in any such Class to any person whom We may think fit to admit into the same:

And whereas by Article IX. of the Statutes of Our said Order it is ordained and declared that nominations to the Second Class or Knights Commanders shall not exceed eighty-two in number, and that nominations to the Third Class or Companions shall not exceed twenty in any successive year.

And whereas We deem it expedient further to increase the number of the Members of the Second Class, and to make provision for the nomination and admission into the Third Class of the Order during the year one thousand nine

hundred and three of forty Companions of Our said Order.

Now, therefore, in pursuance and in exercise of the power reserved to Us by the aforesaid Letters Patent and the Statutes made in pursuance thereof, We are pleased to alter and dispense with so much of the aforesaid Article IX. of the Statutes of Our said Order as may be necessary for the purposes hereinbefore recited, and such portion of the said Article IX. is altered and dispensed with accordingly, and in lieu thereof We have made, ordained, and established, and by these Presents sealed with the Seal of the Order, do make, ordain, and establish the following Statutes, viz.:—

I. It is ordained that nominations to the Second Class or Knights Commanders shall not exceed ninety-two in number.

II. It is ordained that nominations to the Third Class or Companions of the Order for and during the year one thousand nine hundred and three may be made up to, but shall not exceed, forty in number for that year only, and that thereafter nominations to the Third Class or Companions shall not exceed twenty in any one year, as in and by the said Article IX. of the Statutes of the Order was formerly ordained and declared.

And it is Our Will and Pleasure that this Special Statute sealed with the Seal of the said Order be taken and received as part and parcel of the Statutes thereof.

## ORDER OF THE BOARD OF AGRICULTURE.

(DATED 31ST DECEMBER 1902.)

## ORKNEY (STRANGLES) ORDER OF 1902.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

## Extension of certain Sections of Diseases of Animals Act, 1894.

1. Horses, asses, and mules shall be animals, and strangles of horses, asses, and mules (in this Order called strangles) shall be a disease for the purposes of this Order and of the following sections of the Act of 1894 (namely):

Sections nineteen and twenty (slaughter and compensation);

Section forty-three (powers of police);

Section forty-four (powers of inspectors);

and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences or procedure.

## Separation of Diseased and Suspected Animals and Notice of Disease.

2. Every person having in his possession or under his charge a horse, ass, or mule affected with or suspected of strangles shall (a) as far as practicable keep that animal separate from animals not so affected or suspected; and (b) with all practicable speed give notice of the fact of the horse, ass, or mule being so affected or suspected to an Inspector of the Local Authority or to one of his Assistants, who shall forthwith report the same to the Local Authority.

Duty of Inspector to act immediately.

3. An Inspector of the Local Authority on receiving in any manner whatsoever information of the supposed existence of strangles, or having reasonable ground to suspect the existence of strangles, shall proceed with all practicable speed to the place where such disease, according to the information received by him, exists, or is sus-

pected to exist, and shall there and elsewhere put in force and discharge the powers and duties conferred and imposed on him as Inspector by or under the Act of 1894 and this Order.

#### Public Warning as to Existence of Strangles.

4.—(1) The Local Authority may, if they think fit, give public warning by placards, advertisement, or otherwise, of the existence of strangles in any stable, building, field, or other place, with or without any particular description thereof, as they think fit, and may continue to do so during the existence of the disease, and in case of a stable, building, or other like place, until the same has been cleansed and disinfected.

(2) It shall not be lawful for any person (without authority or excuse) to remove or deface any such placard.

#### Slaughter.

5.—(1) The Local Authority may, if they think fit, cause to be slaughtered—

- (i.) any horse, ass, or mule affected with strangles; or
- (ii.) any horse, ass, or mule being or having been in the same stable, building, field, or other place in which strangles exists or is suspected to exist, or being or having been in contact with a horse, ass, or mule affected with strangles.

(2) Provided that if the owner of the horse, ass, or mule gives notice in writing to the Local Authority, or their Inspector or other officer, that he objects to the horse, ass, or mule being slaughtered, it shall not be lawful for the Local Authority to cause that horse, ass, or mule to be slaughtered except with the further special authority of the Board first obtained.

#### Compensation.

6. The Local Authority shall, except as hereinafter provided, pay out of the local rate as compensation for any horse, ass, or mule slaughtered under this Order, the value of the horse, ass, or mule immediately before it was slaughtered.

#### Regulations of Local Authority as to Movement.

7. The Local Authority may, with the view of preventing the spreading of strangles, make Regulations for the following purposes, or any of them:—

- (a) For prohibiting or regulating the movement by land or by water of horses, asses, or mules in the whole of their District, or in such part or parts thereof as may be specified by the Local Authority;
- (b) For prohibiting or regulating the movement by land or by water of horses, asses, or mules out of the whole of their District, or out of such part or parts thereof as may be specified by the Local Authority;
- (c) For prohibiting or regulating the movement out of any stable, building, field, or other place of a horse, ass, or mule affected with or suspected of strangles;
- (d) For prohibiting or regulating the movement out of any stable, building, field, or other place in which strangles exists or is suspected to exist of a horse, ass, or mule that has been in contact with or in the same

stable, building, field, or other place with a horse, ass, or mule affected with or suspected of strangles:

- (e) For regulating the taking out of any stable, building, field, or other place of any fodder, litter, or other thing that has been in contact with or used for or about a horse, ass, or mule affected with or suspected of strangles;

but nothing in any such Regulation shall authorise movement in contravention of any provision of any Order of the Board for the time being in force; and a Regulation under paragraph (d) of this Article shall operate so long only as any horse, ass, or mule which, in the judgment of the Local Authority, is affected with strangles, remains in the stable, building, field, or other place to which the Regulation refers, and in case of a stable, building, or other like place, until the Regulations of the Local Authority as to cleansing and disinfection have been complied with.

#### Regulations of Local Authority as to Cleansing and Disinfection.

8.—(1) The Local Authority may, for the purpose of preventing the spreading of strangles, make Regulations for the following purposes, or any of them:—

- (a) For providing for the cleansing and disinfection of any place used by a horse, ass, or mule affected with or suspected of strangles;
- (b) For prescribing the mode in which such cleansing and such disinfection are to be effected;
- (c) For requiring the owner, lessee, or occupier of any such place to cleanse and disinfect the same at the expense of the Local Authority, or at the expense of such owner, lessee, or occupier.

(2) If any person fails to cleanse and disinfect in accordance with any such Regulation, it shall be lawful for the Local Authority, without prejudice to the recovery of any penalty for the infringement of such Regulation, to cause such place to be cleansed and disinfected, and to recover summarily the expenses of such cleansing and disinfection from such person.

#### Occupiers to give facilities for Cleansing.

9.—(1) Where the power of causing any place to be cleansed and disinfected under this Order is exercised by the Local Authority, the owner, lessee, or occupier thereof shall give all reasonable facilities for that purpose.

(2) Any person failing to comply with the provisions of this Article shall be deemed guilty of an offence against the Act of 1894.

#### Provisions as to Regulations of Local Authority.

10.—(1) The Local Authority shall forthwith send to the Board a copy of every Regulation made by them under this Order.

(2) If the Board are satisfied on inquiry, with respect to any Regulation made by the Local Authority under this Order, that the same is for any reason objectionable, and direct the revocation thereof, the same shall thereupon cease to operate.

#### Withholding of Compensation.

11.—(1) The Local Authority may, if they think fit, withhold, either wholly or partially,

compensation in respect of a horse, ass, or mule slaughtered by their order under this Order where the horse, ass, or mule was, in their opinion, affected with strangles at the time of its being brought into their District.

(2) The Local Authority before determining under sub-section seven of section twenty of the Act of 1894, or under this Article, to withhold, either wholly or partially, compensation or other payment in respect of a horse, ass, or mule slaughtered by their order under this Order, shall give to the owner of the horse, ass, or mule an opportunity of making representations to them respecting the facts and circumstances of the case, and shall consider the same.

#### Record of Slaughter.

12. The Local Authority shall keep, in the form provided by the Board, a record relative to horses, asses, or mules slaughtered by their order under this Order, stating the particulars indicated in such form, with such variations as circumstances require.

#### Production of Licences ; Names and Addresses.

13.—(1) Every person in charge of any horse, ass, or mule being moved, where, under any Regulation of the Local Authority made under this Order, a Movement Licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Local Authority, produce and show to him the Licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2) Every person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

#### Offences.

14.—(1) If any horse, ass, or mule is moved in contravention of a Regulation of the Local Authority made under this Order, or of the conditions of a Movement Licence thereunder, the owner of such horse, ass, or mule, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying such horse, ass, or mule, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2) If any person, with a view to unlawfully evade or defeat the operation of this Order, by clipping, or washing, or in any other manner, takes out, effaces, or obliterates, or attempts to take out, efface, or obliterate, any mark clipped, painted, or stamped on any horse, ass, or mule as required by a Regulation of the Local Authority made under this Order, the person doing the same, and the person causing, directing, or permitting the same to be done, and the owner of the horse, ass, or mule, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(3) If anything is omitted to be done as regards cleansing or disinfection in contravention of a Regulation of the Local Authority made under this Order, the owner and the lessee and the occupier of any place in or in respect of which the same is omitted, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(4) If a person in charge of any horse, ass, or mule being moved, where, under a Regulation of the Local Authority made under this Order, a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.

#### Interpretation.

15. In this Order—

“The Board” means the Board of Agriculture :

“The Act of 1894” means the Diseases of Animals Act, 1894 :

“Fodder” means hay or other substance commonly used for food of horses, asses, or mules :

“Litter” means straw or other substance commonly used for bedding or otherwise for or about horses, asses, or mules :

“Master” includes a person having the charge or command of a vessel :

Other terms have the same meaning and scope as in the Act of 1894.

#### Extent.

16. This Order extends to the county of Orkney only.

#### Commencement.

17. This Order shall come into operation on the second day of January one thousand nine hundred and three.

#### Short Title.

18. This Order may be cited as the ORKNEY (STRANGLES) ORDER OF 1902.
