**ORDER OF THE BOARD OF  
AGRICULTURE.**

(DATED 3RD FEBRUARY 1903.)

The Board of Agriculture, by virtue and in  
exercise of the powers in them vested under the  
Diseases of Animals Acts, 1894 and 1896, and of  
every other power enabling them in this behalf,  
do order, and it is hereby ordered, as follows:—

The Foreign Animals (Amendment) Order of  
1900 (prohibiting the landing of animals from  
the country of the Argentine Republic or from  
Uruguay) is hereby repealed: Provided that such  
revocation shall not interfere with the institution  
or prosecution of any proceeding in respect of  
any offence committed against, or any penalty

incurred under, the Order hereby revoked before the date of this Order.

### ORDER OF THE BOARD OF AGRICULTURE.

(DATED 6TH FEBRUARY 1903.)

### FOREIGN ANIMALS (AMENDMENT) ORDER OF 1903.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

#### Animals from the Republic of Mexico Prohibited.

1. Unless and until the Board otherwise order, it shall not be lawful to land any animal brought from the country of the Republic of Mexico, and the First Schedule (*Prohibited Countries and Parts of Countries*) to the Foreign Animals Order of 1896 shall be read and have effect as if that country were included in the list of prohibited countries and parts of countries mentioned in that Schedule.

#### Interpretation.

2. In this Order terms have the same meaning as in the Foreign Animals Order of 1896.

#### Commencement.

3. This Order shall come into operation on the ninth day of February one thousand nine hundred and three.

#### Short Title.

4. This Order may be cited as the FOREIGN ANIMALS (AMENDMENT) ORDER OF 1903.
