#### TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday the 23rd instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vict. cap. 2, and 52 Vict. cap. 6, to the amount of  $\pounds 2,720,000$ , in replacement of Bills falling due on the 29th instant.

2. The Bills will be in amounts of £1000, £5000, or £10,000. They will be dated the 28th March 1903, and will be payable at twelve months after date, viz., on the 28th March 1904.

3. The Tenders must specify the net amount per cent. which will be given for the amounts applied for; and the Tenders of private individuals must be made through a London Banker.

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday the 24th instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than twelve o'clock on Saturday the 28th instant.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

\* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

(Amendment of the Wick and Pulteney Harbours Acts, 1879 to 1899, and the Wick Burgh Extension Order Confirmation Act, 1902; Alteration of the Provisions of those Acts with respect to the Qualification, Disqualification, and Election of Harbour Trustees; Extension and Improvement of Harbours; Acquisition of Land; Appointment of single Arbiter to determine questions of Compensation; Arbiter to have regard to benefit to remaining or contiguous Lands; Alteration and Increase of Rates, Duties, and Charges, and additional provisions for recovering same; Imposition of new Rates, Duties, and Charges; Borrowing Powers, Bye-Laws, and Regulations; Power to Corporation of Royal Burgh of Wick to guarantee Harbour Loan, and provisionally to assess the Harbours for Municipal purposes on the full annual valuation thereof; Power to Trustees to make charges for services not otherwise provided for; Superannuation Allowances to Officers and Servants of the Trustees ; Amendment and Incorporation of Acts; and other purposes.)

OTICE is hereby given that application is intended to be made to the Secretary for Scotland by Petition under the provisions of the 1899, for a Provisional Order (hereinafter called "the Order") promoted by the Wick and Pulteney Harbours Trustees, incorporated by the Wick and Pulteney Harbours Acts, 1879 to 1899 (in this notice called "the Trustees") for the following or some of the following objects, powers, and purposes, that is to say:—

- (12) A quay wall, commencing at a point on the north side of the north pier one thousand four hundred and seventy feet or thereby from the outer or seaward

proceeding thence in a south-easterly direction for a distance of one thousand four hundred and seventy-five feet or thereby, and terminating there by a junction with head of the north pier, which work will be solid throughout :

- (13) A spur wall, commencing at a point two hundred and thirty-five feet or thereby from the commencement of work number (12), and proceeding in a north-easterly direction for a distance of twenty-five feet or thereby, and there terminating, which work will be solid throughout:

13. To make bye-laws, and to alter, vary, and rescind existing bye-laws, and to make any new or existing bye laws applicable to the existing harbour and to the works authorised by the Order, and in particular to empower the Trustees regulating the use of the harbour by young per- | sons under the age of fourteen years; to provide for making the parents or legal guardians of such young persons responsible for any breach or infraction of such bye-laws, after due notice of previous infringement, and to make provision for the imposition of penalties for contravention of such bye-laws.

14. 17. To provide that the assessments on the harbour and property of the Trustees within the harbour area for all municipal or other purposes leviable by or payable to the Corporation of the Burgh of Wick by virtue of any statute shall, notwithstanding the provisions of the Wick Burgh Extension Order Confirmation Act, 1902, be imposed on the full annual value thereof, as entered in the valuation roll of the Burgh of

18. To make provision for the quays of the Trustees being public and legal quays.

19. To empower the Trustees to let or lease any lands or premises which may be acquired by them under the authority of the Order, or any lands in the neighbourhood thereof authorised to be reclaimed by the Order, to fish dealers, fishcurers, or other persons, and on such terms as the Trustees may think fit, and to levy and recover rents and stallages in respect thereof, and to make other provisions in relation thereto; and to empower the Trustees to sell, feu, let, or lease, or otherwise dispose of, any lands or property vested in them, and which may not be required for the purposes of the Order or the Harbour undertaking.

23. To vary or extinguish all rights, powers, privileges, authorities, jurisdictions, inconsistent with, or which may interfere with, the objects or purposes of the Order, or any of them, and to confer, vary, or extinguish other rights and privileges. 24. To incorporate with and to extend and
