THE King has been graciously pleased to signify His intention to confer the decoration of the Victoria Cross on the under-mentioned Officers, whose claims have been submitted for His Majesty's approval, for their conspicuous bravery in Somaliland, as stated against their names:—

Bikanir Camel Corps	Captain W. G. Walker, Indian Army	During the return of Major Gough's column to Danop on the 22nd April last, after the action at Daratoleh, the rear-guard got considerably in rear of the column, owing to the thick bush, and to having to hold their ground while wounded men were being placed on camels. At this time Captain Bruce was shot through the body from a distance of about 20 yards, and fell on the path unable to move.
Berbera Bohotle Flying Column	Captain G. M. Rolland, Indian Army, Intelligence Officer	
		Captains Walker and Rolland, two men of the 2nd Battalion King's African Rifles, one Sikh and one Somali of the Camel Corps were with him when he fell.
		In the meantime the column, being unaware of what had happened, were getting further away. Captain Rolland then ran back some 500 yards and returned with assistance to bring off Captain Bruce, while Captain Walker and the men remained with that officer, endeavouring to keep off the enemy, who were all round in the thick bush. This they succeeded in doing, though not before Captain Bruce was hit a second time, and the Sikh wounded. But for the gallant conduct displayed by these officers and men, Captain Bruce must have fallen into the hands of the enemy.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it was enacted

that it should be lawful for His Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland, that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said first-named Act had been received, in pursuance thereof, to order that no new burial ground should be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland (or as the case might require) that after a time mentioned in such Order burials within certain limits, or in certain burial grounds or places of burial should be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council should thereupon have like force and effect as if the same were embodied in the said Act: Provided always that notice of such Representation, and of the time it should please His Majesty to order the same to be taken into consideration by the Privy Council, should be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same should be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the Parish affected by such Representation, one month before such Representation was so considered:

And whereas the Secretary for Scotland made a Representation stating that he had received a copy of an Interlocutor by the Sheriff-Substitute at Kilmarnock, finding that St. Andrew's Burying Ground, situate in the Burgh of Kilmarnock (St. Andrew's *quoad sacra* Parish), is in an overcrowded and insanitary condition and is dangerous to health.

And whereas in the said Representation it was recommended that the said Burying Ground should be closed as a place of sepulture, subject to certain exceptions:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order as follows, viz:—

That St. Andrew's Burying Ground, situate in the Burgh of Kilmarnock (St. Andrew's *quoad sacra* Parish) be closed as a place of sepulture, except for the burial of—

- (1) Any widow or widower of over sixty years of age at the date of this Order, whose husband or wife has been buried therein.
- (2) Persons claiming right of interment and receiving licence therefor under section 8 of the Burial Grounds (Scotland) Act, 1855.

Provided always, as regards all interments after the date of this Order, that the exercise of the right of burial shall not be injurious to public health; that no interment shall be made in any part of the Burying Ground unless the coffin can be laid without displacement of remains, at a depth of four feet from the surface of the ground to the upper side of the coffin and with an interval of at least one foot between adjacent coffins; that such burials be made at sight of the Sanitary Inspector of the District in which the said

Burying Ground is situated ; and that notice be given to the Sanitary Inspector on the day preceding that on which a grave is to be opened.

The KING's Most Excellent Majesty in Council.

WHEREAS the Patents, Designs, and Trade Marks Act, 1883, amongst other things provides by section thirty-nine that the exhibition of an invention at an industrial or international exhibition certified as such by the Board of Trade or the publication of any description of the invention during the period of the holding of the exhibition or the use of the invention for the purpose of the exhibition in the place where the exhibition is held or the use of the invention during the period of the holding of the exhibition by any person elsewhere without the privity or consent of the inventor shall not prejudice the right of the inventor or his legal personal representative to apply for and obtain provisional protection and a patent in respect of the invention or the validity of any patent granted on the application provided that both the following conditions are complied with, namely :—

(a) The exhibitor must before exhibiting the invention give the Comptroller the prescribed notice of his intention to do so ; and

(b) The application for a patent must be made before or within six months from the date of the opening of the exhibition.

And whereas the said Act further provides by section fifty-seven that the exhibition at an industrial or international exhibition certified as such by the Board of Trade or the exhibition elsewhere during the period of the holding of the exhibition without the privity or consent of the proprietor of a design or of any article to which a design is applied or the publication during the holding of any such exhibition of a description of a design shall not prevent the design from being registered or invalidate the registration thereof provided that both the following conditions are complied with, namely :—

(a) The exhibitor must before exhibiting the design or article or publishing a description of the design give the Comptroller the prescribed notice of his intention to do so ; and

(b) The application for registration must be made before or within six months from the date of the opening of the exhibition.

And whereas His Majesty by virtue of the authority committed to Him by the provisions of the Patents Acts, 1886, is empowered by Order in Council from time to time to declare that the provisions of the said Act of 1883 above recited shall apply to any exhibition mentioned in the Order in like manner as if it were an industrial or international exhibition certified by the Board of Trade and to provide that the exhibitor shall be relieved from the conditions specified in the said hereinbefore recited sections of the said Act of 1883.

Now, therefore, His Majesty by and with the advice of His Privy Council and by virtue of the authority committed to Him by the said Act of

1886 doth declare and it is hereby declared that the provisions of the foregoing sections of the said Act of 1883 shall apply to the International Exhibition to be held at Saint Louis in the year one thousand nine hundred and four ; and further, that the exhibitor of an invention, a design, or any article to which a design is applied shall be relieved from the conditions specified in the said hereinbefore recited sections of the said Act of 1883 of giving notice as therein required of his intention to exhibit such invention, design, or article to which a design is applied.

CONSTITUTION OF A PORT LOCAL AUTHORITY.

Order of the Local Government Board for Scotland constituting the Local Authority of the Burgh of Glasgow, in terms of the Public Health (Scotland) Act, 1897, the Port Local Authority of the Port of Glasgow.

To all Local Authorities whose district or part of whose district forms part of or abuts on any part of the Port of Glasgow or the waters of such Port ;

To all Persons having authority in or over such Port or any part thereof ;

To the Local Authority of the Burgh of Greenock ;

And to all others whom it may concern ;

Whereas the Port of Glasgow is a Port established for the purposes of the laws relating to the Customs of the United Kingdom ;

And whereas the district of the Local Authority of the Burgh of Glasgow forms part of or abuts on the said Port ;

And whereas the districts of the after-mentioned Local Authorities under the Public Health (Scotland) Act, 1897, also form part of or abut on the said Port, viz. :—

The Local Authority of the Burgh of Rutherglen,

The Local Authority of the Burgh of Govan,

The Local Authority of the Burgh of Partick,

The Local Authority of the Burgh of Renfrew,

The Local Authority of the Burgh of Clydebank,

The Local Authority of the Burgh of Dumbarton,

The Local Authority of the Burgh of Kirkintilloch,

The Local Authority of the Lower Ward District of the County of Lanark,

The Local Authority of the Upper District of the County of Renfrew,

The Local Authority of the Lower District of the County of Renfrew,

The Local Authority of the Western District of the County of Dumbarton,

The Local Authority of the Eastern District of the County of Dumbarton ;

And whereas it is expedient that a Port Local Authority should be constituted for the said Port, and that the expenses incurred by such Port Local Authority should be apportioned as hereinafter mentioned ;

Now, therefore, We, the Local Government Board for Scotland, in pursuance of the powers given to Us by the Public Health (Scotland) Act, 1897, in that behalf, hereby order as follows:—

SECTION I.

Constitution of Port Local Authority.

Article 1.—This Order shall come into operation on the first day of October, One thousand nine hundred and three.

Article 2.—The Local Authority under the Public Health (Scotland) Act, 1897, for the Burgh of Glasgow shall be constituted the Port Local Authority for the said Port of Glasgow.

SECTION II.

Limits of Jurisdiction.

Article 3.—The jurisdiction of the said Port Local Authority shall, subject to the exceptions hereinafter in this Article mentioned, extend to the whole of the said Port of Glasgow as defined by the Treasury Warrant dated 19th April 1859, and to the place or places for the time being appointed as the Customs Boarding Station or Stations for the said Port, and the place for the time being appointed for the mooring or anchoring of ships for the said Port under any regulation for the prevention of the spread of diseases issued under Part IV. of the Public Health (Scotland) Act, 1897, and to all waters, harbours, and strands belonging to the said Port, and to so much of any district forming part of or abutting on said Port as comprises any dock, basin, quay, wharf, or other place for the embarkation or disembarkation of persons or the lading or unlading, transshipping, or removal of goods on or from any ship; but the jurisdiction of the said Port Local Authority shall not extend to or include the harbours of Dumbarton and Renfrew so far as not forming portions of the River Clyde, nor the Forth and Clyde Canal to the east of the creek and harbour of Bowling, and the harbour works connected therewith.

SECTION III.

Assignment of Powers, &c.

Article 4.—For the purposes of this Order the following Parts and Sections of the Public Health (Scotland) Act, 1897, shall apply, and the Port Local Authority shall, within the limits of their jurisdiction, have, exercise, perform, and be subject to, all the powers, rights, duties, capacities, liabilities, and obligations of a Local Authority under these Parts and Sections so far as the same are applicable, namely:—

Preliminary.—Section 4.

Part I.—Sections 6 to 10 inclusive, and Sections 14 and 15.

Part II.—Sections 16 to 27 inclusive, and Sections 29, 30, 36, 37, 40, and 43.

Part III.—Sections 44 to 73 inclusive, Section 77.

Part IV.—Sections 78 to 88 inclusive.

Part VII.—Sections 136, 137, 141, and 142.

Part VIII.—Sections 144 and 145.

Part IX.—Sections 146 to 171 inclusive.

Part X.—Sections 172 to 176 inclusive.

Part XI.—Sections 177 to 188 inclusive.

Part XII.—Sections 189 to 196 inclusive.

Article 5.—Nothing in this Order shall affect the provisions of Section 39 of the Greenock Corporation Act, 1893, or the powers and duties of the Local Authority of the Burgh of Greenock to execute the Public Health Acts with respect to any ships coming or being within their jurisdiction and not bound for the Port of Glasgow.

SECTION IV.

Expenses, Accounts, &c.

Article 6.—The Local Authority of the Eastern District of the County of Dumbarton shall pay to the said Port Local Authority the sum of Ten Pounds per annum towards the expenses incurred and to be incurred by the said Port Local Authority by virtue of the authority conferred on them by this Order, and the Local Authorities of the Burghs of Glasgow, Govan, and Partick shall pay to the said Port Local Authority the amount of the remainder of the said expenses in proportion to the annual value of the whole lands and heritages within their respective districts.

Article 7.—The Accounts of the said Port Local Authority shall at all reasonable times be open to inspection and transcription without payment by any member of any Local Authority contributing as aforesaid, or by any officer of any such Local Authority authorised by them for that purpose.

Article 8.—The Accounts of the said Port Local Authority shall be audited in accordance with regulations framed by Us, by an Auditor who shall be appointed by Us and be paid by the Port Local Authority such fee as We may approve. A copy of the Auditor's Report and of the Abstract of the Accounts of the said Port Local Authority when duly audited shall be sent by the Port Local Authority to each of the Local Authorities contributing as aforesaid.

Article 9.—If at any time any difference arises between the Port Local Authority on the one hand and any Local Authority or Authorities on the other hand, or between any two or more Local Authorities, respecting any matters arising out of the provisions of this Order, the same may, if all the parties concerned agree, be referred to and be settled by a sole Arbitrer appointed in manner set forth in Sub-section Eleven of Section One hundred and forty-five of the Public Health (Scotland) Act, 1897.

Article 10.—The Port Local Authority may, for the purpose of obtaining payment of the sums to be contributed by Local Authorities in terms of this Order, inspect, take copies of, or make extracts from any Valuation Roll in force in the districts of the said Local Authorities or any book relating to the same.
