PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS on the ninth day of September one thousand eight hundred and eighty-six, a Convention (hereinafter called the Berne Convention) with respect to the protection to be given by way of copyright to the authors of literary and artistic works was concluded between Her late Majesty Queen Victoria and the foreign countries following, that is to say:—Belgium, Hayti, Switzerland, France, Italy, Germany, Spain, and Tunis.

And whereas on the fifth day of September one thousand eight hundred and eighty-seven, the ratifications of the said Convention were duly exchanged between Her late Majesty Queen Victoria and the aforesaid countries.

And whereas by an Order in Council dated the twenty-eighth day of November one thousand eight hundred and eighty-seven, and made under the authority committed to Her late Majesty Queen Victoria by the International Copyright Acts, 1844 to 1886, Her Majesty was pleased to make provision for giving rights of copyright throughout Her Majesty's dominions to the authors of literary and artistic works first produced in any of the said foreign countries (therein referred to as the foreign countries of the Copyright Union) and otherwise giving effect throughout Her Majesty's dominions to the terms of the said Berne Convention, and an English translation of the said Convention was set out in the first schedule to the said Order in Council.

And whereas since the date of the said Order in Council the foreign countries following, namely:—Luxembourg, Monaco, Montenegro, and Norway have acceded to the said Berne Convention, and by Orders in Council dated respectively the tenth day of August one thousand eight hundred and eighty-eight, the fifteenth day of October one thousand eight hundred and eighty-nine, the sixteenth day of May one thousand eight hundred and ninety-three, and the first day of August one thousand eight hundred and ninety-six, and made under the authority aforesaid, the provisions of the said Order in Council of the twenty-eighth day of November one thousand eight hundred and

eighty-seven have been extended to the last-mentioned foreign countries respectively.

And whereas an Additional Act to the said Berne Convention was agreed upon between Her late Majesty Queen Victoria and the following foreign countries for the purpose of varying the provisions of the said Berne Convention, namely, Germany, Italy, Switzerland, Belgium, Luxembourg, Spain, Monaco, Tunis, France, and Montenegro, and the ratifications of the said Additional Act were on the ninth day of September one thousand eight hundred and ninety-seven exchanged between Her late Majesty Queen Victoria and the said foreign countries.

And whereas by an Order in Council dated the seventh day of March one thousand eight hundred and ninety-eight, and made under the authority aforesaid, Her late Majesty Queen Victoria was pleased to make provision for varying the hereinbefore recited Order in Council of the twenty-eighth day of November one thousand eight hundred and eighty-seven, and otherwise giving effect to the said Additional Act throughout Her Majesty's dominions so far as regards the foreign countries hereinbefore named as parties to the said Additional Act, and an English translation of the said Additional Act is set forth in the Schedule to the Order in Council now in recital.

And whereas the Republic of Hayti having duly acceded to the said Additional Act, the said Order in Council of the seventh day of March one thousand eight hundred and ninety-eight was by Order in Council of the nineteenth day of May one thousand eight hundred and ninety-eight extended to the said Republic.

And whereas the Empire of Japan having duly acceded to the said Berne Convention and the said Additional Act, the said Orders in Council of the twenty-eighth day of November one thousand eight hundred and eighty-seven, and the seventh day of March one thousand eight hundred and ninety-eight, were by Order in Council of the eighth day of August one thousand eight hundred and ninety-nine extended to the said Empire of Japan.

And whereas the Principality of Montenegro having duly denounced the said Berne Convention the said Order in Council of the sixteenth day of May one thousand eight hundred and ninety-three was revoked by an Order in Council of the eighth day of August one thousand eight hundred and ninety-nine, and the provisions of the said Orders in Council of the twenty-eighth day of November one thousand eight hundred and eighty-seven, and the seventh day of March one thousand eight hundred and ninety-nine, have ceased to apply to the said Principality of Montenegro.

And whereas the foreign countries following, namely:—Luxembourg, Monaco, Norway, and Japan, together with the foreign countries comprised in the said Order in Council of the twenty-eighth day of November one thousand eight hundred and eighty-seven, now constitute the foreign countries of the Copyright Union within the meaning of the said Order in Council of the twenty-eighth day of November one thousand eight hundred and eighty-seven.

And whereas it has been intimated to His Majesty's Government that the Government of Denmark have notified the accession of that country to the said Berne Convention and Additional Act so far as regards the Kingdom of

Denmark and the Faroe Islands, but excluding Iceland, Greenland, and the Danish Antilles, such accession to take effect from the first day of July one thousand nine hundred and three.

And whereas His Majesty in Council is satisfied that the said Government of Denmark has made such provisions as it appears to His Majesty expedient to require for the protection of authors' works first produced in His Majesty's dominions.

Now, therefore, His Majesty, by and with the advice of His Privy Council and by virtue of the authority committed to His Majesty by the International Copyright Acts, 1844 to 1886, doth order, and it is hereby ordered as follows:—

1. From and after the commencement of this Order the hereinbefore recited Orders in Council of the twenty-eighth day of November one thousand eight hundred and eighty-seven, and the seventh day of March one thousand eight hundred and ninety-eight, shall extend to the Kingdom of Denmark and the Faroe Islands.

2. This Order shall come into operation as from the first day of July one thousand nine hundred and three, which date is hereinbefore referred to as the commencement of this Order.

3. And the Lords Commissioners of His Majesty's Treasury are to give the necessary orders herein accordingly.

WHEREAS by Section 8 of "The Weights and Measures Act, 1878," it is provided that the Board of Trade shall from time to time cause such new denominations of Standards, being either equivalent to or multiples or aliquot parts of the imperial weights and measures ascertained by the said Act, as appear to them to be required in addition to those mentioned in the second schedule to the said Act, to be made and duly verified, and that those new denominations of Standards, when approved by His Majesty in Council, shall be Board of Trade Standards in like manner as if they were mentioned in the said schedule:

And whereas it has been made to appear to the Board of Trade that a new denomination of Standard weight of fifty pounds, or "Half-cental," being a multiple of the imperial weight of one pound ascertained by the said Act, is required, and they have caused the same to be made and duly verified and deposited in their custody:

And whereas it has also been made to appear that such standard fifty pounds weight should be of a prescribed form:

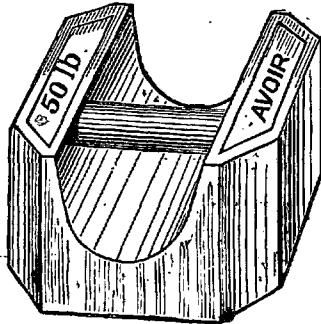
Now, therefore, His Majesty, by virtue of the power vested in Him by the said Act, by and with the advice of His Privy Council, is pleased to approve of the fifty pounds weight as a new denomination of Standard, and doth direct that the same shall be of the form prescribed in the schedule hereto, and be a Board of Trade Standard in like manner as if it was mentioned in the second schedule to "The Weights and Measures Act, 1878."

SCHEDULE.

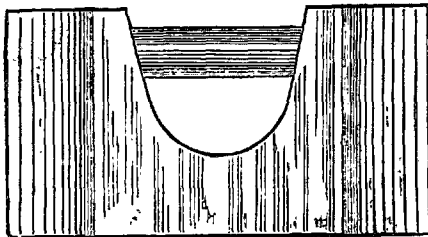
Octagonal form of 50 lb. standard weight deposited at the Standards Department, Board of Trade :—

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the twenty-fourth day of August one thousand nine hundred and three, in the words following, viz. :—

"Whereas Your Majesty was graciously pleased by Your Order in Council, dated the twenty-sixth day of September one thousand nine hundred and one, to establish regulations for the grant from Naval Funds of Pensions and Allowances to widows and children of non-commissioned officers, petty officers, and men of the Royal Navy and Marines and of the Reserve Forces whose deaths are attributable to warlike operations :

"And whereas the Pensions which may be granted under such regulations are at higher rates than the pensions which are granted from the funds of Greenwich Hospital to the widows of Seamen, Marines, and other seafaring persons who are killed or drowned on duty in the service of the Crown (other than warlike operations), or on lifeboat service, under authority of an Order in Council of Her late Majesty bearing date the twelfth day of December one thousand eight hundred and eighty-three :

"And whereas we deem it advisable that these pensions and allowances shall be granted according to an uniform scale :

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the Pensions which are now granted from the funds of Greenwich Hospital being supplemented from Naval Funds to the extent which may be necessary to raise them as from the first July one thousand nine hundred and three to the scale sanctioned by Your Majesty's aforesaid Order in Council of the twenty-sixth day of September one thousand nine hundred and one :

"The Lords Commissioners of Your Majesty's Treasury have expressed their concurrence in this proposal :

"We further beg leave humbly to recommend that Your Majesty may be graciously pleased to approve of the regulations for the grant of Pensions and Allowances from the funds of Greenwich Hospital which are annexed hereto being substituted for those now in force."

REGULATIONS for the Grant of Pensions to Widows, and Allowances to Children, and of Gratuities to Parents and other Relatives of Seamen, Marines, and other Seafaring Persons.

1. Under the second section of Act 46 and 47 Vict. cap. 32, Pensions and Allowances are granted by the Admiralty out of the Funds of Greenwich Hospital to Widows and Children of—

- (a) Non - commissioned officers and petty officers and men of the Royal Navy and Marines killed or drowned in the service of the Crown, or on lifeboat service ; and of
- (b) Men of the Royal Naval Volunteers (i.e., Royal Naval Reserve) killed or drowned in the service of the Crown ; and of
- (c) Men killed or drowned in the service of the Crown while serving in the Seamen Pensioners' Reserve ; and of
- (d) Men of the Royal Naval Artillery Volunteer Force killed or drowned in the service of the Crown.

2. These Pensions and Allowances are granted also to Widows and Children of non-commissioned officers, petty officers, or men as aforesaid who die from the effects of any injury or disease when it shall be proved to the satisfaction of the Admiralty—

- (a) That the injury or disease was caused by accident on duty in the service of the Crown, and that the man died therefrom within two years ; or
- (b) That the injury or disease was caused by extraordinary exposure or exertion on duty in the service of the Crown, and that it terminated fatally within two years of being first certified.

3. Pension or Allowance will not be granted when death has been due to a man's own culpable action or negligence, or when the Widow was not legally married to the man before the receipt of the injury or before the disease was contracted.

4. The Pensions are supplemented from Naval Funds, and awards are made according to the following scale :—

Rates in excess of the foregoing scale may, at the discretion of the Admiralty, be awarded in cases needing special relief.

5. If a Widow re-marry, her Pension will cease, and she will be eligible to receive a Gratuity equal to one year's pension in full discharge of all claims upon the public bounty. Allowances to children may be continued.

6. Pensions and Allowances are tenable subject to good behaviour, and are granted at the discretion of the Admiralty. They cannot be claimed as a right. Any assignment, sale, or contract relating to a Pension or Allowance is void.

7. If a Mother die, or children be removed from a Mother's control on account of her misconduct (see paragraph 6), the allowances in respect of the Children may be paid at twice the normal rates (see paragraph 4); or provision may be made for the maintenance of the Children in a benevolent institution.

8. If a Widow be in receipt of parish relief, in respect either of herself or her family, the payment of the Pension or Allowance may be suspended. In no case will the Pension or Allowance be paid to the parish authorities.

9. Widows will be required to make a declaration quarterly or whenever it may be considered necessary, before a duly authorised person, as to their continued widowhood, and of any particulars required in reference to their families. (Forms for this purpose will be supplied.)

10. Boys above 14 and girls above 16 will, as a rule, be ineligible for Allowances.

11. If the claim of a Widow to a Pension be not established before her death, the amount of the Pension to which she would have been entitled if living will not be allowed to her representatives.

12. These Regulations apply only from the first July one thousand nine hundred and three.

13. In the event of men specified in paragraphs 1 and 2 not leaving Widows or Children, but leaving Parents or other Relatives dependent upon them, Gratuities not exceeding one year's full wages may be given at the discretion of the Admiralty to such Parents or Relatives, provided the total expenditure in such Gratuities shall not

exceed in any one year the sum of five hundred pounds.

NOTE.—Widows of Coast Guard Men entitled to Civil Pensions are excepted from these Regulations.

And whereas the provisions of section one of the Rules Publication Act, 1893, have been complied with:

His Majesty having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
