(Vesting Existing Harbours in Promoter; Construction and Maintenance of New Pier at Portencross; Widening and Extension of Existing Harbours there; Dredging; Regulation of Harbours and Byelaws; Rates; Power to appoint Harbour Master; Power to supply Steam Tugs, &c.; Limits of Harbours; Borrowing and other Powers; Incorporation and Amendment of Acts.)
