The KING's Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it was enacted that it should be lawful for His Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said first-named Act had been received, in pursuance thereof, to order that no new burial ground should be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland (or as the case might require) that after a time mentioned in such Order burials within certain limits, or in certain burial grounds or places of burial, should be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council should thereupon have like force and effect as if the same were embodied in the said Act: Provided always that notice of such Representation, and of the time it should please His Majesty to order the same to be taken into consideration by the Privy Council, should be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same should be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the Parish affected by such Re- Mary Hamilton in lair No. 398; to Adam Letham

presentation, one month before such Representation was so considered:

And whereas the Secretary for Scotland made a Representation stating that he had received a copy of an Interlocutor by the Sheriff-Substitute of Lanarkshire at Hamilton, finding that the public Burying Ground known as St. Ninian's Churchyard, lying in the Parish of Stonehouse and County of Lanark, is in a condition which is offensive and contrary to decency:

And whereas in the said Representation it was recommended that the said public Burying Ground should be closed, subject to certain reservations:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, there ore, His Majesty, by and with the advice of His Privy Council, is pleased to order as follows, viz .:-

That burials be discontinued in the said public Burying Ground, known as St. Niman's Churchvard, except for the burial of any widow or widower whose husband or wife has been buried in the said Burying Ground, and under reservation (first) of the right of interment to John Mitchell, Physician and Surgeon, Arnold House, Silloth, and Jane Mitchel, Branxion, Stonehouse, in lot No. 379 of said Burying Ground; to George Meikle and E. Meikle h s wife in lair No. 354; to Gavin Lawrie in lair No. 432; to John Hamilton in lair No. 59; to Peter M'Niven in lair No. 9; to

in lair No. 443; to William Craig in lair No. 472; to Walter Borland in lair No. 238; and to Robert Small in lair No. 190; and (second) of the right of interment to members of a family in those graves in which a member of said family has been interred since 1st January 1891, and from which, to make room for such interment, the bones have been collected and redeposited at a depth of seven feet, as such graves are shown on the list No. 3,7 of the proceedings before the Sheriff of Lanarkshire at Hamilton for the closing of said Burying Ground, which list is retained in the hands of the Sheriff-Clerk at Hamilton; provided, however, that the number of interments in each of said graves shall not exceed three, and subject to the further conditions as regards all interments after the date of this Order, that the exercise of the right of burial shall not be injurious to public health or offensive or contrary to decency, and that notice be given to the Sanitary Inspector on the day preceding that on which a grave is to be opened, and that no interment shall be made unless the costin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.

^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

CUSTOM HOUSE, LONDON, April 1, 1905.

Whereas it is desirable to make provision for the delivery from Premises licensed for the manufacture of Tobacco by the Commissioners of His Majesty's Inland Revenue for transmission by Parcel Post to Places out of the United Kingdom

of such goods as the suid Commissioners may from time to time allow. We, the Commissioners of His Majesty's Treasury, in exercise of the powers conferred upon us by the 14th section of the Post Office (Parcels) Act, 1882, and of all other powers enabling us in this behalf, do, by this Warrant, made on the recommendation of the Commissioners of His Majesty's Customs and of His Majesty's Postmaster-General (testified by their respectively signing the same), order, direct, and declare as follows:—

- (1) The Foreign Parcels (Customs) Warrant, 1885, shall not apply to parcels of goods, delivered from Premises licensed for the manufacture of Tobacco by the Commissioners of His Majesty's Inland Revente, hereinafter referred to as "bonded parcels."
- (2) Every bonded parcel delivered from Promises licensed for the manufacture of Tobacco by the Commissioners of His Majesty's Island Revenue to the sender shall be accompanied by an authority for such delivery signed by an officer of Island Revenue.
- (3) The Officer of the Post Office accepting a bonded parcel, duly accompanied by the

Inland Revenue authority, shall give to the sender a certificate of the posting of the parcel.

- (4) The certificate of posting thus given shall, for the purposes of section 104 of the Customs Consolidation Act, 1876, relating to the exportation of bonded goods, be deemed to be evidence of an act equivalent to shipment under that section.
- (5) The delivery of bonded parcels from Premises licensed for the manufacture of Tobacco by the Commissioners of His Majesty's Inland Revenue shall be subject to such bond, and to such special conditions, as the said Commissioners may from time to time prescribe.
- (6) If any claim shall be made on the Postmaster-General for compensation in respect of the loss of or damage to any bonded parcel, that claim shall, in the absence of proof to the contrary, be deemed to be conclusive evidence that such parcel has not been duly exported, and that its contents have gone into consumption in the United Kingdom, and any drawback paid shall be repaid by the Tobacco Manufacturer.
- (7) This Warrant shall come into operation on the first day of April 1905.
- (8) This Warrant may be cited as the "Foreign Parcels (Inland Revenue) Warrant, 1905."

CIVIL SERVICE COMMISSION.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz.:-

REGULATIONS respecting Open Competitive Examinations for the situation of Valuer and Surveyor (Second Section) in the Department of the General Valuation and Boundary Survey of Ireland.

N.B.—These Regulations are liable to alteration for future Examinations.

I. The limits of age for this situation are 22 and 28, and Candidates must be of the prescribed age on the first day of the Examination.

In reckoning age for competition the following allowances will be made, viz. :-

(i.) Persons who have served in the Army or Navy may deduct from their actual age any time during which they have served;

(ii.) Persons who may be serving or who may have served in the Militia, the Imperial Yeomanry, the Honourable Artillery Company, or the Volunteers, may deduct from their actual age any time spent on actual military service, such time being reckoned by the number of days for which they received Army pay;

(iii.) Persons who have served for two full consecutive years-

> (A) In any Civil situation to which they were admitted with the certificate of the Civil Service Commissioners,

> (B) In the Royal Irish Constabulary, or (C) As Registered Boy Clerks in connection with the Civil Service,

may deduct from their actual age any time not exceeding five years which they may have spent in such service.

II. Candidates will be required to show what technical education and preliminary training they have undergone to qualify themselves for a situation of this nature. They must show (1) that they have served for at least two years in a public or private office under a Civil Engineer,

Architect, or Surveyor; (2) that the works on which they have been engaged during those years were such as to afford them the opportunity of gaining a satisfactory knowledge of their profession; and (3) that they have fully profited by their practical training, and possess the necessary qualifications and experience. Evidence on these points must be sent in at such times and in such manner as the Civil Service Commissioners may appoint. If such evidence should prove prima facie satisfactory, the Candidate will be admitted to examination, subject, in the case of his being successful in the competition, to such further inquiry, and the production of such further evidence as may be necessary.

III. The Examination will be in the following subjects, viz.:—

- 1. Énglish Composition (including Handwriting and Orthography).
- 2. Arithmetic.
- 3. Land Surveying, including Draughtsmanship and the making and plotting of Surveys; and either
- Architectural Surveying and Valuing;
 or
- Practical Farming, including the elements of Geology and Chemistry as applied to Agriculture, and Land Valuing.

In subjects 3, 4, and 5, there will be an Oral and Practical Examination.

Candidates must pass to the satisfaction of the Civil Service Commissioners in subjects numbered 1, 2, 3, and must obtain such an aggregate of marks in the Examination, as a whole, as may indicate, in the judgment of the Civil Service Commissioners, a competent amount of general proficiency.

IV. Subject to the provisions of Clause II. of these Regulations, the examinations are open to all natural-born or naturalised British subjects, being of the requisite age, health, and character, with the following restrictions:—

- (i.) The following classes of persons are ineligible, viz.:—
 - (a) Persons actually serving in the Army or Navy.
 - (b) Members of the Royal Irish Constabulary of less than five years' service.
 - (ii.) The following classes of persons are eligible under certain conditions only, that is to say:—
 - (c) Persons holding situations in the Civil Service.
 - (d) Members of the Royal Irish Constabulary, of more than five years' service.
 - (e) Probationary Engineer Cadets in the Navy, and Apprentices in His Majesty's Dockyards.
 - (f) Persons who have been trained in Training Colleges at the public expense.
 - (g) Persons who have been trained in the Inland Revenue Branch of the Government Laboratory.
 - Persons comprised in the classes (c), (d), (e) must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.

Persons comprised in class (f) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

Persons comprised in class (g) will not be qualified for appointment until the consent of the Board of Inland Revenue, given with the like sanction, has been notified to the Civil Service Commissioners.

V. Application for permission to attend an Examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.

VI. A fee of £3 will be required from every Candidate attending an Examination.

- 2. Every passenger shall enter or depart from a carriage by the hindermost or conductor's platform, and not otherwise.
- 3. No passenger shall smoke inside any carriage.
- 4. No passenger or other person shall, while travelling in or upon any carriage, play or perform upon any musical instrument.
- 5. A person in a state of intoxication shall not be allowed to enter or mount upon any carriage, and if found in or upon any carriage shall be immediately removed by or under the direction of the conductor.
- 6. No person shall swear or use obscene or offensive language whilst in or upon any carriage, or spit, or commit any nuisance in or upon or against any carriage, or wilfully interfere with the comfort of any passenger.
- or wilfully interfere with the comfort of any passenger
 7. No person shall wilfully cut, tear, soil, or damage
 the cushions or the linings, or remove or deface any
 number plate, printed or other notice, in or on the
 carriage, or break or scratch any window of or otherwise
 wilfully damage any carriage, or interfere with the

 Any person acting in contravention of this Regulation
