#### CIVIL SERVICE COMMISSION,

April 14, 1905.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz.: —
SPECIAL REGULATIONS respecting Open Competi-

SPECIAL REGULATIONS respecting Open Competitive Examinations for the situation of Second Class Clerk in the Dublin Metropolitan Police Courts.

N.B.—These Regulations are liable to alteration for future Examinations.

1. The limits of age for this situation are 17 and 25, and Candidates must be of the prescribed age on the first day of the Examination.

In reckoning age for competition the following allowances will be made, viz:—

(i.) Persons who have served in the Army or Navy may deduct from their actual age any time during which they have served;

(ii.) Persons who may be serving or who may have served in the Militia, the Imperial Yeomanry, the Honourable Artillery Com-

pany, or the Volunteers. may deduct from their actual age any time spent on actual military service, such time being reckoned by the number of days for which they received Army pay;

(iii.) Persons who have served for two full consecutive years—

(A) In any Civil situation to which they were admitted with the certificate of the Civil Service Commissioners,

(B) In the Royal Irish Constabulary, or
 (C) As Registered Boy Clerks in connection with the Civil Service,

may deduct from their actual age any time not exceeding five years which they may have spent in such service.

II. The Examination will be in the following subjects, viz.:—

Obligatory-

- 1. Reading aloud.
- 2. Handwriting.
- 3. Orthography.
- 4. Arithmetic (including Vulgar and Decimal Fractions).
- 5. English Composition.
- 6. Proceedings before Magistrates.
- 7. Law of Evidence.

Optional—

- 8. Copying imperfect manuscripts.
- 9. Indexing or Docketing.
- 10. Digesting Returns, &c., into Summaries.
- 11. Bookkeeping by Single Entry.
- 12. Any one of the following, viz.:—
- a. Latin (translation from).
- b. French (translation from).c. German (translation from).
- d. Geography and English History.

III. The Examinations are open to all naturalborn or naturalised British subjects, being of the requisite age, health, and character, with the following restrictions:—

(i.) The following classes of persons are in-

eligible, viz.—

(a) Persons actually serving in the Army or Navv.

(b) Members of the Royal Irish Constabulary of less than five years' service.

- (ii.) The following classes of per ons are eligible under certain conditions only, that is to say—
  - (c) Persons holding situations in the Civil Service.
  - (d) Members of the Royal Irish Constabulary of more than five years' service.
  - (e) Probationary Engineer Cadets in the Navy, and Apprentices in His Majesty's Dockyards.
  - (f) Persons who have been trained in Training Colleges at the public expense.
  - (g) Persons who have been trained in the Inland Revenue Branch of the Government Laboratory.
  - Persons comprised in the classes (c), (d), (e) must obtain the permission of the authorities of their Department to attend the Examination, before the commencement of the competition.
  - Persons comprised in class (f) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notifield to the Civil Service Commissioners.

Persons comprised in class (g) will not be qualified for appointment until the consent of the Board of Inland Revenue, given with the like sanction, has been notified to the Civil Service Commissioners.

IV. Application for permission to attend an Examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.

V. A fee of £2 will be required from each Candidate attending an Examination.
