ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 19TH APRIL 1905.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

The application of the provisions of the Sheep-Scab (Regulation of Movement) Order of 1905 to the area described in the Schedule to this Order is suspended from the date hereof until after the thirty-first day of May nineteen hundred and five.

In witness whereof the Board of Agriculture and Fisheries have hereunto set their Official Seal this nineteenth day of April nineteen hundred and five.

SCHEDULE.

Area to which this Order applies.

An area comprising the Counties of Aberdeen, Argyll, Banff, Caithness, Clackmannan, Dunbarton (except its detached part), Elgin, Fife, Forfar, Inverness, Kincardine, Kinross, Nairn, Orkney, Perth, Ross and Comarty, Sutherland, and Zetland, and that part of the County of Stirling which lies to the north of a line from the mouth of the Carron River on the Forth at Grangemouth, and following the Caledonian and North British Railway line from Grangemouth viâ Falkirk, Larbert Junction, and Kilsyth, to the point where it crosses the County boundary of Dunbarton between Belmore and Summerston Stations; the Cities of Aberdeen, Dundee, and Perth; and the Burghs of Campbeltown, Peterhead, Dunbarton, Elgin, Dunfermline, Kirkcaldy, Arbroath, Brechin, Forfar, Montrose, Inverness, and Stirling, and that part of the Burgh of Falkirk which lies to the north of the railway line aforesaid.
