TREASURY CHAMBERS, November 8, 1905.

Prohibition under section 5 of "The Customs and Inland Revenue Act, 1888," of the use in Beer of certain substances.

Whereas by a Notice published in the London Gazette of the eighteenth day of May 1888, the Lords Commissioners of the Treasury prohibited the use of a certain chemical or artificial extract or product from Coal Tar, commonly called "Saccharin," in the manufacture and preparation for sale of Beer; and whereas by a Notice published in the London Gazette of the tenth day of December 1901, the said Lords Commissioners prohibited the use of a certain other chemical or artificial product, commonly called "Sucramine," in the manufacture and preparation for sale of Beer.

And whereas there is another chemical or artificial product of a similar kind called "Sugarol."

And whereas it appears to the satisfaction of the said Lords Commissioners that Saccharin, Sucramine, Sugarol, and the compounds of Saccharin, Sucramine, and Sugarol respectively, and also all other substances being chemical or artificial products which furnish the chemical tests of Saccharin, are capable of being used in the manufacture and preparation for sale of Beer, and that the use of any of the said substances is calculated to affect prejudicially the interests of the Revenue.

Now, the said Lords Commissioners, under the power conferred upon them by section 5 of "The Customs and Inland Revenue Act, 1888," do hereby prohibit the use of any of the said substances in the manufacture and preparation for sale of Beer.

Dated this eighth day of November 1905.

N.B.—A penalty of £50 is imposed by the said section for any breach of this prohibition.

Perth Gas Act, 1871 (hereinafter called "the Act of 1871") and to repeal Section 46 of that Act and provide that the limits for the supply of gas by the Corporation (hereinafter called "the limits of supply") shall comprise and include the Burgh of Perth and the Parishes of Scone, Kinnoull, Kinfauns, Rhynd, Dunbarney, Forgandenny, Aberdalgie, Tibbermore, Redgorton, St. Martins, Kilspindie, Errol, St. Madoes, Abernethy, Dron, Forteviot, Findo-Gask, Methven, Moneydie, Auchtergaven, Kinclaven, Cargill, Collace, Kinnauld, Arngask, and Dunning, all in the County of Perth, or some or one of them or so much thereof respectively as lies within a radius of seven miles beyond the boundaries of the said Burgh, and to enable the Corporation to have and exercise within the limits of supply all the rights, powers, privileges, and authorities which they now have or may exercise within the said existing limits of supply, including the powers of breaking up streets and roads and levying and recovering rates, rents, and charges for the supply of gas and apparatus used in the consumption of gas and residual products arising from the manufacture of gas, and to extend and make applicable to the limits of supply the provisions or some of them of the Act of 1871, and any other Act or Order relating to or affecting the gas undertaking of the Corporation and of the Order.

2. To empower the Corporation within the limits of supply to supply gas for lighting and also for motive power, heating, cooking, warming, ventilating, manufacturing, agricultural, industrial, and generally for business or trade purposes on such terms and conditions as the Corporation may determine, or as may be agreed between the Corporation and the person to whom such supply shall be given, and to levy, collect, and recover rates, rents, and charges, differential or otherwise, for the sale and supply of gas for the purposes aforesaid.

3. To authorise the Corporation to manufacture, purchase, provide, sell, supply, let for hire, or otherwise deal in, contract for doing work in connection with, fix, repair, and remove engines, stoves, gas fires, ranges, pipes, meters, fittings, lamps, burners, incandescent mantles, apparatus and appliances for lighting, for motive power, for heating, cooking, ventilating, manufacturing, agricultural, industrial, or any other purpose for which gas can or may be used, and that either free of charge or for such remuneration or rents and charges, and on such terms and conditions as may be agreed upon, or as the Corporation shall deem reasonable and proper, and to provide that such articles and fittings aforesaid shall not be subject to pawning, distress, or the landlord's remedy for rent, or be liable to be taken in execution under any process or proceedings in bankruptcy.

4. To provide for notice being given to the Corporation before any pipes or fittings used or intended to be used for the distribution or supply of gas are covered over or used, and to empower the Corporation to inspect, examine, and test the same, and to prohibit the use, and require the alteration or removal of such as from insufficient size, material, or strength, or the construction, workmanship, or the method of laying thereof, would be likely to allow of the escape of gas, and to empower the Corporation to specify or prescribe the size and

material and strength of any pipes and fittings to be used, and the method of laying the same and the position of the meter, and to relieve the Corporation from any obligation to supply gas to premises in which the pipes or fittings have been found by them to be defective or insufficient, and have not been made sufficient, or the meter has not been placed as required by the Corporation.

5. To provide where it is intended to lay down or fix any pipes, wires, tubes, or apparatus for the conveyance or supply of electrical energy (hereinafter called "electric fittings") in any house or other building in which pipes, fittings, or apparatus for the conveyance or consumption of gas are fixed or fitted, for notice being given to the Corporation by the owner or occupier of such house or building before a supply of electrical energy is afforded, and to empower the Corporation to enter into any such house or building to inspect and examine such electric fittings and the position thereof relatively to such gas pipes, fittings, or apparatus, and to compel such alteration of such electric fittings, or in the position thereof, as may seem to the Corporation necessary for the safety of the premises.

6. To empower the Corporation from time to time to make, vary, rescind, and enforce bye-laws and regulations for or with respect to the matters or any of them mentioned in the two immediately preceding paragraphs of this Notice.

7. To authorise the Corporation in the case of any building occupied in flats or separate dwellings, entering by a common stair or other access, and belonging to one or more owners, to lay and fit up service pipes in such common stair, with branches to communicate with each separate flat or dwelling for supplying any occupier or occupiers with gas without the consent of the owner or any other owner or owners, occupier or occupiers, as the case may be.

8. To empower the Corporation to provide, fit up, and maintain and renew in any common stair such pipes, lamps, brackets, and other fittings as the Corporation may deem necessary for the proper and sufficient lighting thereof, and to provide the necessary supply of gas therefor, and by their servants or other persons employed by them to clean any lamps and brackets and light and extinguish the same, and to make all necessary provisions for those purposes, and also to levy and recover all rates and charges payable to and incurred by them for and in connection with the aforesaid purposes from the occupiers or failing occupiers, from the owners of all flats or dwellings entering from such common stair, in proportion to the respective real rents or annual values of such flats or dwellings respectively.

9. To repeal, alter, and vary the provisions of the Act of 1871; the Perth Water and Gas Act, 1888 (hereinafter called "the Act of 1888"); and the Perth Harbour City Improvements and Gas Act, 1897 (hereinafter called "the Act of 1897"), with respect to the quality, illuminating power, and pressure, and the testing of the gas supplied by the Corporation, and to alter the method of testing the candle power thereof, and reduce the number of candles prescribed by the said Acts, and make such further or other provisions with respect to the quality, illumina-

ting power and pressure, and the testing of the gas or otherwise in relation thereto as the Order may prescribe.

10. To make special provisions for or with respect to the following matters:—The erroneous registration by defective meters, and the charges for gas in such cases; the use of antifluctuators or other similar apparatus in connection with gas engines, and to enable the Corporation to refuse to supply or continue to supply gas to any engines not fitted with antifluctuators or such similar apparatus as may be prescribed by the Corporation; the liability of owners and occupiers of premises which have been let or sub-let for sums due to the Corporation in respect of such premises; the notice to be given to the Corporation before disconnecting any gas meter or before discontinuing the use of gas, or ceasing to occupy houses or other premises supplied with gas by the Corporation; the relieving of the Corporation from obligation to supply premises in debt to the Corporation; the supply of gas and specifications of internal fittings; the construction and placing of pipes with the fittings thereof between the Corporation's mains and the consumers' premises; the laying of pipes in roads not dedicated to the public use; the payment and recovery of rents, rates, and charges, and requiring a deposit in respect thereof or the prepayment of the same in certain cases; the payment by the Corporation of interest on moneys deposited with them as security for the payment of the price or rent of any meter supplied by them; the allowance of discounts or rebates to consumers of gas and of electrical energy in consideration of prompt payment or large consumption; the purchase by the Corporation of waggons and trucks for the conveyance of coal, oxide of iron, lime, shells, and secondary products to and from their gas works; and freeing the Corporation from penalties for insufficiency of pressure, defect in illuminating power, or for excess of impurity in the gas supplied by them in cases of unavoidable cause or accident.

11. To authorise the Corporation on their lands situate at Friarton, in the East Church Parish of Perth and County of Perth, described in the Second Schedule to the Act of 1897 or on any part thereof, or on any lands which they may acquire by agreement, to erect, provide, and maintain dwelling-houses for officers, workmen, and others employed by the Corporation in connection with their gas undertaking, or to appropriate any lands for the time being vested in them for those purposes, and to defray the cost of the erection and maintenance of such dwelling-houses out of the contingency and depreciation of works fund provided by Section 78 of the Act of 1897, or otherwise to borrow the money required for those purposes on the security of the said fund and the moneys for the time being standing to the credit thereof.

12. To empower the Corporation out of the rates and revenues of their gas undertaking to establish a Fire Insurance Fund to be available for the purpose of reconstructing, rebuilding, repairing, restoring, replacing, and making good any loss or damage by or in consequence of fire to any buildings, works, and property belonging or on loan to, or under the care, custody, or control of the Corporation for the purposes of or in connection with their gas undertaking,

and to make all necessary provisions in reference thereto; and also out of the said rates and revenues to create an Accident Fund to meet claims upon them under the Employers' Liability and Workmen's Compensation Acts; and also to grant allowances and pensions to aged or disabled employees in connection with the gas undertaking, and to the dependants of employees who may be serving with any of His Majesty's forces.

13. To empower the Sheriff of the County of Perth or any of his Substitutes, notwithstanding the provisions in that behalf of the Town Councils (Scotland) Acts, 1900 and 1903, on the application of the Corporation, as provided for by Section 15 of the Act of 1871, to appoint an auditor to audit and docket the accounts of the Corporation relating to their gas undertaking on the terms and otherwise as provided for in the said Section.

14. To provide, notwithstanding the provisions of the Town Councils (Scotland) Acts, 1900 and 1903, in that behalf, that the accounts of the Corporation relating to their gas undertaking shall be made up and balanced to the 30th day of April in each year, or otherwise to amend or repeal Section 7 of the Act of 1871 and to provide that the annual general meeting referred to in that Section shall be held by the Corporation in Perth, on the second Monday of July in the year 1906 and in each year thereafter.

15. To enable the Corporation to pay any surplus profits, not exceeding £250 in any one year, arising from their gas undertaking after payment of all annual charges affecting the same and such other charges as the Order may provide, into the Common Good of the Burgh of Perth, to be applied by the Corporation in promoting the interests or maintaining the dignity of the city, or for any useful purpose connected with the administration of the city as the Corporation may think proper, or as may be specified in or provided by the Order.

16. To authorise and provide for the purchase or redemption by the Corporation, compulsorily or otherwise, of the Perth gas annuities authorised or constituted under the provisions of the Act of 1871, or of such of them as remain unredeemed, on such terms and conditions, and at such time or times, and in such way or manner as the Corporation may deem expedient, or as may be agreed to between the Corporation and the respective holders of the said annuities, or as may be prescribed by the Order, and to empower the Corporation to enter into and carry into effect agreements or arrangements with such holders of annuities accordingly, and such holders, including trustees and holders with limited interests, to enter into such agreements or arrangements, and to make all necessary provisions for carrying out and effecting such purchase or redemption of the said annuities.

17. To empower any holder of Perth gas annuities, being a person enabled by the Lands Clauses Consolidation (Scotland) Act, 1845 (Section 7), to sell land, to consent to the purchase or redemption of the annuities or annuity so held by him.

18. To authorise the Corporation to continue or to alter or vary and to levy rates, rents, and charges (differential or otherwise) for the supply of gas and for residual products, and to make, levy and recover for gas supplied by them beyond the boundaries of the burgh of Perth,

or within such area as may be defined by the Order, higher rates, rents and charges than those made and levied for gas supplied within the said burgh or such other area; to levy new and additional rates, rents, and charges for the objects and purposes of the Order; and to confer, vary, or extinguish exemptions from the payment of rates, rents, and charges.

19. To authorise the Corporation to apply to the purposes or any of the purposes set forth in this notice, and of the Order, any moneys now belonging to or held by them in respect of the gas undertaking, and for those purposes or any of them to borrow and from time to time to reborrow additional money on mortgage, bond, annuity, or cash credit, or by the creation and issue of stock, on the security of the whole or any part of the property, works, and plant forming their gas undertaking, and of the rates, rents, charges, and other revenues arising therefrom, and to grant mortgages, bonds, or other deeds or securities for the same, and to provide the forms thereof, and of assignment, transfer, and discharge thereof.

20. To authorise the Corporation for the purpose of providing temporarily for current expenses, or for the payment of any expenses which they are entitled to defray from moneys borrowed or authorised to be borrowed by them, to borrow by way of temporary loan or overdraft from any bank, or on temporary loan on deposit receipt from any person, on the security of the rates, rents, charges, and revenues of their gas undertaking, such sums as they may from time to time resolve, and to make all necessary and proper provisions with reference thereto.

21. To remove any legal disability affecting any person or persons lending money to or entering into contracts with the Corporation, and to make all necessary provisions with respect to the rankings and priorities of moneys already borrowed by the Corporation in connection with their gas undertaking and of the additional moneys to be borrowed under the powers of the Order (including temporary loans) and the application thereof, and with respect to a sinking fund or sinking funds for the repayment of such moneys borrowed and to be borrowed by the Corporation, or the redemption of stock which they may create and issue, as the Order may prescribe.

22. To vary or extinguish all rights and privileges which may interfere with any of the objects or purposes of the Order, and to confer all rights and privileges necessary or expedient for effecting those objects or purposes, or in relation thereto.

23. To incorporate with, and to extend and make applicable to the objects and purposes of the Order, all or some of the provisions of all or some or one of the following Acts (that is to say the Commissioners Clauses Act, 1847, the Gas Works Clauses Act, 1847, the Gas Works Clauses Act, 1871, the Burgh Police (Scotland) Acts, 1892 to 1903, and the Local Authorities Loans (Scotland) Acts, 1891 and 1893).

24. To alter, amend, extend, or repeal, so far as may be necessary or desirable for the purposes of the Order, all or some of the provisions of all or some or one of the following Acts and Orders (that is to say) the Act of 1871, the Act of 1888, the Act of 1897, the Perth Electric Lighting Order, 1898, the Perth Water, Police, and Gas Act, 1899, the Perth Gas Order, 1900, and the Perth Corporation Order, 1904.



25. The petition for the Order and the Draft Order, and printed copies thereof, will be lodged on or before the 16th day of December next, in the office of the Secretary for Scotland, Whitehall, London, and on or before the same day a printed copy of the Draft Order will be deposited in the office of the Clerk of the Parliaments, and in the Private Bill Office of the House of Commons.

26. The subsequent procedure will be by way of Provisional Order, unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act, 1899, in which case the procedure may be by way of Private Bill, and, if the subsequent procedure shall be by way of Private Bill, this notice and the deposits with reference to the said intended application will, subject to the Standing Orders of Parliament, apply to such Bill.

- (5) To grant insurances or contracts of indemnity or guarantee against the liability of employers and others to pay compensation to workmen servants and others whether such liability arises under the Acts relating to Employers Liability or Compensation to Workmen or otherwise.
- (6) To empower the Company to undertake the insurance of carriages motor cars motor omnibuses and vehicles of every description whether drawn or propelled by animal or by mechanical power and of compensation to any person or persons for loss of life or for personal injury to persons using the same by reason of accident to any such vehicle and the insurance of the owner of any such vehicle from liability for compensation in respect of accidents of any kind to any person or persons or of damage to property caused by or arising out of the use of any such vehicle.

(Section 49) To provide that the instrument appointing any proxy shall be deposited at the Head Office of the Company not less than forty-eight hours before the time appointed for holding any meeting of the Company at which such proxy is to be used or at such other place and within such other period or otherwise as the Order may prescribe

(Section 69) To repeal the words "before the passing of this Act" therein appearing

To repeal Section 73 and so far as may be necessary to amend Section 72 and to provide that the Company may hold as long as it may deem expedient any heritable or moveable real or personal property which they have already acquired or may hereafter acquire

To amend Section 78 and make other provisions for the representation of the Company in bankruptcy and other proceedings

(Section 6 subsection (1)) To repeal the restriction on the total money which the Company may lay out or invest in the purchase of lands and interests in lands

NOTICE is hereby given that the Most Noble Charles Henry Gordon Lennox, Duke of Richmond Gordon and Lennox, K.G. 2. To enable the Undertaker to appropriate acquire by Agreement or Lease lands or interests in lands for the purposes of the Order, and to construct and maintain stations and works for the generation and supply of electricity, together with all necessary engines and apparatus.
3. To authorise the Undertaker to open and break up for the purposes of the Order, all roads, streets, and thoroughfares within the area of supply and to take up, alter, relay or divert all sewers, drains, mains pipes, wires and apparatus, and to do all such works as may be necessary to carry into effect the objects of the Order, and to lay down, set up, maintain, renew, or remove above or below ground pipes, wires, tubes, posts and apparatus and other works and things for enabling the Undertaker to supply, produce, store, convey, transform, and distribute electrical energy for the public and private purposes aforesaid, and to confer all other powers upon the Undertaker necessary for effecting the objects and purposes of the Undertaker.
4. To authorise the Undertaker to break up the following streets or roads not repairable by a Local Authority, namely:—
