PRESENT,

The KING'S Most Excellent Majesty in Council.

Whereas by an Act passed in the forty-fifth and forty-sixth years of Her late Majesty Queen Victoria's reign, intituled "The Militia Act, 1882," it is, amongst other things, enacted that, save as therein otherwise provided, the Militia shall be trained and exercised for not less than twenty-one days, and not more than twenty-eight days, in every year, at such times and at such places in every part of the United Kingdom as His Majesty may appoint, and also that His Majesty may from time to time, with the advice of His Privy Council, order that the period of training and exercise, in any year, of all or any part of the Militia be extended, but so that the whole period of training and exercise be not more than fifty-six days; and also, on the other hand, may order that in any year the annual training of all or any part of the Militia be dispensed with.

And whereas it is expedient for the year one [thousand nine hundred and six that the training of the Militia units hereinafter mentioned should be extended beyond the period of twenty-eight

Now, therefore, His Majesty, with the advice of His Privy Council, is pleased to order and direct that for the year one thousand nine hundred and six the period of training and exercise of the under-mentioned Regiment of Militia shall be extended, under the provisions of the before cited Act, from twenty-eight days to fifty-six days, viz. :-

The Lancashire Royal Field Artillery;

that the period of training and exercise of the under-mentioned Service Companies (specially trained for Bridging) and Depôt Companies of Militia shall be extended from twenty-eight days to forty-eight days, viz. :-

Royal Anglesey Royal Engineers, and Royal Monmouthshire Royal Engineers;

that the period of training and exercise of the under-mentioned Field Companies and Service Companies (specially trained for Railway work) of Militia shall be extended from twenty-eight days to fifty-five days, viz. :-

Royal Anglesey Royal Engineers, and Royal Monmouthshire Royal Engineers;

that the period of training and exercise of the under-mentioned Regiments of Militia shall be extended from twenty-eight days to forty-one days, viz. :-

The Antrim Royal Garrison Artillery, The Cardigan Royal Garrison Artillery, The Carmarthen Royal Garrison Artillery, The Cork Royal Garrison Artillery, The Devon Royal Garrison Artillery The Duke of Edinburgh's Own Edinburgh Royal Garrison Artillery, The Londonderry Royal Garrison Artillery, The Pembroke Royal Garrison Actillery, The Suffolk Royal Garrison Artillery, and The Yorkshire (Duke of York's Own) Royal Garrison Artillery;

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 30TH JUNE 1906.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows—

Application of Swine-Fever (Regulation of Movement) Order of 1903.

1. From and after the commencement of this Order the provisions of the Swine-Fever (Regulation of Movement) Order of 1903 shall apply to the Area described in the First Schedule to this Order, and the Area described in the Second Schedule hereto shall thereupon cease to be a separate Area.

Provision as to Local Regulations.

2. The powers of the Local Authorities of any district comprised in the First Schedule hereto to make regulations under the Swine-Fever Order of 1894, as to movement, exposure, or sale of swine, shall be suspended during the operation of this Order, and all such regulations in force at the commencement of this Order shall thereupon cease to operate.

Commencement.

3. This Order shall come into operation on the first day of August, nineteen hundred and six.

In witness whereof the Board of Agriculture and Fisheries have hereunto set their Official Seal this thirtieth day of June, nineteen hundred and six.
