A PROCLAMATION

Declaring that the Colony of New Zealand shall be called and known by the title of the Dominion of New Zealand.

EDWARD, R. & I.

THEREAS We have, on the Petition of the Members of the Legislative Council and House of Representatives of Our Colony of New Zealand, determined that the title of the Dominion of New Zealand shall be substituted for that of the Colony of New Zealand as the designation of the said Colony, We have therefore, by and with the advice of Our Privy Council, thought fit to issue this Our Royal Proclamation, and We do ordain, declare, and command that on and after the twenty-sixth day of September one thousand nine hundred and seven, the said Colony of New Zealand and the territory belonging thereto shall be called and known by the title of the Dominion And We hereby give Our of New Zealand. Commands to all Public Departments accordingly.

Given at Our Court at Buckingham Palace, this ninth day of September, in the year of our Lord one thousand nine hundred and six, and in the seventh year of Our Reign.

The KING's Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it was enacted that it should be lawful for His Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said first-named Act had been received, in pursuance thereof, to order that no new burial ground should be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland (or as the case might require) that after a time mentioned in such Order burials within certain limits, or in certain burial grounds or places of burial, should be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council should thereupon have like force and effect as if the same were embodied in the said Act: Provided always that notice of such Representation, and of the time it should please His Maje-ty to order the same to be taken into consideration by the Privy Council, should be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same should be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the Parish affected by such Representation, one month before such Representation | CHANCERY OF THE ROYAL VICTORIAN ORDER, was so considered:

And whereas the Secretary for Scotland made Representations stating that he had received copies of Interlocutors by the Sheriff of Ross and Cromarty at Stornoway, finding that the Burial Grounds at Little Bernera and Kirivig, situated in the Parish of Uig, are so crowded with bodies as to be contrary to decency:

And whereas in the said Representations it was recommended that the said Burial Grounds should

be closed as hereinafter directed:

And whereas notice of the said Representations, and of the time when it pleased His Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows, viz.:

That the said Burial Grounds at Little Bernera and Kirivig, situated in the Parish of Uig, shall be closed, except for the burial of any person, widow or widower, whose husband or wife has been burisd in either of the said Burial Grounds, and subject to the conditions as regards all interments in the said Burial Grounds after the date of this Order-(1) that the exercise of the right of burial shall not be injurious to the public health, or offensive or contrary to decency; (2) that notice shall be given to the Clerk to the Lewis District Committee, Stornoway, on the day preceding that on which a grave is to be opened; (3) that no interment shall be made unless the coffin can be laid at a depth of three feet at least, and where possible at a depth of four feet, from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin:

WHITEHALL, September 9, 1907.

The King has been pleased to confer the Albert Medal of the First Class upon Mr. William Henry Pearce, of Islington, near Newcastle, New South Wales, for conspicuous gallantry in saving life on the railway between Maitland and Newcastle, on the 4th December 1905, as detailed below:—

On the morning of the day mentioned, while the passenger train running between Maitland and Sydney was approaching Thornton Railway Station, at the rate of 45 miles an hour, a boiler plate of the engine collapsed, and through the opening, about 12 inches square, steam and boiling water were ejected with great force. Both the driver of the engine. James Pead, who has since succumbed to his injuries, and the fireman, Pearce, were severely scalded. Pead was quite incapacitated, and was still exposed to the full force of the escaping steam when Pearce, at great personal risk, lifted him to a place of safety behind the bunker tank,

Pearce having endeavoured, without success, to close the throttle valve, climbed over the cab of the engine, along the boiler, to the front of the engine, exposing himself again to the escaping water and steam, and having reached the footplate of the engine, and placed one leg in the draw hook for support, he reached under the buffer plank for

a distance of about 18 inches, and opened the cock of the air pipe, thus applying the automatic brake and bringing the train to a standstill.

The presentation of the medal in the name of His Majesty, was performed by His Excellency the Governor-General of Australia, at Government House, Sydney, on the 16th July.

^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
