LOCAL GOVERNMENT (SCOTLAND) ACTS. COUNTY COUNCIL ELECTORAL DIVI-SIONS OF STIRLINGSHIRE.

PARISH OF ST. NINIANS.

ORDER by the Secretary for Scotland.

WHEREAS by Order of the Boundary Commissioners, dated 22nd January 1892, the Parish of St. Ninians was divided into four Electoral Divisions, named respectively—(1) Bannockburn, (2) Cambusbarron, (3) Sauchie, and (4) Polmaise and Plean:

And whereas the County Council of the County of Stirling have represented to me that a material change of circumstances has occurred in respect of the population and annual value of the Electoral Division of Polmaise and Plean, and that it is desirable to divide the area comprised in the said Electoral Division into two Electoral Divisions, and accordingly to alter the number of County Councillors:

And whereas I am of opinion that it is expedient to give effect to the proposal of the said County Council:

Now therefore I, the Right Honourable John Sinclair, His Majesty's Secretary for Scotland, do, in virtue of the powers conferred on me by section 51 of the Local Government (Scotland) Act, 1889, order as follows:—

1. The number of County Councillors for the County of Stirling shall be increased from fortyfive to forty-six.

2. The Polmaise and Plean Electoral Division as defined by the Order of the Boundary Commissioners for Scotland, dated 22nd January 1892,

shall be divided into two County Council Electoral Divisions, having the following names and contents, that is to say :---

Names of Electoral Divisions.	Contents of Electoral Divisions.
Polmaise Division	That part of the present Pol- maise and Plean Division lying to the north of the middle line of the road known as the Cowie road in said Parish, extending from the end of Tait's Close, Bannockburn, to a point near Burnhead stead- ing and of a line drawn thence in an easterly direc- tion along the southern boundary of the lands of Throsk to the Parish boundary.
Plean Division .	The remaining portion of the present Polmaise and Plean Division lying to the south of the lines above described.

LOCAL GOVERNMENT (SCOTLAND) ACTS.

COUNTY COUNCIL ELECTORAL DIVISIONS OF THE COUNTY OF LANARK WITHIN THE BURGHS OF GOVAN, PARTICK, AND MOTHERWELL, AND THE PARISHES OF BOTHWELL. CAMBUS-LANG, AND CADDER.

Whereas the contents and boundaries of the electoral divisions of the County of Lanark were determined by an Order under the hand and seal of the Secretary for Scotland, dated 16th May, 1899;

And whereas the contents and boundaries of the electoral divisions of the police burghs of Govan and Partick were altered by Orders under the hand and seal of the Secretary for Scotland, dated 11th October, 1901, and 14th September, 1904, respectively;

And whereas by deliverance of the Sheriff of the County of Lanark, dated 16th March, 1906, the municipal wards of the police burgh of Motherwell were increased from four to five, and altered in description so that, as now con-""" stituted, they do not coincide with the County Council electoral divisions as determined under the said Order of the Secretary for Scotland, dated 16th May, 1899;

And whereas the police burghs of Govan, Partick, and Motherwell, and the parishes of Bothwell and Cambuslang have within recent years increased in population and annual value;

And whereas certain parts of the Parish of Cadder, which is divided into two electoral divisions, have increased in population and annual value so as to make it advisable that the description of the contents and boundaries of these divisions should be readjusted;

And whereas, in view of the aforesaid material change of circumstances, the County Council of Lanark have applied to me for an Order in terms of Section 51 of the Local Government (Scotland) Act, 1889, providing for, *inter alia*, an increase in the representation of the Burghs of Govan, Partick, and Motherwell, and of the Parishes of Bothwell and Cambuslang, and for the readjustment of the contents and boundaries of the electoral divisions therein as well as in the Parish of Cadder;

And whereas I am of opinion that it is expedient to give effect to the application of the said County Council, subject to certain modifications.

Now, therefore, I, the Right Honourable John Sinclair, His Majesty's Secretary for Scotland, in virtue of the powers conferred upon me by the said Acts, do hereby order and determine that the contents and boundaries of the electoral divisions within the police burghs of Govan, Partick, and Motherwell, and the Parishes of Bothwell, Cambuslang, and Cadder, shall be as follows, viz. :--

BURGH OF GOVAN.

GOVAN (NORTH PLANTATION).—That part of the Fifth Municipal Ward of the police burgh of Govan which lies to the north of the centre of Paisley Road, and to the east of a line drawn in a northerly direction from the junction of Paisley Road and Maclean Street along the centre of Maclean Street to its northmost point,

and thence continuing in the same direction as the said street to the burgh boundary.

GOVAN (CESSNOCK).—That part of the Fifth Municipal Ward not included in the North Plantation Division.

GOVAN (BELLAHOUSTON).—The Sixth Municipal Ward.

GOVAN (WHITEFIELD).—The Fourth Municipal Ward.

GOVAN (BROOMLOAN).—The Third Municipal Ward.

GOVAN (CROSS).—Those parts of the First and Second Municipal Wards of the police burgh of Govan which lie to the east of a line drawn in a southerly direction from the burgh boundary at the north end of Holme Street along the centre of the said street to its southmost point, thence direct to the north end of Harmony Row, and along the centre of Harmony Row to its junction with Marr Street, thence along the centre of Marr Street to its junction with Helen Street, and thence along the centre of Helen Street to the southern boundary of the burgh.

GOVAN (FAIRFIELD).—That part of the First Municipal Ward not included in the Cross Electoral Division.

GOVAN (CRAIGTON).—That part of the Second Municipal Ward not included in the Cross Electoral Division.

GOVAN (LINTHOUSE).—The Seventh Municipal Ward.

BURGH OF PARTICK.

PARTICK EAST.—The First Municipal Ward. PARTICK EAST CENTRAL.—The Second Muni-

cipal Ward.

PARTICK CENTRAL.—The Third Municipal Ward.

PARTICK WEST CENTRAL.—The Fourth Municipal Ward.

BROOMHILL.—The Fifth Municipal Ward. WHITEINCH.—The Sixth Municipal Ward.

BURGH OF MOTHERWELL.

MOTHERWELL (SOUTH).—The First Municipal Ward.

MOTHERWELL (EAST).—The Third Municipal Ward.

MOTHERWELL (NORTH).—The Fourth Municipal Ward.

MOTHERWELL (WEST).—The Second and Fifth Municipal Wards.

PARISH OF BOTHWELL.

HOLYTOWN .- That part of the Parish of Bothwell which lies to the north of the Dalzel Electoral Division and east of a line drawn along the centre of the Caledonian Railway from Coatbridge to Motherwell northwards till it reaches a point opposite the north boundary fence of the plantation marked "Reset Plantstion " on the Ordnance Survey Map; thene to the said boundary fence; thence following the line of said fence eastwards, north-eastwards, and eastwards till it reaches the march fence which separates the estates of Cambre and Woodhall; thence in an easterly, northerly, north-easterly, and northerly direction along the march between the estates of Cambroe and Woodhall till it reaches the North Calder Water.

BELLSHILL (EAST).—That part of the Parish of Bothwell which lies to the west of the Holytown Division, to the north of the South Calder Water, to the south of the North Calder Water, and to the east of a straight line commencing in the centre of Holmforge Bridge, which crosses the South Calder Water, northwards till it reaches the centre of the main street (Edinburgh Highway) at a point opposite Barty's Road; thence westwards along the centre of the said main street for a distance of 107 yards or thereby to a point opposite Bowling Green Street; thence along the centre of the last-mentioned street; thence in a straight line northwards till it reaches the Shirrel Burn; thence along the said burn in a north-westerly direction till it reaches the North Calder Water.

BELLSHILL (WEST) .- That part of the Parish of Bothwell which lies to the west of the Bellshill (East) Electoral Division, and is otherwise bounded as follows, viz. :--Commencing at a point in the centre of the South Calder Water at Holmforge Bridge; thence in a westerly and southerly direction along the South Calder Water to a point where the said water is crossed by the Clydesdale section of the Caledonian Railway; thence in a north-westerly direction along the centre of the said railway to a point near Fallside Station where the Uddingston Coal Highway crosses the railway; thence slong the centre of the said highway in a northeasterly direction to a point in the centre of Edinburgh Highway near Fallside House; thence in an easterly direction along the centre of the last-mentioned highway to a point 100 yards or thereby west of Belziehill Steading; thence in a northerly direction in the line of a fence to a point in the centre of the Old Edinburgh Highway leading from Tannochside to Bellshill; thence easterly for a distance of 20 yards or thereby along the centre of the last-mentioned highway; thence in a northerly direction along fences of fields till it reaches a point in the North Calder Water near the gasometer at Douglas Support; thence in an easterly direction along the North Calder Water to the junction of the Shirrel Burn.

BOTHWELL ELECTORAL DIVISION .- That part of the Parish of Bothwell which lies to the south-west of the Bellshill Electoral Division and to the north of the parish boundary from s point in the centre of the South Calder Water where the Clydesdale section of the Caledonian Railway crosses the said water ; thence following the parish boundary in a southerly, westerly, and southerly direction till it reaches the River Clyde; thence along the River Clyde till it reaches a point due west of the southmost point of Bothwell Castle; thence in a straight line to the said southmost point of said castle ; thence along the centre of the avenue from Bothwell Castle to the south gable of the principal entrance lodge of said castle; thence nund the south gable of the said principal entrance lodge till it reaches a point in the centre of the Bothwell Highway from Uddingston to Bothwell opposite the centre of the entrance at the front gate lodge; thence in a south-easterly direction along the centre of the said highway to a point 186 yards or thereby southeast of said gate lodge; thence in a north-easterly direction along a footpath past Main's Cottage till it joins the Uddingston Coal Highway from Uddingston to Bellshill; thence in a north-easterly direction along the centre of the last-mentioned highway till it reaches the

Clydesdale section of the Caledonian Railway from Glasgow to Motherwell.

UDDINGSTON ELECTORAL DIVISION. — That part of the Parish of Bothwell which lies to the north-west of the Bothwell Electoral Division. generally to the east of the River Clvde to the south-east of the North Calder Water, and to the south-west of a line drawn from a point in the centre of the Hamilton and Bothwell section of the North British Railway where the said railway intersects the boundary of the parish as it crosses the North Calder Water; thence south-eastwards along the centre of the said railway till it reaches a point 200 yards or thereby north-west of Uddingston West Station; thence in a straight line in a south-easterly direction at a distance of 100 yards from and purallel to the Edinburgh Highway leading from Glasgow to Bellshill till it reaches the fence to the east of Thornwood House; thence in a south-westerly direction along said fence till it reaches the North British Railway from Hamilton to Glasgow near the Roman Catholic Church; thence in a south-easterly direction alon, said railway till it reaches the boundary of the Bothwell Electoral Division near Main's Cottage.

TANNOCHSIDE ELECTORAL DIVISION.—The remainder of the Parish of Bothwell, so far as not included in the Dalziel Electoral Division.

PARISH OF CAMBUSLANG.

HALLSIDE.—The Hallside Parliamentary Polling District.

CAMBUSLANG (NORTH).—That portion of the Parish of Cambuslang which lies to the north of the a line commencing at the point where the parish boundary intersects the main road from Glasgow with ROOM to Hamilton; thence in an easterly and four the easterly direction along the centre of the same of the road till it reaches the boundary of the Hallside Polling District to the east of Gateside Rows; thence along said boundary till it reaches the Newton Burn; thence along said burn to the River Clyde; thence in a westerly direction along the centre of the River Clyde till it reaches the parish boundary at Rosebank Bridge; thence in a southerly and westerly direction along said parish boundary to the point of commencement.

CAMBUSLANG (SOUTH).—The remainder of the Parish of Cambuslang.

PARISH OF CADDER.

BISHOPBRIGGS.—That part of the Parish of Cadder lying generally to the west of a line commencing at the corner of the Glasgow Parish boundary north-east of Coshnockmuir Steading; thence in a northerly direction across the Garnkirk Burn to the Langmuirhead Road at a point in the prolongation of the western boundary of enclosure No. 1573 of the Ordnance Survey Map of the Parish of Cadder (1898 Edition); thence generally in a 1 orth-easterly direction along the south side of the said road and the north and north-west boundaries of enclosures Nos. 1581, 1583, and 1550, and across the Auchinloch Road to the north-west corner of enclosure No. 1548 of the said map; thence along the north boundary of last-mentioned enclosure and the prolongation thereof to the

centre of the Cult Burn ; thence in a north-1 (Scotland) Act, 1889, do hereby order as easterly and generally northerly direction along the Cult Burn to the east boundary of enclosure No. 854 of said map; thence in a northerly direction along said boundary fence and the continuation thereof to the centre of the Lindsaybeg Road; thence in a westerly and northerly direction along the said road to the south-west corner of enclosure No. 860 of said map; thence along the west boundary of last-mentioned enclosure to the parish and county boundary.

CHRYSTON.-The remainder of the Parish of Cadder.

The number of County Councillors for the County of Lanark shall be increased from seventy to seventy-six, and the additional County Councillors shall be assigned to the Burgh of Govan (one), the Burgh of Partick (one), the Burgh of Motherwell (one), the Parish of Bothwell (two), and the Parish of Cambuslang (one).

BURGH OF CLYDEBANK.

Whereas by their Order, dated 1st February 1892, the Boundary Commissioners for Scotland determined the Contents and Boundaries of the Electoral Divisions of the County of Dumbarton :

And whereas there were included the Electoral Divisions in the Parish of West Kilpatrick, known as Old Kilpatrick Electoral Division and Duntocher Electoral Division; and the Contents and Boundaries of Electoral Divisions so far as within the Burgh of Clydebank were, under the Order of 1st February 1892, made coincident with the then existing Municipal Wards of the said Burgh; and whereas by the Clydebank and District Water and Burgh Extension Order, 1906, the Boundaries of the Burgh of Clydebank were extended, and there were annexed and included within the Municipal limits of the Burgh portions of Old Kilpatrick and Duntocher Electoral Divisions, which portions so annexed now form the Fifth Municipal Ward of the Burgh of Clydebank :

And whereas, in view of the foregoing change of circumstances and of a material alteration in the circumstances in respect of population and valuation in the Electoral Divisions of Old Kilpatrick and Duntocher, it has been represented to me by the County Council of the County of Dumbarton that I should issue an Order, under section 51 of the Local Government (Scotland) Act, 1889, altering the Contents and Boundaries of the Electoral Divisions in the County of Dumbarton :

And whereas I am of opinion that it is expedient to give effect to the Representation of the said County Council :

Now therefore, I, the Right Honourable John Sinclair, His Majesty's Secretary for Scotland, in virtue of the powers conferred upon me by section 51 of the Local Government follows :--

1. The Order of the Boundary Commissionen, dated 1st February 1892, dealing with the Electoral Divisions of the County of Dunbarton, is hereby recalled in so far as concerns those portions of the Electoral Divisions of Old Kilpatrick and Duntocher annexed to the Burgh of Clydebank, by the Clydebank and District Water and Burgh Extension Order, 1906. The portions of Old Kilpatrick Electoral Division and Duntocher Electoral Division, now included in and forming the Fifth Municipal Ward of the Burgh of Clydebank, shall be formed into a new and additional Electoral Division, to be known as Clydebank Fifth Electoral Division.

2. The Boundaries of the Electoral Divisions of Old Kilpatrick and Duntocher shall be correspondingly altered by the exclusion therfrom of the portions thereof now included within the limits of the Burgh of Clydebank.

3. The number of County Councillors for the County of Dumbarton shall be increased from forty to forty-one, and the additional County Councillor shall be assigned to Clydebank Fifth Electoral Division.

4. Clydebank Fifth Electoral Division shall be number 37, and the numbers of the under mentioned Electoral Divisions shall be a follows :-

- 38. Kirkintilloch North-West;
- 39. Kirkintilloch North-East;
- 40. Kirkintilloch South ;
- 41. Milngavie.
