THE King has been pleased, by Warrant under His Majesty's Royal Sign Manual, bearing date the 7th day of February 1908, to direct the issue under the Seal appointed by the Treaty of Union to be kept and made use of in place of the Great Seal of Scotland of a Commission to make an inventory of the Ancient and Historical Monuments and Constructions connected with or illustrative of the contemporary culture, civilisation, and conditions of life of the people in Scotland from the earliest times to the year 1707, and to specify those which seem most worthy of preservation, as follows:—

OUR WILL AND PLEASURE IS THAT LETTERS PATENT be made and passed under the Seal appointed by the Treaty of Union to be kept and made use of in Scotland in the place of the Great Seal of Scotland, in words and to the effect following:—

EDWARD THE SEVENTH, by the Grace of God of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas King, Defender of the Faith, to—

Our right trusty and well-beloved Councillor Sir Herbert Eustace Maxwell, Baronet, Fellow of the Royal Society, President of the Society of Antiquaries of Scotland; Our trusty and well-beloved Charles John Guthrie, Esquire (commonly called The Honourable Lord Guthrie), one of the Senators of Our College of Justice in Scotland;

Our trusty and well-beloved Gerald Baldwin Brown, Esquire, Master of Arts, Professor of Fine Arts in the University of Edinburgh;

Our trusty and well-beloved Thomas Hastie Bryce, Esquire, Doctor of Medicine, Fellow of the Royal Society of Edinburgh, Fellow of the Society of Antiquaries of Scotland;

Our trusty and well-beloved Francis Christian Buchanan, Esquire.

Our trusty and well-beloved William Thomas Oldrieve, Esquire, Fellow of the Society of Antiquaries of Scotland, Principal Architect and Surveyor in Scotland to the Commissioners of Our Works and Public Buildings;

Our trusty and well-beloved Thomas Ross, Esquire, Fellow of the Society of Antiquaries of Scotland. Greeting!

Whereas We have deemed it expedient that a Commission should forthwith issue to make an inventory of the Ancient and Historical Monuments and Constructions connected with or illustrative of the contemporary culture, civilisation, and conditions of life of the people in Scotland from the earliest times to the year 1707, such as—

- 1. Sepulchral cairns and other burial places.
- 2. Forts, camps, earthworks, brochs, crannogs, and other defensive works, either overground or underground.

- 3. Stone circles and standing stones, and rock surfaces with incised or other sculpturings.
- 4. Architectural structures, ecclesiastical and secular, whether ruinous or in use, including sculptured or inscribed memorials.

And to specify those which seem most worthy of preservation.

Now know ye that We, reposing great trust and confidence in your knowledge, discretion, and ability, have nominated, constituted, and appointed, and do by these Presents nominate, constitute, and appoint you, the said Sir Herbert Eustace Maxwell (Chairman), Charles John Guthrie, Gerald Baldwin Brown, Thomas Hastie Bryce, Francis Christian Buchanan, William Thomas Oldrieve, and Thomas Ross to be Our Commissioners for the purposes of the said inquiry.

And for the better enabling you to carry out the purposes of this Commission, We do by these Presents authorise you to call in the aid and co-operation of owners of ancient monuments, inviting them to assist you in furthering the objects of this Commission; and We do further authorise and empower you to call before you such persons as you may judge necessary by whom you may be the better informed of the matters herein submitted for your consideration, and every matter connected therewith, with power to invite the possessors of such papers as you may deem it desirable to inspect to produce them before you, and to inquire of and concerning the premises by all other lawful ways and means whatsoever.

And We do further by these Presents authorise and empower you, or any one or more of you, to visit and personally inspect such places as you may deem expedient for the more effectual carrying out of the purposes aforesaid.

And we do hereby direct that you, or any one or more of you, may from time to time proceed in the execution of this Commission and of every matter and thing herein contained.

And Our further Will and Pleasure is that you Our said Commissioners, or any three or more of you, do report to Us from time to time in writing under your hands and seals all and every your proceedings under and by virtue of these Presents.

And for your assistance in the execution of these Presents, We do hereby nominate and appoint Our trusty and well-beloved Alexander Ormiston Curle, Esquire, Writer to the Signet, one of the Secretaries of the Society of Antiquaries of Scotland, to be Secretary to this Our Commission.

And We ordain the said Letters Patent to be extended in the most ample form, and to pass the Seal aforesaid per saltum, without passing any other Seal or Register. For doing whereof these Presents shall be to the Director of Our Chancery for writing the same, and to the Keeper of the said Seal for causing the same to be appended thereto a sufficient Warrant.

Given at Our Court at Buckingham Palace the seventh day of February 1908, in the eighth year of Our Reign.

### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 5TH FEBRUARY 1908.)

MID-LOTHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Movement into, out of, or within Scheduled District.

1. No cattle, sheep, goats, or swine shall be landed in, or moved into or out of, the District described in the Schedule to this Order, hereinafter referred to as the Scheduled District, or be moved along over or across a highway or thoroughfare within the Scheduled District:

provided that nothing in this Order shall be deemed to apply to the movement of animals into or out of the Scheduled District where they are moved through such District by railway from a place outside such District to another place outside such District without unnecessary delay and without the animals being untrucked or rebooked within such District.

### Local Authority to enforce Order.

2. The provisions of this Order shall be executed and enforced by the Local Authority.

### Offences.

- 3. (1.) If an animal is landed in contravention of this Order, the owner and the charterer and the master of the vessel from which it is landed, and the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the landing, and the person landing the same, and the consignee or other person receiving or keeping it knowing it to have been landed in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.
- (2.) If an animal is moved in contravention of this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movemen, and the person moving or conveying the animal, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the animal is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.
- (3.) If any persons with a view unlawfully to evade or defeat the operation of this Order allows a head of cattle or a sheep or goat or pig to stray, he shall be deemed guilty of an offence against the Diseases of Animals Act, 1894.

### Short Title.

4. This Order may be cited as the Mid-Lothian and District (Foot-and-Mouth Disease (Order of 1908.
