ORDER OF THE BOARD OF AGRI-CULTURE AND FISHERIES.

(DATED 12TH FEBRUARY 1908.)

MIDLOTHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908 (No. 3).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Modification of former Order and Contraction of Boundaries of Scheduled District.

1.—(1) The Mid-Lothian and District (Footand Mouth Disease) Order of 1908 is hereby modified in manner hereinafter appearing.

(2) The Scheduled District for the purposes of the above-mentioned Order and this Order shall after the commencement of this Order be the District described in the First Schedule to this Order.

Exception of Certain Animals from Provisions as to Movement.

- 2. Nothing in this Order shall be construed as authorising-
 - (i.) movement of an animal which is affected with Foot-and-Mouth Disease, or which has during the preceding twenty-eight days been in any way exposed to the infection of such disease; or
 - (ii.) movement of an animal the movement of which is prohibited by notice of an Inspector of the Local Authority or of the Board given under any Order of the Board; or
 - (iii.) movement of an animal along, over, or across a highway or thoroughfare

- Schedule to this Order; or
- (iv.) movement out of a Foot-and-Mouth Disease Infected Place.

Movement within Scheduled District with Licence for Special Purposes.

- 3.—(1) Where the Local Authority consider that it is necessary or expedient that any animals within their District should be permitted to be moved within the Scheduled District-
 - (i.) on a particular occasion, for feeding purposes or otherwise; or
 - (ii.) as often as occasion may require, either between different parts of the same farm, or between different farms in the District of the same Local Authority;

and it is impossible to so move the animals otherwise than along, over, or across a highway or thoroughfare, the Local Authority may authorise such movement by a Movement Licence (in the form set forth in the Third Schedule to this Order or to the like effect) granted by an Inspector of such Local Authority.

- (2) Where the movement authorised by the Licence is movement as often as occasion may require, the Licence shall be marked with the words "Occupation Licence" and shall be in force until it is revoked by an Inspector of the Local Authority by a Notice to the occupier of the farm on which the animals then are. In other cases the Licence shall be in force for not more than four days inclusive of the day of issue.
- (3) The Licence shall specify the name and address of the person to whom the Licence is granted, the number and description of the animals authorised to be moved, and the name or description of the several premises to and from which the animals are authorised to be moved.

Movement into Edinburgh, Leith or Musselburgh for Slaughter.

- 4.—(1) An animal may be moved by railway from outside the Scheduled District to a railway station in the city of Edinburgh or burgh of Leith or Musselburgh without a Licence, but an animal so moved shall only be moved from the railway station to a slaughter-house within the city or one of the said burghs, and only if accompanied by a Movement Licence granted by the Local Authority of the city or burgh. The animal shall be moved to such slaughter-house by the route described in the Licence, and after arrival at the slaughter-house shall be there detained until it is slaughtered.
- (2) An animal may also be moved by railway or otherwise from any place outside the Scheduled District to a slaughter-house in the city of Edinburgh or in the burghs of Leith or Musselburgh, respectively, if accompanied by a Movement Licence granted by an Inspector of the Local Authority of the city or burgh, which Licence shall be obtained before movement into the Scheduled District.
- (3) The Licence shall be in force for not more than four days, inclusive of the day of issue, and shall be in the form set forth in the Third Schedule to this Order, or to the like effect.

- in the Area described in the Second | Movement within Scheduled District with Licence for Slaughter.
 - 5.—(1) An animal may be moved from any premises in the Scheduled District to a slaughterhouse within such District provided that the animal is marked as required by this Article and accompanied by a Movement Licence granted by an Inspector of the Local Authority of the place from which the animal is to be
 - (2) Every animal moved under this Article shall, before the movement is commenced, be marked by and at the expense of the owner in manner following:-
 - Cattle.—By the clipping of a broad arrow 1 about six inches long on the left hind quarter of each of the cattle and by the clipping of the hair off the end of the tail.
 - Sheep.—By the clipping of a broad arrow 1 on the forehead of each of the sheep, and by the painting or stamping of the letter M, about six inches long, on both sides of each of the sheep with the following composition namely :- Rosin, five parts; oil of turpentine, two parts; and blue or red ochre, one part; melted and used warm; or with some other adhesive composition of a blue or red colour.
 - Swine.—By the painting or stamping of the letter M, about six inches long on both sides of each of the swine with the composition above-mentioned.
 - (3)) The Licence shall be in force for not more than four days, inclusive of the day of issue, and shall be in the form set forth in the Third Schedule to this Order or to the like effect.
 - (4) A copy of a Licence granted under this Article shall be sent by the Inspector granting the same to the Local Authority of the District in which is situate the place of destination specified in the Licence.

General Provisions as to Movement.

- 6.—(1) Animals, while being moved under this Order, shall be accompanied by the Licence authorising the movement and shall so far as is practicable be kept separate from all animals which are not being so moved, and shall be moved by the nearest available route and without unnecessary delay to the place of destination specified in the Licence, and not elsewhere, and where the place of destination is a slaughterhouse they shall be there detained until they are slaughtered.
- (2) Where animals are moved with a Licence under this Order to a slaughter-house, the Licence shall forthwith after completion of the movement be delivered up at, or sent by post to, the nearest Police Station in the same District by the person in charge of the animals at the time of completing the said movement.

Granting of Movement Licences.

7. A Movement Licence granted under this Order shall not be available if granted by the owner of the animal to be moved, or by his agent, or by the consignee of the animal, or by the occupier of the farm or premises or slaughterhouse from or to which the animal is to be

moved, or by any individual member of an Executive Committee or Sub-Committee of a Local Authority.

Saving for Orders and Regulations.

8. Movement of animals under this Order is subject to any Order of the Board relating to any disease other than Foot-and-Mouth Disease, and also subject to any Regulation made by a Local Authority under any Order of the Board for prohibiting or regulating the movement of animals.

Production of Licences; Names and Addresses.

- 9.—(1) Any person in charge of an animal being moved, where under this Order a movement Licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the Licence, if any, necessary for the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.
- (2) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

Offences.

- 10.—(1) If an animal is moved in contravention of the conditions of a Licence under this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the animal is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
- (2) If a person in charge of an animal being moved, where under this Order a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.
- (3) If an animal is not marked as required by this Order, the person to whom the Licence to move the animal is granted, and the owner of the animal, and the person for the time being in charge thereof, and the person failing to cause the same to be so marked, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
- (4) If any person, with a view unlawfully to evade or defeat the operation of this Order, by washing, or in any other manner, takes out, effaces, or obliterates, or attempts to take out, efface, or obliterate, any mark painted on any animal as required by this Order, the person doing the same, and the person causing, directing, or permitting the same to be done, and the owner of the animal, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(5) If any person with a view unlawfully to evade or defeat the operation of this Order allows a head of cattle, or a sheep, or goat, or pig to stray, he shall be deemed guilty of an offence against the Act of 1894.

Interpretation.

11. In this Order—

- "The Act of 1894" means the Diseases of Animals Act, 1894:
- "The Board" means the Board of Agriculture and Fisheries:
- "Animals" means cattle, sheep, goats, and swine
- "Slaughter-house" means any premises where animals are habitually slaughtered.
- Other terms have the same meaning as in the Diseases of Animals Act, 1894.

Revocation.

12. The Order described in the Fourth Schedule to this Order is hereby revoked from and after the commencement of this Order.

5 Commencement.

13. This Order shall come into operation on the fourteenth day of February nineteen hundred and eight.

Short Title, &c.

14. This Order may be cited as the MID-LOLHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908 (No. 3), and shall be read with the Order mentioned in Article 1 of this Order.

FIRST SCHEDULE.

New Scheduled District.

A District comprising the county of Mid-Lothian (except the parishes of Temple, Borthwick, Cranston, Crichton, Fala and Soutra, Heriot, and Stow); the parishes of Dalmeny, Kirkliston, and Uphall, in the county of Linlithgow, the burghs of Leith and Musselburgh, and the city of Edinburgh.

SECOND SCHEDULE.

The movement of animals under this Licence is subject to any Order of the Board of Agriculture and Fisheries relating to any disease other than foot-and-mouth disease, and also to any Regulation made by a Local Authority for prohibiting or regulating the movement of animals.

Where Animals are moved with this Licence to a slaughter-house the Licence must forthwith after completion of the movement be delivered up at, or sent by post to, the nearest Police Station in the same District by the person in charge of the animals at the time of completing the said movement, and the animals must be detained at the slaughter-house until they are slaughtered.

This Licence is not available if it is granted by the owner of the animals to be moved, or by his agent, or by the consignee of the animals, or by the occupier of the farm or premises or slaughter-house from or to which the animals are to be moved, or by any individual member of an Executive Committee or Sub-Committee of a Local Authority.

Caution.—Persons acting without a Licence where a Licence is necessary, or acting thereon after the Licence has expired, or counterfeiting, fabricating, or altering, or obtaining or endeavouring to obtain a Licence by means of a false pretence, or granting or issuing a Licence knowing the same to be false in any respect, or committing other offences with respect to a Licence, are liable, under the Diseases of Animals Act, 1894, to fine and imprisonment.
