

moved, or by any individual member of an Executive Committee or Sub-Committee of a Local Authority.

*Saving for Orders and Regulations.*

8. Movement of animals under this Order is subject to any Order of the Board relating to any disease other than Foot-and-Mouth Disease, and also subject to any Regulation made by a Local Authority under any Order of the Board for prohibiting or regulating the movement of animals.

*Production of Licences ; Names and Addresses.*

9.—(1) Any person in charge of an animal being moved, where under this Order a movement Licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the Licence, if any, necessary for the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

*Offences.*

10.—(1) If an animal is moved in contravention of the conditions of a Licence under this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the animal is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2) If a person in charge of an animal being moved, where under this Order a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.

(3) If an animal is not marked as required by this Order, the person to whom the Licence to move the animal is granted, and the owner of the animal, and the person for the time being in charge thereof, and the person failing to cause the same to be so marked, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(4) If any person, with a view unlawfully to evade or defeat the operation of this Order, by washing, or in any other manner, takes out, effaces, or obliterates, or attempts to take out, efface, or obliterate, any mark painted on any animal as required by this Order, the person doing the same, and the person causing, directing, or permitting the same to be done, and the owner of the animal, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(5) If any person with a view unlawfully to evade or defeat the operation of this Order allows a head of cattle, or a sheep, or goat, or pig to stray, he shall be deemed guilty of an offence against the Act of 1894.

*Interpretation.*

11. In this Order—

“The Act of 1894” means the Diseases of Animals Act, 1894 :

“The Board” means the Board of Agriculture and Fisheries :

“Animals” means cattle, sheep, goats, and swine.

“Slaughter-house” means any premises where animals are habitually slaughtered.

Other terms have the same meaning as in the Diseases of Animals Act, 1894.

*Revocation.*

12. The Order described in the Fourth Schedule to this Order is hereby revoked from and after the commencement of this Order.

*Commencement.*

13. This Order shall come into operation on the fourteenth day of February nineteen hundred and eight.

*Short Title, &c.*

14. This Order may be cited as the MID-LOTHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908 (No. 3), and shall be read with the Order mentioned in Article 1 of this Order.

FIRST SCHEDULE.

*New Scheduled District.*

A District comprising the county of Mid-Lothian (except the parishes of Temple, Borthwick, Cranston, Crichton, Fala and Soutra, Heriot, and Stow); the parishes of Dalmeny, Kirkliston, and Uphall, in the county of Linlithgow, the burghs of Leith and Musselburgh, and the city of Edinburgh.

SECOND SCHEDULE.

*Area in which Modifications do not take effect.*

An area which lies within the following boundaries, namely :—From the point where the Caledonian Railway crosses the Water of Leith between Craighleith and Murrayfield Railway Stations, thence in a south-westerly direction along the course of the Water of Leith to the point where the Gorgie Road crosses the Water of Leith by Saughton Mills, thence in a north-easterly direction along, and including, the Gorgie Road to the point where that road is crossed by the Caledonian Railway by the Magdalene Asylum, and thence along the said railway to the point of commencement.
