ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES. (DATED 3RD MARCH 1908.)

MID-LOTHIAN AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1908 (No. 6).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:---

Modification of former Orders.

1.—(1) The Mid-Lothian and District (Footand-Mouth Disease) Order of 1908, as modified by subsequent Orders, is hereby further modified in manner hereinafter appearing.

(2) The Scheduled District for the purposes of in this behal this Order shall be the District described in the as follows:-

First Schedule to the Mid-Lothian and District (Foot-and-Mouth Disease) Order of 1908 (No. 3).

Movement of Animals for Store purposes into Scheduled District by Licence.

2. Where the Local Authority consider it necessary or expedient that any animal should be permitted to be moved into their District for store purposes from premises outside the Scheduled District, an Inspector of the Local Authority may authorise such movement by a Movement Licence, in the form set forth in the Third Schedule to the Mid-Lothian and District (Footand-Mouth Disease) Order of 1908 (No. 3) or the like effect.

Exception of Certain Animals from Provisions as to Movement.

3. Nothing in this Order shall be construed as authorising-

- (i.) movement of an animal which is affected with Foot-and-Mouth Disease, or which has during the preceding twenty-eight days been in any way exposed to the infection of such disease; or
- (ii.) movement of an animal the movement of which is prohibited by notice of an Iuspector of the Local Authority or of the Board given under any Order of the Board; or
- (iii.) movement out of a Foot-and-Mouth Disease Infected Place; or
- (iv.) movement of an animal along, over, or across a highway or thoroughfare in the Area described in the Schedule to the Mid-Lothian and District (Foot-and-Mouth Disease) Order of 1908 (No. 5).

Short Title, &c.

4. This Order may be cited as the MID-LOTHIAN AND DISTRICT (FOOT - AND - MOUTH DISEASE) ORDEK OF 1908 (No. 6), and shall be read with the Orders mentioned in Article 1 of this Order.


