**W**HEREAS His Majesty was pleased, by  
His Commission dated the seventeenth  
day of March one thousand nine hundred and  
eight, to nominate and appoint His Royal High-  
ness The Prince of Wales, in His Majesty's  
absence from His Realm in foreign parts, to hold,  
on His Majesty's behalf, His Privy Council, and  
to signify thereat His approval of any matter or  
thing whereunto His Royal Highness should be so  
authorised by writing under His Majesty's Sign  
Manual, and to do further on His Majesty's  
behalf any matter or thing for the purposes of  
the said Commission whereunto His Royal High-  
ness should be authorised in manner aforesaid:

And whereas it is expedient to amend in  
certain particulars the regulations prescribed by  
the Order made by The King's Most Excellent  
Majesty in Council on the twenty-first day of

December one thousand nine hundred and seven,  
respecting the employment and remuneration of  
Clerks of the Second Division of His Majesty's  
Civil Service:

Now therefore, His Royal Highness The Prince  
of Wales, being authorised in that behalf by  
writing under His Majesty's Sign Manual, doth,  
by and with the advice of His Majesty's Privy  
Council, on His Majesty's behalf, order, as it is  
hereby ordered, as follows:—

1. Clause five of the Order in Council of the  
twenty-first day of December one thousand nine  
hundred and seven, shall not apply to any clerk  
whose salary will, as on the first day of April  
one thousand nine hundred and eight, under the  
provisions of the last-mentioned Order and other  
Orders in force before the twenty-first day of  
December one thousand nine hundred and seven,  
amount to a sum which is not less than one  
hundred and sixty-seven pounds ten shillings.  
nor more than two hundred and fifty pounds, and  
who is unable to obtain a report in writing from  
his immediate superior, countersigned by the  
Head of the Department, or such officer as he  
may designate for the purpose, to the effect that  
such clerk is competent to perform efficiently the  
highest duties ordinarily assigned to clerks of the  
Second Division in the Department in which  
he is.

2. If on the first day of April of the year one  
thousand nine hundred and eight, or of any sub-

sequent year, the salary of any clerk electing under Clause five of the Order in Council of the twenty-first day of December one thousand nine hundred and seven, to be placed on the scale of salary prescribed by that Order shall amount to a sum intermediate between one hundred and twenty-two pounds ten shillings and one hundred and thirty pounds the annual increment of salary accruing next thereafter shall be calculated as the sum of—

(a) the portion of an increment at the rate of seven pounds ten shillings per annum proportionate to the period between such first day of April and the date next thereafter upon which (but for the operation of the Order aforesaid) an increment would have accrued, and

(b) the portion of an increment at the rate of ten pounds per annum proportionate to the period between the last mentioned date and the first day of April next following.

3. The following words shall be added to Clause nine of the Order of the twenty-first day of December one thousand nine hundred and seven:—

(c) Such clerkship does not lead in the ordinary course of promotion to a clerkship of which the maximum salary exceeds five hundred pounds per annum.

**ZETLAND MASONIC SICK AND WIDOWS  
AND ORPHANS FUND.**

(Reconstitution and Incorporation of the Masonic Orphans and Widows' Fund of Zetland: Amendment, Alteration, and Enlargement of Objects and Purposes: Transfer of Funds and Property: Dissolution of the Existing Constitution: Provisions with respect to Management, etc. of Fund: Payment of Sick Allowances and other Payments: Terms and Conditions of Membership: Payments to be Alimentary Provisions: Costs of Administration and other Purposes.)

**N**OTICE is hereby given that application is intended to be made to the Secretary for Scotland on or before the 17th day of April 1908, by Petition under the Private Legislation Procedure (Scotland) Act 1899 for a Provisional Order (hereinafter called "The Order") for all or some of the following among other purposes, that is to say:—

(1) To reconstitute the Masonic Orphans and Widows Fund of Zetland and to re-establish the Fund on an altered and enlarged basis and to dissolve the existing constitution of the Fund and all rules and regulations pertaining thereto and all the existing purposes thereof.

(2) To incorporate a new body for the administration and management of the Fund as re-constituted under the name of the Masonic Sick and Widows' and Orphans' Fund of Zetland or such other name as may be fixed by the Order being the present and future Members of the Masonic Lodge Morton No. 89 of Lerwick on the Roll of the Grand Lodge of Scotland who are or who may be admitted Members of said Fund under the provisions of the new constitution or otherwise as the Order may provide.

(3) To provide that the said Fund as re-constituted as aforesaid shall be applied for the relief of Members of the Masonic Lodge aforesaid who may for the time be Members of the Fund under the provisions of the new constitution by way of payments during sickness or otherwise and for making payments to Widows or Orphan Children on the death of Members or other payments to Members or their Widows or Children or for any one or more of these and for any other purpose as may be prescribed in the Order.

(4) To transfer to and vest in or provide for the transfer to or vesting of the Fund for the purposes thereof of all funds and property of the old Masonic Widows' and Orphans' Fund of Zetland established in or about 1809 and registered as a Friendly Society in the year 1834 (hereinafter called "The Old Fund.")

(5) To transfer all obligations debts and liabilities of The Old Fund to The Fund as re-constituted and incorporated by the Order and exonerate and discharge all its Directors

and other Officers and to dissolve and wind up the affairs of The Old Fund.

(6) To provide for the management of The Fund and the funds thereof by Directors and Officials and to make provisions as to the election and retirement of the Directors Presidents Treasurers Clerks and Auditors of the Fund.

(7) To prescribe the conditions of admission of Members of Morton Lodge to the Fund and the contributions payable in respect of Membership and the consequence of default in payment.

(8) To define the duties and powers of the Directors President Treasurer and Clerk and other Servants of The Fund and to make provisions for meetings of the Fund and of Directors and for the voting of Members and for the management regulation and control of the Fund.

(9) To provide for the payments from the Fund of allowances to Members thereof and to Widows or Children or Orphans or other Members or payments on death of Members all as may be prescribed or sanctioned by the Order.

(10) To define the conditions attached respectively to all or any payments to be made under the Order.

(11) To declare all payments out of the Fund to be alimentary provisions in favour of those entitled thereto and not assignable or transferable and to make other provisions in relation to payments and the conditions thereof.

(12) To authorise the expenses related to or incurred in the management or administration of the Fund or obtaining possession of the fund thereof and in carrying out the provisions of the Order to be paid out of the Fund and to provide for payment of the costs of the Order from the Fund.

(13) To repeal all or some of the provisions of the Friendly Societies Act 1896 and the Life Assurance Companies Acts 1870, 1871, and 1872, or any Acts amending the same for the purposes of the Order and to limit or dispense with the amount required to be deposited under the last mentioned Act.

(14) To provide for the indemnity of Directors Presidents Treasurers and Clerks or other Servants of The Fund.

(15) To provide for the appointment of Auditors and for a yearly audit of accounts and to provide for quinquennial investigations of The Fund.

(16) To enable the new incorporation to alter or rescind the provisions or any of them of the Order and to make alter or rescind other provisions bye-laws or regulations in lieu thereof or in addition thereto subject to the approval of the Registrar of Friendly Societies in Scotland or to authority being obtained from the Court of Session on application for that purpose or to such other approval or authority as may be prescribed in the Order.

(17) To vary or extinguish any rights and privileges which may impede or interfere with the objects and purposes of the Order and to confer other rights and privileges.

The Petition and printed copies thereof, and of the Draft Order will be lodged at the Office of the Secretary for Scotland on the 17th day of April next and on the same day a printed

copy of the Draft Order will be deposited in the Office of the Clerk of the Parliaments and in the Private Bill Office of the House of Commons.

The subsequent procedure will be by way of Provisional Order unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act 1899 in which case the procedure may be by way of Private Bill and this Notice and the deposits will subject to the standing orders of Parliament, apply to such Bill.

# WATER OF LEITH PURIFICATION AND SEWERAGE.

(New Works; Acquisition of Lands; Construction of Surface Water Drains; Additional Borrowing Powers; Rates; Agreements; Amendment of Acts, and Other Purposes.)

NOTICE is hereby given that application is intended to be made by petition under the provisions of the Private Legislation Procedure (Scotland) Act, 1899, to the Secretary for Scotland on or before the 17th day of April 1908 by the Water of Leith Purification and Sewerage Commissioners incorporated by the Water of Leith Purification and Sewerage Act 1889 (hereinafter called "the Commissioners") for a Provisional Order (hereinafter called "the Order") for the following or some of the following objects powers and purposes, that is to say:—

1. To authorise the Commissioners to make construct and maintain the works hereinafter mentioned or some of them or some part or parts thereof together with all necessary works and appurtenances outlets overflows walls embankments tunnels dams banks rails culverts drains sewers dykes ventilating shafts offlets manholes cleansing shafts scourpipes bywashes pits tanks cuts outfalls sluices weirs roads approaches fences connections valves flushing apparatus and other works and conveniences relative to the said works, or any of them, or for connecting the same with the main and branch sewers already constructed by or under the control of the Commissioners.

2. The Works proposed to be authorised by the Order are the following, that is to say:—

- (1) An aqueduct or sewer (Work No. 1) commencing at a point in Russell Road 36 yards or thereby, measured in a north-westerly direction from the north-west corner of Roseburn Maltings, by a connection with the Lochrin Sewer of the Corporation of Edinburgh, and Work No. 9 hereinafter described and terminating by a connection with the regulating tank (Work No. 2) hereinafter described

at a point 286 yards or thereby, measured in a north-easterly direction from the centre of the viaduct carrying the Caledonian Company's Leith Branch Railway over the Water of Leith at Coltbridge.

- (2) A regulating tank (Work No. 2), commencing at a point on the haugh belonging to the Governors of George Heriot's Trust 286 yards measured in a north-easterly direction from the centre of the said viaduct, and terminating at a point in said haugh 393 yards or thereby measured in a north-easterly direction from said centre of said viaduct.
- (3) An aqueduct or sewer (Work No. 3), commencing by a junction with the termination of Work No. 2, hereinbefore described and terminating by a connection with the main sewer of the Commissioners constructed under their Act of 1889 at a point 396 yards or thereby measured in an easterly direction from the centre of said viaduct.
- (4) An aqueduct or sewer (Work No. 4), commencing at a point in Work No. 1, above described, 286 yards or thereby, measured in a north-easterly direction from the said centre of said viaduct, and terminating by a connection with the regulating tank (Work No. 5), herein-after described, at a point 460 yards or thereby, measured in a north-easterly direction, from the centre of the said viaduct.
- (5) A regulating tank (Work No. 5) commencing at a point on "The Haugh" shown on the 25-inch Ordnance Survey plan of the parish of the City of Edinburgh, published at Southampton in the year 1896, 460 yards or thereby, measured in an easterly direction from the centre of the said viaduct and terminating at a point in said last-mentioned Haugh, 643 yards or thereby, measured in an easterly direction from the said viaduct.
- (6) An aqueduct or sewer (Work No. 6), commencing by a junction with the termination of Work No. 5 hereinbefore described, and terminating by a connection with the main sewer of the Commissioners constructed under their Act of 1889, 726 yards or thereby, measured in an easterly direction from the centre of said viaduct.
- (7) A diversion (Work No. 7) of so much of the existing 1864 sewer vested in the Commissioners by their Act of 1889 as is required for the construction of the said regulating tank (Work No. 2), and the said aqueducts or sewers (Works Nos. 1, 3, and 4).
- (8) A diversion (Work No. 8) of so much of the existing pipe sewer which passes behind the houses known as Coltbridge Gardens and crosses the river at or near the site of the said intended regulating tank (Work No. 2), commencing at a point on the north bank of the river 283 yards or thereby measured in a north-easterly direction from the centre of the said viaduct and terminating in a connection with the said Work No. 7 near to the commencement of the said regulating tank (Work No. 2).

- (9) An overflow or connecting chamber (Work No. 9) situated at the said point of commencement of the said Work No. 1, between the said Lochrin Sewer of the Corporation of Edinburgh and the said aqueduct or sewer (Work No. 1) hereinbefore described.
- (10) A road of access (Work No. 10), commencing by a junction with the highway known as Wester Coates Gardens, and terminating at the centre of the tank (Work No. 2) hereinbefore described.
- (11) A road of access (Work No. 11) commencing by a junction with the highway at or near the west abutment of Belford Bridge and terminating at or near the centre of the said regulating tank (Work No. 5) hereinbefore described.
- (12) An aqueduct, conduit, or line of pipes (Work No. 12) commencing in the Water of Leith near the south end of the caul at Coltbridge Mill at a point 163 yards or thereby, measured in a south-westerly direction from the centre of the said viaduct and terminating in the said regulating tank (Work No. 2) near to its said commencement.
- (13) An aqueduct, conduit, or line of pipes (Work No. 13), commencing by a junction with the said Work No. 12, near to its point of termination hereinbefore described, and terminating in the said regulating tank (Work No. 5) near its said commencement.
- (14) An aqueduct or sewer (Work No. 14) commencing by a junction with Work No. 4 hereinbefore described at a point 416 lineal yards or thereby measured in an easterly direction from centre of said viaduct and terminating by a connection with the main sewer of the Commissioners constructed under their Act of 1889 at a point 418 lineal yards or thereby measured in an easterly direction from centre of said viaduct.
- (15) A measuring well or tank (Work No. 15) situate at a point on the north side of the Water of Leith 225 yards or thereby measured in a north-easterly direction from the centre of Belford Bridge.
- (16) A sewer (Work No. 16) commencing at the measuring well or tank (Work No. 15), hereinbefore described, and terminating by a junction with the main sewer of the Commissioners constructed under their Act of 1889 at a point on the south side of the river 345 yards or thereby measured in an easterly direction from the centre of said Bridge.
- (17) A recorder or meter chamber (Work No. 17) situate at a point on the west side of the private roadway leading from Lower Broughton Road to Lindsay's Cooperage 32 yards or thereby measured in a north-westerly direction from the front wall of the tenement built on the south side of Lower Broughton Road where the said tenement faces the private roadway before mentioned.
- (18) A sewer (Work No. 18) commencing by a junction with the existing sewer belonging to Messrs. White, Burns, & Company near to the extreme north-west point of their drying store, and terminating by a connection with the Commissioners' main 1864 sewer at a point 100 yards or thereby measured in a westerly direction from the point at which said sewer crosses the centre of Newhaven Road.
- (19) A sewer (Work No. 19) commencing near the north-east corner of the steeping house at Bonnington Skinnery, and terminating by a junction with the sewer (Work No. 18), 20 yards or thereby measured in an easterly direction from its said point of commencement hereinbefore described.
- (20) A sewer outfall (Work No. 20) commencing at a point in the overflow chamber of the sewer constructed by the Commissioners under the Act of 1889 at the sea wall near the west end of Marine Esplanade, numbered said Esplanade 71 on the 25-inch plan, Ordnance Survey, of the Parish of South Leith, Burgh of Leith and County of Mid-Lothian, and terminating at or near to the rocks called "Eastern Craigs," being part of the Black Rocks on or near to the Sands of Leith, and on or adjoining the south shore of the Firth of Forth, at or near to or beyond low-water mark of ordinary spring tides, and 10 yards or thereabouts measured in a westerly direction from the seaward termination of the outfall sewer being Work No. 10 of the Act of 1889, which sewer outfall will be situate wholly in the Parish of South Leith, Burgh of Leith, and the seashore of the Firth of Forth at Leith or some one or more of them and County of Mid-Lothian.
- (21) A flood gate or balanced sluice (Work No. 21) to be placed below the present existing overflow sill of the overflow chamber at the point of commencement of Work No. 20 hereinbefore described, which flood gate or balanced sluice will be situate wholly in the Parish of South Leith, Burgh of Leith and County of Mid-Lothian.
- (22) A surface-water drain or watercourse (Work No. 22) commencing in the North British Railway cutting at a point 150 yards or thereby measured in a southerly direction from the footbridge crossing the Railway at Gorgie Station and terminating in the Water of Leith at or near the crossing of the River by the North British Edinburgh and Glasgow main line of Railway.
- (23) A surface-water drain or watercourse (Work No. 23), commencing at a point in Inverleith Row, Edinburgh, at or near the west end of Eildon Street, and terminating in the Water of Leith near the north-east end of Warriston Crescent.
- (24) A surface-water drain or watercourse (Work No. 24), commencing near the south end of Lockharton Gardens, Edin-

The said intended Works hereinbefore described and the lands to be acquired for the purposes thereof will be wholly situate in the City Parish of Edinburgh and the County of the City of Edinburgh.

- burgh, and terminating in the Water of Leith at or near the weir on the river at the head of the Gorgie Mills mill-lade together with a settling-tank at or near the point of termination; which said surface-water drain or watercourse will be situate in or pass through from or into the City Parish of Edinburgh and Parish of Colinton, or one of them, and the County of the City of Edinburgh and County of Mid-Lothian, or one of them.
- (25) A surface-water drain or watercourse (Work No. 25), commencing at a point in the boundary between Colinton and Currie parishes 100 yards or thereby measured in a northerly direction from the point of intersection of said boundary by the Edinburgh and Lanark Highway and terminating in the settling tanks (Work No. 27) hereinafter described in the field or enclosure numbered 391 on the 25-inch Ordnance Survey plan of the Parish of Colinton published at Southampton in 1894, 120 yards or thereby measured in a westerly direction from the westmost corner of Mossie Mill.
- (26) A surface-water drain or watercourse (Work No. 26), commencing at the junction of Gillespie Road with the Edinburgh and Lanark Road near the house known as Belezza, Colinton, and terminating by a junction with Work No. 25 hereinbefore described at a point in the private Road leading to Woodhall Barley Mill, 160 yards or thereby measured in a northerly direction from the north corner of said Mill.
- (27) Settling-tanks (Work No. 27), situated at or near the point of termination of Work No. 25 hereinbefore described.
- (28) An overflow pipe (Work No. 28), commencing at said settling-tanks (Work No. 27), and terminating in the Water of Leith at a point 70 yards or thereby measured in a westerly direction from the westmost point of Mossie Mill.
- (29) A surface-water drain or watercourse (Work No. 29) commencing in the road or street lying to the north and east of the property called Caledonia in Juniper Green, and terminating in the Edinburgh and Lanark Road by a connection with the surface-water drain or watercourse (Work No. 25) hereinbefore described.
- (30) A surface-water drain or watercourse (Work No. 30), commencing at the intersection of Gillespie Road and the Lanark Road at Colinton and terminating in the Water of Leith at the point where it is crossed by the Balerno Branch of the Caledonian Railway near to West Mill together with a settling-tank at or near the point of termination.
- (31) A surface-water drain or watercourse (Work No. 31), commencing at or near the north end of Spylaw Avenue, Colinton, and terminating by a junction with Work No. 30 hereinbefore described at or near the south end of Spylaw Avenue.
- (32) A surface water drain or water course (Work No. 32) commencing at or near the point of commencement of Work No. 33 hereinafter described and terminating by a junction with Work No. 30 hereinbefore described at or near the south end of Pentland Avenue Colinton.
- (33) A surface water drain or water course (Work No. 33) commencing in Pentland Avenue Colinton 140 yards or thereby measured in a westerly direction from the north-west point of the goods shed at Colinton Railway Station and terminating in the Water of Leith near to the centre of Colinton Viaduct together with a settling tank at or near the point of termination.
- (34) A surface water drain or water course (Work No. 34) commencing in Bonaly Road Colinton at the point where it is crossed by the boundary of the Commissioners' Landward District and terminating in the ditch or water course on the north side of Colinton Road 66 yards or thereby measured in a westerly direction from the point of junction between Bonaly Road and Woodhall Road Colinton together with a settling tank at or near the point of termination.
- (35) A surface water drain or water course (Work No. 35) commencing in Dreghorn Loan Colinton at the point where it is crossed by the boundary of the Commissioners' Landward District and terminating at the point of termination of Work No. 36 hereinafter described together with a settling tank at or near the point of termination.
- (36) A surface water drain or water course (Work No. 36) commencing in Redford Road Colinton at the point where it is crossed by the boundary of the Commissioners' Landward District and terminating in the ditch or water course on the north side of Colinton Road 130 yards or thereby measured in a south-westerly direction from the point of junction of Colinton Road and Redford Road.
- The said intended surface water drains or water courses or settling tanks Works Nos. 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, and 36 will be situate in or pass through from or into the Parishes of Currie and Colinton or one of them and County of Midlothian.
- (37) A surface water drain or water course (Work No. 37) commencing at a point in Kaimes Road Corstorphine 50 yards or thereby measured in a westerly direction from the westmost gable of the Convalescent House and terminating in the Corstorphine Stank at a point 270 yards or thereby in a south-easterly direction from the southmost point of Meadow House, Corstorphine; which said intended surface-water drain or water course will be wholly situate in the Parish of Corstorphine and County of Midlothian.
- (38) New manholes (Works *a*, *b*, and *c*) on the Commissioners' main sewer constructed under their Act of 1889 (*a*) 100 yards or thereby measured in a north-easterly direction from the centre of the bridge carrying the public road

from Edinburgh to Blinkbonny over the Caledonian Railway Company's Balerno Branch Railway near Kinleith Mill: (b) 60 yards or thereby measured in an easterly direction from the weir and intake on Woodhall Mill lade; (c) at or near the west end of Juniper Green Station platform, which said intended manhole (a) will be wholly situate in the Parish of Currie and County of Midlothian, and which said intended manholes (b) and (c) will be wholly situate in the Parish of Colinton and County of Midlothian.

3. To authorise the Commissioners to purchase take and acquire and enter upon and use compulsorily or by agreement and to hold lands houses buildings waters streams and other property which may be necessary or convenient for the purposes of the intended works and the Order or any of them or rights of user thereof and easements servitudes and other rights privileges and powers over in or under any such lands and property railways viaducts or bridges so far as may be necessary for the purposes of the Order.

4. To authorise the Commissioners to increase the height and to enlarge or alter all or any existing manholes in the bed of the Water of Leith and to enlarge any existing overflows or to close same and to construct and provide all necessary overflows into the River in connection with the works authorised by the Order and to discharge the contents into the River or any sewer.

5. To authorise the Commissioners notwithstanding anything contained in section 90 of the Lands Clauses Consolidation (Scotland) Act 1845 to purchase and acquire so much only of any lands houses property buildings or manufactories as they may require for the purposes of the Order without being compelled to purchase the remainder.

6. To authorise the Commissioners to deviate laterally from the lines delineated on the plans to be deposited as hereinafter mentioned to the extent defined on the said plans or as may be described in the Order and to deviate vertically from the levels of the said works or any of them shown upon the sections to be deposited as hereinafter mentioned or as may be prescribed in the Order.

7. To authorise the Commissioners to acquire compulsorily or by agreement either the whole or any part or parts of the following lands lying within the City of Edinburgh and City Parish of Edinburgh and County of the City of Edinburgh, that is to say:—

A. All and Whole that area of land at Wester Coates in the City Parish of Edinburgh and County of the City of Edinburgh extending to 3·045 acres imperial measure or thereby and bounded as follows namely: on the East by property belonging to the Trustees of Donaldson's Hospital; on the south south-east and again on the east by the sloping bank adjoining the feuing ground of Wester Coates belonging to the Governors of George Heriot's Trust; on the south-west by property belonging or reputed to belong to the Caledonian Railway Company; and on the north-west north and north-east by the Water of Leith, being part

of the field or enclosure numbered 210 on the 25 inch Ordnance Survey Plan First Edition 1896 of that Parish.

B. All and Whole that area of ground at or near Bellsmills in the City Parish of Edinburgh and County of the City of Edinburgh being part of the land named "The Haugh" upon the 25 inch Ordnance Survey Plan First Edition 1896 of that Parish which area of ground is bounded as follows namely: On the west by the Water of Leith at the Weir Damdyke or Caul in connection with the Mill Lead for Bellsmills; on the north by the south bank of said Mill Lead; on the east by an undefined straight line extending southwards from a point on said bank of said Mill Lead to a point in the centre of the Water of Leith immediately opposite the north-most end of the wall dividing the property of the Trustees for Donaldson's Hospital and the gardens effeiring to the houses in Douglas Crescent; and on the south by the Water of Leith.

and to authorise the Commissioners to construct on the said lands respectively or on some part or parts thereof and thereafter maintain use flush and manage all necessary and proper regulating Tanks appliances manholes intake pipes outlets and overflow pipes pumping and other engines mains pipes buildings machinery and other apparatus and works for the purpose of receiving regulating distributing conveying and disposing of the whole or any portion of the contents of the main and branch sewers of the Commissioners or any of them, or of any sewers connected directly or indirectly with the said main and branch sewers and discharging the said contents into the sewers of the Commissioners, and also to authorise the Commissioners in addition to the construction on the said lands of the said regulating tanks to lay out maintain and use the surface of the ground or any part of the same or any adjacent ground as ornamental gardens and to enclose same with all necessary and convenient walls and railings and to sell feu lease or let or give the use of the said ground for recreation or any other purposes which the Commissioners might think fit and to provide that no part of the said lands to be acquired shall be deemed to be superfluous lands under the Lands Clauses Act and to enable the Commissioners to deal with the said lands as their own absolute property.

8. To make applicable to the works proposed to be authorised or acquired by the Commissioners under the Order no matter when and by whom constructed the provisions of the Water of Leith Purification and Sewerage Act 1889 and of the Water of Leith Purification and Sewerage (Additional Powers) Act, 1893, in the same way and to the same effect and extent in all respects so far as the same are not modified and altered by the provisions of the Order as if the said works had been works authorised by the said Act of 1889 or by the said Act of 1893. And further to make applicable as far as may be necessary and with such variations as the Order may prescribe the provisions of the Edinburgh Extension Act 1896 and the Edinburgh Corporation Act 1900 so far as those Acts are applicable or



relate to the works and undertaking of the Commissioners.

9. To provide that the increase of capacity of Harperrig and Threipmuir Reservoirs authorised by the said Act of 1889 shall be full compensation for the diversion or abstraction of river water from the Water of Leith mill leads and harbour by the works authorised by the Order or by the existing works or works vested in the Commissioners by the said last above-mentioned Act; that the regulations made or to be made by the Commissioners prescribing the quantity of foul water to be discharged into their works may be varied by the Commissioners from time to time and shall apply to the foul water discharged by means of connections made after the passing of the said Act of 1889 into the sewers authorised or vested in the Commissioners by that Act or into sewers connected directly or indirectly therewith from the mills and other works on the Water of Leith; and that the obligations upon the Commissioners to construct and maintain measuring gauges pipes from regulating and gauging tanks and orifices and openings in sewers and other apparatus meters and recorders under the said Act of 1889 shall apply to the sewers authorised or vested in the Commissioners by that Act or sewers connected directly or indirectly therewith; and to authorise the Commissioners to measure the quantity of foul water discharged from mills or works on the Water of Leith or adjacent thereto by or through any sewer or drain situated within the district and area of the Commissioners' jurisdiction or any part thereof and connected with any of said mills or works by means of recording instruments on discharge drains or supply pipes and to disconnect all or any existing drains whether formed by the Commissioners or by any other person from the 1864 sewers described and referred to in the said Act of 1889 or from any sewers connected directly or indirectly therewith and to divert the contents of any such drain so to be disconnected from the 1864 sewer and discharge and convey the same by the works or some of them authorised by the Order into the main sewers constructed by or vested in the Commissioners under the said Act of 1889 or otherwise; and to authorise the Commissioners to erect place construct and maintain measuring gauges such as recorders or meters on or near any discharge or supply pipes connected with any mills or works on the Water of Leith or Mill Lade's pipe and that within any part of the premises of any such mills or works, or at any other place; to require the owners and occupiers of any such mills or works to give the Commissioners facilities and access for such operations and for taking measurements by such instruments, and to make all necessary tanks wells connections and disconnections for carrying out the powers referred to in this clause and to authorise the Commissioners to enter upon all such mills and works for such purposes and to prohibit and prevent the discharge into any sewers of foul river water from any mills or works unless and until all necessary gauges recorders or meters which may be required by the Commissioners to be placed for the purpose of measurement of such foul water entering the sewers are provided and placed so as to secure the accuracy of such measurements.

10. To authorise the Commissioners in addition to their existing statutory powers in that behalf to scour flush and cleanse the bed of the Water of Leith and the said Regulating Tanks which may be constructed under the Order and any sewers and pipes and any other works to be authorised and by means of the works to be authorised or by some of them to take use and apply the water of the said River of the Water of Leith and tributaries and of the mill leads thereon or connected therewith for those purposes and to discharge the contents of the tanks or any portion thereof into the sewers of the Commissioners or otherwise as the Commissioners think fit and to provide that the said existing powers of the Commissioners shall extend to and embrace the works to be constructed under the Order for the purpose of scouring flushing and cleansing the River bed and the Regulating tanks and other works.

11. To authorise the Commissioners to exercise for themselves and others within the districts under their jurisdiction all the powers of a Local Authority under the Public Health (Scotland) Act, 1897 and any Acts amending that Act so far as such powers apply to sewerage or drainage systems and the taking and using of lands for the purpose of sewers and drains, as if the Commissioners were a Local Authority under the said Act and to constitute and create the Commissioners a Local Authority accordingly within their jurisdiction and to apply and extend such powers to the construction and maintenance of sewers pipes and surface water drains and the taking and user of lands for the purpose of the same.

12. To authorise the Commissioners to construct and maintain duplicate enlarge alter and repair surface water drains throughout the Landward District described and referred to in the said Act of 1889 and also in the Urban District and all necessary settling tanks and to discharge surface water into the Water of Leith and tributaries thereof or into other Rivers Streams or Burns and to agree with and to permit any owner of lands or any feuar or person within or beyond the said landward district to connect surface water drains from any lands roads houses mills works buildings or other artificial structures with any surface water drains belonging to or which may belong to the Commissioners on such terms and conditions as the Commissioners may prescribe either by way of single payment or annual sum or on such other terms and conditions as the Commissioners and such owner feuar or other person may agree and to require the junction of such surface water drains from lands roads houses mills works buildings or other artificial structures with the surface water drains of the Commissioners, and to prohibit all and every person or persons from discharging any surface water into the sewers of the Commissioners or into any sewers directly or indirectly connected therewith and from discharging the same into the surface water drains of the Commissioners except with the consent of the Commissioners and determine in what manner any surface water must be dealt with and to abstract surface water from any of the main or branch sewers of the Commissioners or from any sewers directly or indirectly connected therewith and to define the meaning of "surface water."

13. To authorise the Commissioners to acquire and take over on any terms and conditions they may deem expedient any surface water drains and settling tanks constructed by any owners or feuars or other persons within the said landward district or beyond the same so far as the said surface water drains may in the opinion of the Commissioners be suitable for their purposes and to enter into and carry out agreements with any person for such purpose, and to maintain duplicate enlarge alter and repair such surface water drains and settling tanks so to be acquired and taken over, and to confirm and carry out and give effect to any agreements already made or which may be made before the passing of the Order by the Commissioners and any owners feuars or other persons with regard to such surface water drains.

14. To authorise the Commissioners to take over and the Corporation of the City of Edinburgh to transfer to the Commissioners all or any of the powers of the Corporation of Edinburgh conferred under the Edinburgh Municipal and Police Acts 1879 to 1906 or under any of the said Acts or under the Edinburgh Police Amendment Act 1854 so far as the same relate to the Water of Leith or to any property in the said Water of Leith belonging to the Corporation of Edinburgh or with respect to any powers of supervision or cleansing or any other similar powers of administration possessed by the Corporation of Edinburgh under those Acts or otherwise and to authorise the Commissioners and the Corporation of Edinburgh to enter into agreements with respect to such matters and to confirm and carry out and give effect to any such agreements already made or which may be made before the passing of the Order.

15. To authorise the Commissioners at any time and from time to time to purchase and acquire by agreement any mills mill leads cauls dams and water rights on the river or any part thereof or on or arising out of the mill lades pipe constructed under the Edinburgh Improvement Act 1887 and to apply the funds of the Commissioners for carrying out any such purchase and upon such acquisition to authorise the Commissioners to deal with the same in such way and manner as in the opinion of the Commissioners may be most expedient.

16. To repeal sections 49 and 50 of the said Act of 1889.

17. To amend vary and extend the provisions of the said Act of 1889 in the following respects or some of them, that is to say, extend and enlarge the powers of the Commissioners with respect to control over junctions of sewers and sewers and drains connecting or which may connect directly or indirectly with the main or branch sewers of the Commissioners; to provide that no person shall construct any sewer so that it may discharge into the River of the Water of Leith, or tributaries or Mill Leads or shall convey discharge or allow to pass any sewage or refuse into the River or tributaries or Mill Leads or into any surface water drains; to provide that any person who proposes to connect any sewer directly or indirectly with the Commissioners' system shall only do so on obtaining authority from the Commissioners and shall submit for the approval of the Commissioners specifications plans and sections of any sewer so

proposed to be connected, such specifications plans and sections to give all necessary particulars for the consideration of the Commissioners and to submit information regarding the proposed method and materials of construction of the sewer proposed to be connected, and to provide for the manner in which the Commissioners shall intimate approval or disapproval and for the inspection of sewers during construction and the alteration thereof on requisition from the Commissioners and to grant power to the Commissioners to require alterations thereon to have junctions of sewers made at their sight and to their satisfaction by the person proposing to connect or to execute the work of junction themselves at the expense of such person; to provide that the Commissioners may disconnect or close any junction made with the main or branch sewers of the Commissioners or any sewer connected directly or indirectly therewith without the authority of the Commissioners; to provide that the Commissioners may require the owner of any land or building to construct adequate sewers for carrying off into the main or branch sewers of the Commissioners or any sewer connected directly or indirectly therewith any sewage arising within or beyond their districts which might pass into the River; and to provide for notices to be served by the Commissioners with regard thereto and for the submission of specifications plans and sections and for the execution of the necessary works by the Commissioners themselves should they deem this necessary; to provide that the Commissioners may require the owner of any private sewer connected directly or indirectly with the Commissioners main or branch sewers to allow any other person to connect the sewer thereto on such conditions as may be determined; to make provisions for connections to sewers from beyond the Commissioners districts and connected with the Commissioners main and branch sewers; to extend the provisions of the said Act of 1889 regarding the construction of houses buildings and other erections over the main and branch sewers of the Commissioners; to prohibit the erection or placing of any obstruction or any work or material of any kind so as to interfere with the flow of the water in the River or diminish the same or abstract or divert the water therefrom; to prohibit any person from sending or permitting to flow or pass into any of the main or branch sewers of the Commissioners or into any sewer connected directly or indirectly therewith any liquid or solid substance or matter which would be injurious to the construction use or efficiency of said main or branch sewers; to provide power to the Commissioners in the application of their revenues for current expenses to apply the sinking funds in the hands of the Commissioners to such purposes; to provide further and extended powers to the Commissioners in relation to sewers and drains and junctions and connections with the main and branch sewers of the Commissioners and sewers and drains connected directly or indirectly therewith and to make provisions regarding the construction of surface water drains and connections and junctions therewith similar to the provisions which may be made relative to sewers and connections and junctions therewith; to apply

the provisions of the said Acts of 1889 and 1893 and of the Order with regard to the main and branch sewers of the Commissioners and other works to sewers connected directly or indirectly therewith; to provide for the recovery by the Commissioners of any costs or expenses which they may incur in carrying out any work authorised or to be authorised to be done by them on behalf of any person; and to provide for penalties to be exacted from persons contravening any of the provisions of the said Acts of 1889 and 1893 and of the Order or any regulation or bye-law made in pursuance thereof and for recovery of expenses relating thereto, and to make provision for the election of Commissioners by any of the local authorities and to alter the date or dates of election by any such authorities.

18. To authorise the Commissioners and any local authority Corporation body or person to enter into and carry out agreements with respect to the objects powers and purposes of the Order and confirm any agreements which have been and which may be made or entered into before the passing of the Order.

19. To authorise the Commissioners in addition to any powers they now possess to borrow from time to time and to reborrow any sum or sums of money which may be required for the execution of the said works hereinbefore described and proposed to be authorised by the Order and any other works which may be constructed under the powers of the Order and for the purchase and acquisition of lands and other property compulsorily or by agreement under the powers of the Order and that by way of mortgage cash credit note receipt or otherwise as the Order may provide and on the same security as is authorised by the said Act of 1889 and the said Act of 1893 and to attach to sums to be borrowed under the Order such equal rights and preferences with sums already borrowed or with such postponement as shall be provided in the Order and to provide for the mode of borrowing transfer repayment and sinking fund and all the provisions of the said Acts of 1889 and 1893 with respect to the borrowing of money and the security for the same and estimating the sum required to be raised and the apportionment and requisition of the sums payable by the Corporations of Edinburgh and Leith and the landward Local Authorities respectively and other persons and also the repayment for money borrowed and the sinking fund and application of revenue shall and may be extended and applied with such variations and amendments as may be provided in the Order to any sums to be borrowed and to all mortgages or other securities granted or to be granted under the Order.

20. To authorise the Commissioners to make allowances from the revenues of the Commissioners to aged and incapacitated employees of the Commissioners and to their dependants in such way and manner as may be prescribed in the Order.

21. To provide for the appointment of a single arbiter for the purpose of settling any questions of disputed compensation between the Commissioners and any person with respect to the purchase and acquisition of lands and other property and to give power to such Arbiter to conduct and carry out such arbitration in such way and manner as he may pre-

scribe and to dispense with proceedings or formal proof and to provide for the remuneration of the Arbiter.

22. To vary and extinguish all existing rights and privileges which might in any way interfere with the objects powers and purposes of the Order or any of them and to confer other powers rights and privileges which may be necessary and expedient for carrying the same into effect.

23. To levy and requisition for the purposes of the Order existing or altered or increased rates dues assessments and charges or otherwise.

24. To incorporate with the Order with or without alteration or modification the Lands Clauses Acts the Railway Clauses Consolidation (Scotland) Act 1845 the Water of Leith Purification and Sewerage Act 1889 the Water of Leith Purification and Sewerage (Additional Powers) Act 1893 the Public Health (Scotland) Act 1897 the Edinburgh Extension Act 1896 and the Edinburgh Corporation Act 1900 and any Acts amending those Acts or any of them.

25. To alter amend enlarge extend or repeal so far as may be necessary for the purposes of the Order all or some of the provisions of the Water of Leith Purification and Sewerage Acts 1889 and 1893 the Edinburgh Municipal Police Acts 1879 to 1906 the Burgh Police (Scotland) Acts 1892 to 1903 the Public Health (Scotland) Act 1897 the North British Edinburgh Perth and Dundee and West of Fife Railways Amalgamation Act 1862 and all other Acts or for or relating to or affecting the North British Railway Company and the undertakings belonging to amalgamated with or held on lease or authorised or vested in that Company the Caledonian Railway Act 1845 and any other Act or Acts for relating to or affecting the Caledonian Railway Company or the undertakings belonging to or amalgamated with or held on lease or authorised or vested in that Company the Edinburgh Street Tramways Act 1871 and all other Acts relating to or affecting the Edinburgh Street Tramways now owned by the Corporation of Edinburgh the Edinburgh Northern Tramways Act 1884 and any other Act of and relating to the Edinburgh Northern Tramways now owned by the Corporation of Edinburgh the Edinburgh and District Waterworks Act 1869 and all other Acts relating to the Edinburgh and district Water Trustees the Edinburgh and Leith Corporations Gas Act 1888 and all other Acts of or relating to the Edinburgh and Leith Corporations Gas Commissioners The Rivers Pollution Prevention Act 1876 the Leith Harbour and Docks Act 1875 and all other Acts of or relating to the Docks and Harbour of Leith the Leith Municipal Police Act 1848 and all the other Acts of and relating to the Burgh of Leith the Roads and Bridges (Scotland) Act 1878 the Edinburgh Roads Act 1882 and any Acts amending those Acts or any of them and to incorporate and re-enact and make applicable to the Order all or some of the Provisions of some one or more of the said Acts.

26. Plans describing the lines and situation of the works hereinbefore described and of the lands houses and other property which may be taken for the purposes thereof and of the works and conveniences connected therewith and also of the lands to be acquired for the other

purposes of the Order together with a Book of Reference to the said Plans containing the names of the owners or reputed owners the lessees or reputed lessees and occupiers of such lands houses or other property and copies of this Notice as published in the "Edinburgh Gazette" will be deposited for public inspection in the respective offices at Edinburgh of the Principal Sheriff Clerk of the County of Mid-Lothian and the Principal Sheriff Clerk of the County of the City of Edinburgh respectively and a copy of so much of the said plans sections and Book of Reference as relates to the several parishes hereinbefore mentioned and to the City and Royal Burgh of Edinburgh and the Burgh of Leith respectively with a copy of this Notice will be deposited for public inspection with the Clerks of the Parish Councils of each of the said Parishes and as regards the City and Royal Burgh of Edinburgh with the Town Clerk thereof at his Office at Edinburgh and as regards the Burgh of Leith with the Town Clerk of that Burgh at his office at Leith and all which deposits above mentioned will be made on or before the 31st day of March 1908.

To authorise and provide for the establishment and maintenance of a Superannuation Fund for the officials and servants of the Commissioners, and to provide for and require the payment of contributions to the said Fund by such officials and servants and to authorise deduction from the salary or wages of any such persons any contributions which they may be required to make; and to provide that such contributions or some part thereof shall be compulsory in all or in some cases as the Order may define.

4. To provide for the payment of superannuation and other allowances to officials and servants in the employment of the Commissioners.

5. To authorise and require the Commissioners to make contributions to the superannuation fund out of the gas rates rents and charges or out of any other funds rates and revenues of the Commissioners.

6. To alter amend vary or repeal so far as may be necessary or expedient for the purposes of the Order all or some of the powers and provisions of the Edinburgh and Leith Corporations Gas Acts, 1888 to 1902, and the Edinburgh Corporation Act, 1897. And further the Order will or may incorporate all or some of the powers and provisions with such amendments as the Order may prescribe of the said Edinburgh and Leith Corporations Gas Acts, 1888 to 1902, the Edinburgh Extension Act, 1896, the Edinburgh Corporation Acts, 1897 and 1900, and Edinburgh Corporation Order, 1901 and all or any of the Acts incorporated with those Acts respectively and any Act extending the boundaries of Edinburgh or Leith.

The subsequent procedure will be by way of Provisional Order unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act, 1899, in which case the procedure may be by way of Private Bill; and this Notice and the deposits will subject to the Standing Orders of Parliament apply to such Bill.
