PROPOSED ACT OF SEDERUNT ANENT PROCEDURE IN APPEALS UNDER SECTIONS 5 AND 30 OF THE SHERIFF COURTS (SCOTLAND) Acr 1907.

Edinburgh,

THE Lords of Council and Session, by virtue of the powers conformal of the powers conferred on them by section 40 of the Sheriff Courts (Scotland) Act 1907, do Enact and Declare as follows:-

I. Where an Appeal has been taken under sections 5 and 30 of the Sheriff Courts (Scotland) Act 1907, in terms of paragraph 95 of the First Schedule thereof, the Sheriff-Clerk shall transmit the Appeal addressed to the Keeper of the Rolls of the First Division at the First Division Office, New Register House, Edinburgh.

II. The said Keeper of the Rolls shall, on eighth day after receipt of the process, if such eighth day is in session, or on the first sederunt day in the ensuing session if such eighth day is in vacation, enrol the case in the Single Bills of such Division as the Lord President shall direct. The Division shall then consider and decide any preliminary questions as to competency or procedure.

III. Thereafter the said Keeper of the Rolls shall, under the direction of the Lord President, mark the case to a Division and Lord Ordinary, or transmit it back to the Sheriff-Clerk, in terms of said Act.

And the Lords Appoint this Act of Sederunt to be entered in the Books of Sederunt, and to be printed and published in common form.
