TOTICE is hereby given that His Majesty
The King will hold a Levée at St.
James' Palace on Monday the 6th of July, at
12 o'clock noon, and that for this Levée Cards
of Admission will be required, as the numbers
are limited.

The following are the rules to be observed :-

ATTENDANCES AND PRESENTATIONS.

All Officers, whether on the active or retired lists, of the Royal Navy and the Royal Marines, of whatever rank, will communicate with and obtain their cards from the Private Secretary to the First Lord of the Admiralty. All Civil Officers of the Admiralty will follow the same rule.

Deputy Lieutenants of Counties and all Officers, whether on the active or retired lists, of the Army, Special Reserve, Militia, Territorial Force, Yeomanry, or Volunteers, of whatever rank, except those on the Indian and Colonial Establishments, will communicate with and obtain their cards from the Private Secretary to the Inspector-General at the Horse Guards, Whitehall; but Officers of the Household Cavalry or the Brigade of Guards should communicate with the Lord Chamberlain at St. James' Palace.

All Officers of the Indian Civil Service and of the Indian Army, of whatever rank, whether on the active or retired lists, will communicate with and obtain their cards from the Private Secretary to the Secretary of State at the India Office, Whitehall.

All Officers of the Colonial Service and Colonial Forces, of whatever rank, whether on the active or retired lists, will communicate with and obtain their cards from the Colonial Office, Whitehall, with the exception of Officers of the local Forces of the Colonies possessing responsible Government, who will apply to the Private Secretary to the Inspector-General at the Horse Guards, Whitehall, for their cards for attendance or for presentation by the Inspector-General. The application must in all cases be supported by a credential from the Governor or Officer commanding the local Forces of the Colony.

Recorders, Metropolitan Police Magistrates, and other Stipendiary Magistrates, and all Gentlemen connected with the Home Office, are requested to make their applications through the Private Secretary to the Home Secretary.

Judges, Law Officers, King's Counsel, and all Legal Officials holding appointments under the Crown, are requested to make their applications through the Private Secretary to the Lord Chancellor.

Similarly, all Gentlemen connected with the Foreign Office, Civil Staff of the War Office, or any Government Department, will communicate with and obtain their cards for attendance or presentation at Levées from the Department under which they serve.

Peers, Bishops, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all Gentlemen other than the above mentioned, will be good enough to communicate with the Lord Chamberlain at St. James' Palace, when they will each be furnished with a card of admission for use at the Levée.

The names, both for attendance and presentation at this Levée, must be received at the various Offices above indicated not later than Wednesday the 1st July.

Acknowledgment of applications will not be made, but cards of admission will be sent as soon as possible to the addresses given.

The KING's Most Excellent Majesty in Council.

Whereas in an Act passed in the Session of Parliament held in the fifth year of His Majesty's reign, intituled "An Act to provide for the Settle-"ment of certain Questions between the Free "Church and the United Free Church in Scot-"land, and to make certain amendments of the "law with respect to the Church of Scotland," it is enacted that a Commission be established to consist of five Commissioners to be appointed by His Majesty:

And whereas it is further enacted in the Act aforesaid, section three, sub-section seven, that "The powers of the Commission shall be in force "until the first day of March nineteen hundred "and six, but His Majesty may, by Order in "Council, continue their powers for such further "period as His Majesty thinks fit":

And whereas the said Commission was duly established by the appointment of five Commissioners in pursuance of a Warrant under His Majesty's Royal Sign Manual, bearing date the eleventh day of August nineteen hundred and five:

And whereas His Majesty, by Orders in Council dated respectively the sixteenth day of February nineteen hundred and six, the twenty-eighth day of July nineteen hundred and six, the 21st December nineteen hundred and six, the 1st day of June nineteen hundred and seven, and the 21st day of December nineteen hundred and seven, continued the powers of the said Commission.

And whereas it is expedient that the powers of the said Commission should be continued for a further period:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to Order, and it is hereby ordered, that the powers of the Commission established under the Act aforesaid shall be in force until the first day of July nineteen hundred and nine.

NATIONAL GALLERIES OF SCOTLAND (Application of Transferred Property) Order, 1908.

In virtue of the powers conferred on me by the National Galleries of Scotland Act, 1906 (6 Edw. 7, ch. 50), I, the Right Honourable John Sinclair, His Majesty's Secretary for Scotland, with the consent of the Treasury, so far as the same is required, do hereby prescribe with regard to certain property hereinafter mentioned (being portion of the property which passed in pursuance of the said Act to the Board of Trustees established thereby), that the said property shall be applied by the said Board for the purposes and subject to the conditions following, that is to say:—

- 1. The Board of Trustees shall pay out of the Pension Fund accumulated by the late Board of Manufactures such sums as may be required to meet any charges in respect of pension or commuted allowances for former Officers of the Board last mentioned accruing due up to the 31st March 1908 inclusive, and, in consideration of all liabilities to which the said Pension Fund is subject being undertaken by the Treasury, the the Board of Trustees shall transfer the balance of the Fund remaining at the date of this Order to such persons and in such manner as the Treasury shall appoint.
- 2. The sum of £1360 presently invested in mortgage, dated 12th November 1903, with the Edinburgh and District Water Trust, shall be transferred to the Town Council of Edinburgh, to be held in trust by the said Town Council, and the income therefrom shall be applied in providing bursaries in connection with the School of Art conducted by the said Town Council, subject to such conditions as may from time to time be approved by the Secretary for Scotland.
- 3. The balance, amounting to £16 or thereabouts, of a sum of twenty guineas given as a prize fund by Mr. George Waterston, shall be transferred to the Town Council of Edinburgh upon the said Town Council undertaking to apply it in accordance with the purpose for which it was given.
- 4. Out of the balance at the credit of the account of the School of Art formerly conducted by the Board of Manufactures, the Board of Trustees shall pay to the Town Council of Edinburgh a sum of £90 in respect of scholarships awarded in the year 1907 to two students for the purpose of carrying on the National Art Survey which was formerly conducted by the said Board of Manufactures.

- 5. The Board of Trustees shall transfer to the Town Council of Edinburgh for use in the School of Art conducted by the said Town Council such casts, books, drawings, furniture, or other property as the Board of Trustees may select, subject to the approval of the Secretary for Scotland.
- 6. The income of the fund known as the Scottish National Portrait Gallery Endowment Fund shall until otherwise prescribed be applied for the purchase of portraits for the Scottish National Portrait Gallery collection.
- 7. The fund known as the Scottish National Portrait Gallery Decoration Fund shall until otherwise prescribed be applied for the purpose of decorating the Scottish National Portrait Gallery building according to such scheme as shall from time to time be determined by the Board of Trustees with the approval of the Secretary for Scotland.
- 8. Until otherwise prescribed the Board of Trustees shall from time to time, on the application of the Commissioners of Works, pay to the said Commissioners out of the income of the moneys applicable to the maintenance and repair of the building known as Dunblane Cathedral such sums as the Board are satisfied are required to meet expenditure incurred for the maintenance and repair of the said building.

This Order may be cited as the National Galleries of Scotland (Application of Transferred Property) Order, 1908.

THE MOTOR CARS REGULATION (BURGH OF DYSART) ORDER, 1908. Dated 17th June

In pursuance of the powers vested in me by Section 9, as read with Section 18 of the Motor Car Act, 1903, I, the Right Honourable John Sinclair, His Majesty's Secretary for Scotland. on the application of the Town Council of the Burgh of Dysart, being the local authority of the said Burgh, do hereby make the following regula-

- 1. This Order may be cited as "The Motor Cars Regulation (Burgh of Dysart) Order, 1908," and the regulations hereby prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of Section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.
- 2. A person shall not drive a motor car at a speed exceeding ten miles per hour within the limits or places specified in the schedule to these Regulations.
