EDWARD THE SEVENTH, by the Grace of God, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India and Sovereign of the Most Exalted Order of the Star of India, to all to whom these presents shall come, Greeting!

Whereas by virtue of the power in Us vested under certain Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland bearing date respectively the twenty-third day of February, one thousand eight hundred and sixty-one, and the twenty-eighth day of March, one thousand eight hundred and sixty-six, and in the Statutes of the Order made for the government of the Most Exalted Order

of the Star of India, We deem it expedient, without permanently increasing the number of the Ordinary Members of the Order, to provide for the admission into the Second and Third Classes of the Order of such persons as have rendered to Us special and important services.

We therefore in pursuance and in exercise of the power so vested in Us do make ordain and establish by these presents sealed with the Seal of the said Order the following Statutes and

It is ordained that the Additional Members so to be appointed shall have rank and precedence among the Ordinary Members of their respective Classes according to the date of their respective appointments, and that the Statutes of Our said Order shall in all matters and things apply in the same manner to the said Additional Members as to the Ordinary Members of Our said Most Exalted Order any Statute Decree or Usage to the contrary notwithstanding.

Statute sealed with the Seal of Our said Order shall be taken and received as part and parcel of

the Statutes thereof.
