WHEREAS the office of Director General of Army Finance has been replaced by that of Assistant Financial Secretary, it is expedient that the Order in Council dated the tenth of August one thousand nine hundred and four,

defining the functions of the Officer charged with the accounting of Army Votes, Accounts and Funds should be amended.

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

The Assistant Financial Secretary to the War Office shall act as Deputy and Assistant to the Finance Member of Council and shall advise the Administrative Officers at the War Office and in Commands on all questions of Army expenditure. As the Accounting Officer of Army Votes, Funds and Accounts, he shall be charged with the allowance and payment of all monies for Army Services; with accounting for and auditing all cash expenditure and preparing the annual accounts of such expenditure for Parliament; and with auditing all Manufacturing, Expense, Supply and Store accounts.

WHEREAS by section four of the Finance Act. 1908, it is enacted that His Majesty may by Order in Council transfer from the Commissioners of Inland Revenue to the Commissioners of Customs the management of any Excise duties which are under the management of the Commissioners of Inland Revenue at the time the Order is made, and any powers and duties of the Commissioners of Inland Revenue which it appears necessary or expedient to transfer in consequence of or in connexion with the transfer of the management of Excise duties, and that all powers and duties so transferred shall become powers and duties of the Com-missioners of Customs, and that if an Order is made under the section the Commissioners of Customs shall, as from the date fixed by the Order, be styled the Commissioners of Customs and Excise:

And whereas it is further enacted by the said section that such provisions may be made by the Order in Council as it appears necessary or expedient to make in order to give full effect to any transfer, or in consequence of any change of name effected under the section, and that for the purpose of making the provisions as to the action and procedure of the Commissioners of Customs and Excise under the Acts relating to Customs and Excise respectively uniform, the Order may provide that as to the action or procedure of the Commissioners any provisions of the Acts relating to Excise shall have effect to the exclusion of similar provisions of the Acts relating to Customs, or that any provisions of the Acts relating to Customs shall have effect to the exclusion of similar provisions of the Acts relating to Excise:

And whereas it is further enacted that the Stamp duties on medicines and playing cards shall, for the purposes of the section and for all other purposes, be deemed to be Excise duties:

Now, therefore, His Majesty, in exercise of the powers vested in Him by the said recited enactment, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered as follows :-

General Transfer of Management of Excise Duties to Commissioners of Customs.

- 1. This Order may be cited as the Excise Transfer Order, 1909, and shall come into operation on the first day of April one thousand nine hundred and nine.
- 2. As from the date on which this Order comes into operation, the management of all Excise duties (including the duties on medicines and playing cards) which are at that date under the management of the Commissioners of Inland Revenue shall be transferred to the Commissioners of Customs, and all the powers and duties of the Commissioners of Inland Revenue in connexion with the said duties shall also be transferred to the Commissioners of Customs.
- 3. The date on which this Order comes into operation shall be the date as from which the Commissioners of Customs are to be styled the Commissioners of Customs and Excise.

Supplemental Provisions for Giving Effect to General Transfer.

- 4. In addition to the management of the duties of Excise, the care and management of all matters dealt with by Collectors of Inland Revenue shall be transferred to the Comsioners of Customs and Excise as from the date on which this Order comes into operation.
- 5. All persons who are immediately before the date on which this Order comes into operation Collectors of Inland Revenue, or officers of Inland Revenue employed in relation to duties | requires a different interpretation, be construed,

of Excise or other persons so employed in the Department of Inland Revenue shall become Collectors or officers of Customs and Excise, or persons employed in the Department of Customs and Excise, and shall hold their offices as such Collectors, officers, or persons by the same tenure and on the same terms and conditions as those by and on which they held their old offices, and all such Collectors, officers, and persons shall be under the control of the Commissioners of Customs and Excise, and all appointments granted by the Commissioners of Inland Revenue to such Collectors, officers, and persons shall continue in force until the same shall be recalled, and as from the date on which this Order comes into operation shall have the same effect as if they had been granted by the Commissioners of Customs and Excise.

6. For the purpose of the Inland Revenue Regulation Act, 1890, any Inspector of Stamps and Taxes or Surveyor of Taxes, shall, so far as respects any revenue or matter under the care and management of the Commissioners of Inland Revenue which is not transferred to the Commissioners of Customs and Excise under this Order, be deemed to be an officer of Inland Revenue.

- 7. A Collector or officer of Customs and Excise shall, notwithstanding the transfer effected by this Order, continue to perform, subject to the concurrence, control and directions of the Commissioners of Customs and Excise, any duties entrusted to him by the Commissioners of Inland Revenue under any appointment or authority already given or hereafter to be given by those Commissioners appointing any such Collector or officer to be a distributor of stamps or a Collector of taxes or under which statutory declarations in support of claims for the allowance of spoiled stamps may be made before any such Collector or officer.
- 8. The Solicitor for the Customs shall be styled the Solicitor for the Customs and Excise, the Secretary for the Customs shall be styled the Secretary for the Customs and Excise, the Accountant and Comptroller General of the Customs shall be styled the Accountant and Comptroller General of the Customs and Excise, Collectors of Customs and Collectors of Inland Revenue shall be styled Collectors of Customs and Excise, and officers of Customs and officers of Inland Revenue employed in relation to duties of Excise shall be styled officers of Customs and Excise.
- 9. Every Collector of Customs and Excise employed as a Collector of duties of Customs shall have all the powers and perform all the duties conferred or imposed by any Act upon a collector of Customs, and every Collector of Customs and Excise employed as a Collector of duties of Excise shall have all the powers and perform all the duties conferred or imposed by any Act upon a Collector of Inland Revenue, and all powers and duties of officers of Customs under any Act relating to the Customs and of officers of Inland Revenue under any Act relating to the Excise shall be exercised and performed by officers of Customs and Excise.
- 10. References to any persons named in the first column of the annexed Table in any enactment, order, rule, regulation, deed (including bonds and securities), or other instrument, or document whatsoever shall, unless the context

so far as relates to Customs and any matters transferred under this Order to the Commissioners of Customs and Excise, or to Collectors, officers or persons who become under this Order Collectors or officers of Customs and Excise, or persons employed in the Department of Customs and Excise as references to the persons mentioned in the second column of that Table.

TARLE.

11. All Regulations and Orders made by the Commissioners of Inland Revenue in relation to dutics of Excise, and all Regulations and Orders made by the Commissioners of Customs and the Commissioners of Inland Revenue jointly, and in force immediately before the date on which this Order comes into operation, shall continue in force until revoked by the Commissioners of Customs and Excise, and as from that date shall have the same effect as if they had been made by the Commissioners of Customs and Excise, and where under any enactment in force on the date on which this Order comes into operation a power to make regulations is given to the Commissioners of Customs and the Commissioners of Inland Revenue jointly the power shall be exercised by the Commissioners of Customs and Excise alone.

12. The account to be kept at the Bank of England under section twenty-one of the Customs Consolidation Act, 1876, shall be entitled "The General Account of the Commissioners of Customs and Excise," and all money and securities for money collected or received in Great Britain for or on account of the revenues of Excise shall be placed to that account.

13. All money and securities for money from time to time collected or received by the Collectors of Customs and Excise in Great Britain for or on account of duties imposed as stamp duties and taxes shall, under the direction of the Commissioners of Customs and Excise, be paid into the Bank of England to the General Account of the Commissioners of Inland Revenue, and all money and securities for money from time to time collected or received in Ireland for or on account of those duties shall be paid into the Bank of Ireland to the account of of Inland Revenue and to officers of Inland

His Majesty's Exchequer or as the Treasury direct.

14. Before the first day of July one thousand nine hundred and nine a Schedule shall be prepared of the particulars of all sums of public stock which have been transferred into the joint names of any person or persons or company and the Chairman for the time being of the Commissioners of Inland Revenue wholly by way of security in relation to any duties of Excise and remaining so transferred as such security, and a copy of such Schedule signed by the Chairman of the Commissioners of Inland Revenue and by the Chairman of the Commissioners of Customs and Excise shall be delivered to the Governor and Company of the Bank of England, and after such delivery the duties and powers vested in and exercisable by the Chairman of the Commissioners of Inland Revenue in connexion with the stock specified in the Schedule shall be vested in and exercisable by the Chairman for the time being of the Commissioners of Customs and Excise in the same manner as if the transfer of the stock had been made into the joint names of such person or persons or company and of the Chairman for the time being of the Commissioners of Customs and Excise.

15. Subsection (1) of section 24 of the Inland Revenue Regulation Act, 1890, which prescribes the mode in which regulations, minutes, and notices made and issued by the Commissioners of Inland Revenue may be authenticated and proved shall apply to regulations, minutes, and notices made and issued by the Commissioners

of Customs and Excise.

16. Sections 36, 37 and 38 of the Customs Consolidation Act, 1876, which relate to inquiries by the Commissioners of Customs as to any matter under their management or as to the conduct of any person employed therein shall apply in the case of inquiries by the Commissioners of Customs and Excise as to any matter under their management or as to the conduct

of any person employed therein.

17. Section 12 of the Inland Revenue Regulation Act, 1890, which relates to any person not being an officer of Inland Revenue who takes or assumes the name, designation, or character of an officer of Inland Revenue for any such purpose as is specified in that section, shall apply in the case of any person not being an officer of the Commissioners of Customs and Excise who so takes or assumes the name, designation, or character of an officer of those Commissioners.

18. Where under the Sale of Food and Drugs Acts, 1875 to 1907, the justices before whom any complaint may be made or the Court before whom any appeal may be heard are required or empowered to send any article of food or drug to the Commissioners of Inland Revenue for analysis, the article shall be sent for the same purpose to the Commissioners of Customs and Excise, and shall be dealt with by them in conformity with those Acts.

19. Any references in sections 51 and 53 of the Licensing Act, 1872, in section 33 (except subsection 5) of the Customs and Inland Revenue Act, 1881, in sections 13 and 15 of the Corn Returns Act, 1882, in section 49 of the Licensing (Scotland) Act, 1903, in section 3 of the Licensing Act, 1904, in Rules 46, 49, 52, 55, and 56 of the Licensing Rules, 1904, and in section 17 of the Finance Act, 1907, to the Commissioners Revenue respectively shall be read as references respectively to the Commissioners of Customs and Excise and officers of those Commissioners.

The references in sections 3 and 4 of the Plate Assay (Ireland) Act, 1907, to the Commissioners of Inland Excise and Taxes, in section 26 of the Public Money Drainage Act, 1846, to the Receiver-General of Stamps and Taxes, and in section 11 of the London Hackney Carriage Act. 1853, to the Receiver-General of Inland Revenue, shall be read as references to the Commissioners of Customs and Excise.

The references in section 14 of the Plate Assay (Ireland) Act, 1807, to an Officer of Inland Excise and Taxes, and in section 7 of the Gold and Silver Wares Act, 1844, and section 5 of the Gold and Silver Wares Act, 1854, to an officer of stamp duties, shall be read as references to an officer of Customs and Excise.

The reference in section 21 of the Revenue (No. 2) Act, 1861, to the proper Collector of Inland Revenue shall be read as a reference to the proper Collector of Customs and Excise.

20. The Commissioners of Inland Revenue shall, until some other arrangement is made, continue to provide the stamps and labels to be used as labels and wrappers for denoting the amount of the duties charged and payable in respect of medicines, playing cards, and imitations of, and substitutes for, coffee or chicory.

21. Any enactment under which any penalty or forfeiture incurred under any Act relating to the Customs may be sued for and recovered by Order of the Commissioners of Inland Revenue

shall cease to have effect.

22. The benefits and advantages arising from membership of the Customs Annuity and Benevolent Fund, and the Inland Revenue Life Assurance Benevolent Fund Society, respectively, shall be available to all Collectors and officers of Customs and Excise, and all persons employed in the Department of the Commissioners of Customs and Excise.

Provisions as to Uniformity of Action and Procedure.

23. Section 32 of the Inland Revenue Regulation Act, 1890, which confers upon the Commissioners of Inland Revenue power to reward any person who gives information of any offence against any Act relating to the Excise, or assists in the recovery of any fine or penalty, shall apply in the case of the Commissioners of Customs and Excise, and shall have effect to the exclusion of the provisions in sections 211 and 212 of the Customs Consolidation Act, 1876.

24. Section 35 of the Inland Revenue Regulation Act, 1890, which confers upon the Commissioners of Inland Revenue powers to mitigate fines and stay proceedings, shall apply in the case of the Commissioners of Customs and Excise, and shall have effect to the exclusion of the provision in section 209 of the Customs

Consolidation Act, 1876.
25. Section 257 of the Customs Consolidation Act, 1876, which prescribes the time within which proceedings may be taken in the High Court of Justice in England or Ireland, or the Court of Session sitting as the Court of Exchequer in Scotland, for offences against the Acts relating to the Customs shall apply in the case of offences against the Acts relating to the Excise, and shall have effect to the exclusion of the provision in that behalf in subsection (2) of section 22 of the Inland Revenue Regulation Act, 1890.

26. The provisions of section 207 of the Customs Consolidation Act, 1876, which relate to the time within which notice of claim to seizures is to be given, shall apply in the case of goods seized as forfeited under the Acts relating to the Excise, and shall have effect to the exclusion of the provision in subsection (4) of section 25 of the Inland Revenue Regulation Act, 1890, relating to the time within which seizures may be claimed.

^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
