ACT OF ADJOURNAL relative to Prevention of Crime Act, 1908, 8 Edward VII., Cap. 59.

T Edinburgh, the Twenty-fourth day of June Nineteen hundred and nine.

Present,—

The Right Hon. The Lord Justice-General; The Right Hon. The Lord Justice-Clerk; The Right Hon. The Lord Kinnear;

The Right Hon. Lord Pearson.

The Lord Justice-General, Lord Justice-Clerk, and Lords Commissioners of Justiciary, by virtue of the powers conferred upon the Court by the Prevention of Crime Act, 1908, Do hereby Enact and Declare as follows :—

1. The Clerk of Justiciary shall be the Principal Clerk of the Court of Appeal, and is hereinafter referred to as "the Clerk." The First and Second Assistant Clerks of Justiciary shall be the Assistant Clerks of the Court of Appeal, and either of the said Assistant Clerks may act as Depute Clerk of the said Court in the absence of the Clerk through illness or other unavoidable cause. The Macers of the Court of Justiciary shall be the Macers of the Court of Appeal.

2. Where a person who has been sentenced to preventive detention desires to appeal under the said Act he shall within ten days from the date of the sentence lodge with the said Clerk a Note of Appeal, signed by himself or his Agent or Counsel, which may be in the form contained in Schedule A, and shall immediately after lodging the said Appeal send a copy thereof to the Crown Agent : Provided that the Court, on cause shown, may allow an Appeal to be lodged after the expiration of the ten days. 3. On an Appeal being lodged the Clerk shall give notice to the Prison Commissioners for Scotland.

4. The Clerk, on receiving the said Note of Appeal, shall request the Judge of the High Court of Justiciary who tried the case and pronounced the said sentence to furnish him with a copy of his notes of the evidence upon which the Appellant was found to be a habitual criminal, certified by him. The Clerk shall cause the said notes to be printed for the use of the Court of Appeal and the parties.

5. When the Court of Appeal fixes the day for the hearing of an Appeal, the Clerk shall give notice to the Appellant's Agent, who shall thereupon lodge three copies of the said Appeal for the use of the Court. The Clerk shall also give notice to the Prison Commissioners for Scotland conform to Schedule B, which notice shall be sufficient warrant to the said Commissioners for transmitting the Appellant in custody from Prison to the Court of Appeal for the diet of the Appeal and any subsequent diets thereof and for reconveying him to Prison at the conclusion of the said diet and any subsequent diets.

6. Unless the Court order otherwise the Appellant shall be present in Court during the hearing of his Appeal, and shall be brought to Court in ordinary civilian clothes.

7. The Court may continue the hearing of any Appeal to a day not fixed.

8. No Clerk's fees, Court fees, or other fees or expenses shall be exigible from or awarded against an Appellant in respect of an Appeal under the said Prevention of Crime Act, 1908.

9. Within eight days after the Appeal has been disposed of the Clerk shall notify the result of

the said Appeal to the Prison Commissioners for Scotland.

10. The Clerk of Justiciary shall in all cases of Appeal note on the margin of the record of the trial the fact of an Appeal having been taken and the result of the Appeal.

11. This Act of Adjournal shall come into operation on the first day of August 1909, and shall be printed and published in the Edinburgh Gazette.
