CHANCERY OF THE ORDER OF ST. PATRICK, DUBLIN CASTLE, December 16, 1909.

His Majesty the King, as Sovereign of the Most Illustrious Order of Saint Patrick, held an Investiture of the Order at Buckingham Palace on Monday the 13th day of December 1909, at 11 o'clock in the forenoon.

The Right Honourable Arthur Jocelyn Charles, Earl of Arran, was conducted to the Presence by the Officers of the Order in attendance with the usual reverences, in the following order:—

Captain Nevile Rodwell Wilkinson, Ulster King of Arms and Registrar, bearing the Insignia of the Order on a Cushion.

George Dames Burtchaell, Esquire, Athlone Pursuivant of Arms, bearing the Sword.

THE EARL OF ARRAN.

The Lord Chamberlain presented the Earl of Arran to receive the honour of Knighthood, and be invested with the Insignia of a Knight Companion of the Most Illustrious Order of Saint Patrick.

Ulster King of Arms took his place on the right of the Sovereign and Athlone Pursuivant on the left.

The Earl kneeling, Athlone presented the Sword to the Sovereign, who conferred upon the Earl the honour of Knighthood.

The Sovereign then invested the Earl with the Insignia presented by Ulster by placing the Ribbon with the Badge over the Earl's right shoulder, fixed the Star of the Order on his left breast, and pronounced the Admonition as follows:—

 - "and knowledge of this We give you and "present you this Badge, the which God
 - "will that you receive and wear from

The Earl, having kissed the Sovereign's hand, rose and subscribed the Declaration ordained by the Statutes in the Register of the Order.

THE MOTOR CARS REGULATION (COUNTY OF INVERNESS) (No. 2) ORDER, 1909. Dated 17th December 1909).

In pursuance of the powers vested in me by section 9, as read with section 18 of the Motor Car Act, 1903, I, the Right Honourable John, Baron Pentland, His Majesty's Secretary for Scotland, on the application of the County Council of the County of Inverness, being the local authority of the said County, do hereby make the following regulations:—

- 1. This Order may be cited as "The Motor Cars Regulation (County of Inverness) (No. 2) Order, 1909," and the regulations hereby prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.
- 2. A person shall not drive a motor car at a speed exceeding ten miles per hour within the limits or places specified in the schedule to this Order.
