Local Government (Scotland) Acts.

COUNTY COUNCIL ELECTORAL DIVISIONS OF FIFE.

Order by the Secretary for Scotland.

THEREAS the Contents and Boundaries of the Electoral Divisions of the County of Fife comprised in the Parish of Beath were determined by an Order under the hand and seal of the Secretary for Scotland dated 25th March 1901:

And whereas the County Council of the County of Fife have represented to me that it is desirable to divide the area comprised by the said Parish of Beath into three instead of two Electoral Divisions, and accordingly to alter the number of the County Councillors.

Now therefore I, the Right Honourable John, Baron Pentland, His Majesty's Secretary for Scotland, do, in virtue of the powers conferred on me by section 51 of the Local Government (Scotland) Act, 1889, order as follows:—

- The number of County Councillors for the County of Fife shall be increased from 61 to 62.
- 2. The Order of the Secretary for Scotland dated 25th March 1901, dealing with the Electoral Divisions of the County of Fife is hereby recalled in so far as it relates to the Parish of Beath in the County of Fife, and from and after this date the said Parish of Beath shall be divided into three Electoral Divisions having the following names and contents, that is to say:

Names of Electoral Divisions.	Contents of Electoral Divisions.
Cowdenbeath	The whole area in the Police Burgh of Cowdenbeath.
Beath, North	That part of the Parish of Beath which lies to the north of the following line, viz., a line from the eastmost point of the boundary between the Parishes of Beath and Ballingry which is touched by the Lochfilty Burn, following westwards the course of the said Burn to the Bridge near Muirtown Farm on the road between Cautsdam and Kingseat, thence in a straight line north-westwards to the entrance gate at Whitehouse Cottage on the road leading from Oakfield to Gask,
Beath, South	thence in a straight line to Wattiesford Bridge on the road leading from Gask to Nivenston, thence up the Drumnagoil Burn to the boundary between the Parishes of Beath and Dunfermline. That part of the Parish of Beath which lies to the south of the line above mentioned except the portion thereof which is included within the Police Burgh of Cowdenbeath.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 30TH JUNE 1910.)

INVERNESS-SHIRE (SKYE) AND OUTER ISLANDS) SHEEP-SCAB ORDER OF 1910.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1909, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Movement to Dipping Places.

- 1.—(1) Notwthstanding anything contained in Part II. of the Inverness-shire (Skye and Outer Islands) Sheep-Scab Order of 1909 (hereinafter referred to as the "principal Order"), sheep may be moved out of a Scheduled Area to a dipping-place if accompanied by a licence authorising such movement granted by an Inspector of the Local Authority of the District in which the sheep are when the licence is granted, or by an Inspector of the Board of Agriculture and Fisheries, and subject to the following conditions, namely:—
 - (a) The sheep shall after being dipped at the dipping-place be moved as soon as practicable back into the Scheduled Area from which they were moved to the dipping-place:
 (b) The movement of the sheep to and from

(b) The movement of the sheep to and from the dipping-place shall take place under the supervision of an Inspector or other officer of

the Local Authority:

- (c) During the movement of the sheep to and from the dipping-place and their detention thereat the sheep shall as far as practicable be kept separate from all other sheep.
- (2) Any dipping place which has been used for the dipping of sheep for the purposes of this Order shall, without unnecessary delay after each dipping and before any sheep are placed therein, be thoroughly cleansed by the occupier at his own expense and to the satisfaction of an Inspector of the Local Authority, and all tufts of wool gathered and disinfected or destroyed.

Alteration of Application of Principal Order.

2.—(1) The principal Order shall apply to the Scheduled Area described in the Schedule hereto.

(2) The provisions of the principal Order shall cease to apply to the Scheduled Areas numbered 1, 10, and 11 respectively in the First Schedule to that Order, except so far as any part thereof is comprised in the Scheduled Area described in the Schedule hereto.

Commencement, Construction and Short Title.

3. This Order shall come into operation on the twenty-fifth day of July nineteen hundred and ten, and shall be read with the principal Order, and that Order and this Order may be cited as the Inverness-shire (Skye and Outer ISLANDS) SHEEP-SCAB ORDERS OF 1909 AND 1910.

AYRSHIRE (MOVEMENT OF SHEEP) ORDER OF 1910.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1909, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :-

Premises to which this Order applies.

I.—(1) This Order shall apply to the premises described in the Schedule hereto, and also to any premises in the neighbourhood to which the Order may be applied by a Notice to that effect signed by an Inspector of the Board or of the Local Authority of the District in which such premises are situate and served upon the occupier

of the premises described in such Notice.
(2) This Order shall cease to apply to any premises upon service on the occupier thereof of a Notice to that effect signed by an Inspector of

the Board.

(3) A copy of every Notice served under this Article shall forthwith be sent to the Board by the Inspector signing the same.

Restriction on Movement of Sheep from Premises to which this Order applies.

- 2.—(1) Sheep shall not be moved from any premises to which this Order applies unless they are accompanied by a licence authorising such movement granted by an Inspector of the Local Authority of the District in which the sheep are when the licence is granted.
 - (2) Unless the Inspector is satisfied
 - (a) that the sheep are intended for exhibition or that on account of any special circumstances it is impracticable or inexpedient that the sheep should in accordance with the provisions of this Order be dipped before movement, or
 - (g) that the sheep are to be moved direct to a slaughterhouse,

a licence for movement under this Article shall be granted only for sheep which have, within twenty-eight days before the licence is granted, been dipped by a thorough immersion in an efficient sheep-dip in the presence, and to the satisfaction, of an Inspector of the Local Authority of the District, and have since the dipping been kept separate from other sheep not so dipped.

Production of Licences; Names and Addresses.

-(1) Any person in charge of a sheep being moved, where under this Order a licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other

officer.

Effect of Order.

4. The restrictions on movement of sheep imposed by this Order shall be in addition to any other such restrictions which may be in force during the operation of this Order.

Local Authority to enforce Order.

5. The provisions of this Order shall be executed and enforced by the Local Authority.

Offences.

- 6.—(1) If a sheep is moved in contravention of this Order, the owner of the sheep, and the person in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the sheep, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the sheep is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
 - (2) If a person in charge of a sheep being

moved, where under this Order a licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.

Interpretation.

7. In this Order, unless the context otherwise

requires—
"Efficient sheep-dip" means a sheep-dip approved by the Board for sheep-scab, or

purporting to be so approved:
"Inspector" includes Veterinary Inspector: "The Board" means the Board of Agriculture

and Fisheries:

"The Act of 1894" means the Diseases of Animals Act, 1894.

Commencement.

8. This Order shall come into operation on the eleventh day of July nineteen hundred and ten.

Short Title.

9. This Order may be cited as the AYRSHIRE (MOVEMENT OF SHEEP) ORDER OF 1910.
