Roads and Bridges (Scotland) Amendment Act, 1892 (55 & 56 Vict. c. 12).

ORDER by the Secretary for Scotland.

WHEREAS by the fifth section of the Roads and Bridges (Scotland) Amendment Act, 1892, it is provided as follows:—

Notwithstanding anything contained in section eighty of the Act first and second William the Fourth, chapter forty-three, as incorporated in the Roads and Bridges (Scotland) Act, 1878, the exemption from the general right of searching for, digging, and carrying away materials, as made in the said section eighty, shall be extended to such land or grounds as it may appear to the Secretary for Scotland, on the application of the proprietor thereof, desirable to preserve intact, on the ground of national or public interest or historical association.

And whereas an application has been made to me by the Town Council of the City of Edinburgh that the exemption from the general right of searching for, digging, and carrying away materials, may be extended to the lands known as the Blackford Hill, Edinburgh, so far as the same belong to the said Town Council.

Now therefore I, the Right Honourable John,

Baron Pentland, His Majesty's Secretary for Scotland, in pursuance of the powers vested in me by the said Roads and Bridges (Scotland) Amendment Act, 1892, do hereby determine that it is desirable to preserve intact on the grounds of national and public interest the lands known as the Blackford Hill, Edinburgh, so far as the same belong to the Town Council of the City of Edinburgh; and that the exemption from the general right of searching for, digging, and carrying away materials, as made in section eighty of the Act first and second William IV., chapter forty-three, as incorporated in the Roads and Bridges (Scotland) Act, 1878, shall extend to the said lands.
