ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 26TH JULY 1910.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1909, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Power to serve Notices as regards certain Sheep.

1. (1.) An Inspector of the Local Authority or of the Board of Agriculture and Fisheries may serve on the owner or person in charge of any sheep on the premises described in the Schedule. hereto, or of any sheep which have, on or since the first day of January, nineteen hundred and ten, been moved from such premises, or of any sheep which the Inspector has reason to believe to have been in contact with any such sheep, a Notice prohibiting movement of the sheep from the premises where the sheep are at the time of service of the Notice until the Notice is withdrawn, and requiring that such sheep shall, within four weeks from the date of this Order, be thoroughly dipped once, or if so stated in the Notice, twice, in the presence and to the satisfaction of an Inspector of the Local Authority, in a sheep-dip approved by the Board of Agriculture and Fisheries for Sheep-Scab, or purporting to be so approved.

(2.) A dipping shall be carried out on such date, not earlier than ten days after a previous dipping, at such dipping place and in such manner as shall be required by an Inspector of the Local

Authority.
