Local Government (Scotland) Acts.

COUNTY COUNCIL ELECTORAL DIVI-SIONS OF STIRLINGSHIRE.

PARISH OF KILSYTH.

ORDER by the Secretary for Scotland.

WHEREAS by Order of the Boundary Commissioners in Scotland, dated 22nd January 1892, the Parish of Kilsyth, exclusive of the portion included within the limits of the Burgh of Kilsyth, was formed into a County Council Electoral Division, named Kilsyth Electoral Division:

And whereas the County Council of the County of Stirling have represented to me that a material change of circumstances has occurred in respect of the population and annual value of the Electoral Division of Kilsyth, and that it is desirable to divide the area comprised in the said Electoral Division into two Electoral Divisions, and accordingly to alter the number of County Councillors:

And whereas I am of opinion that it is expedient to give effect to the proposal of the said County Council:

Now therefore I, the Right Honourable John, Baron Pentland, His Majesty's Secretary for Scotland, in virtue of the powers conferred on me by section 51 of the Local Government (Scotland) Act, 1889, and Acts amending the same, do hereby order as follows:—

- 1. The number of County Councillors for the County of Stirling shall be increased from forty-six to forty-seven.
- 2. The Kilsyth Electoral Division, as defined by the Order of the Boundary Commissioners for

Scotland, dated 22nd January 1892, shall be divided into two County Council Electoral Divisions having the following names and contents, that is to say:—

Names of Electoral Divisions.	Contents of Electoral Divisions.
Kilsyth (West)	That portion of the present Electoral Division of Kilsyth lying to the west of a line drawn down the centre of the Tak-me-doun Road in said Parish from the point where said road leaves the boundary between the Parishes of Denny and Kilsyth to the point where it enters the Police Burgh of Kilsyth, thence along the eastern boundary of said Burgh to the point where said Municipal boundary intersects the northern boundary of the Kilsyth Burgh School Board area and thence along the northern and eastern boundaries of said area till it reaches the southern boundary of the Parish near Craigmarloch.
Kilsyth (East)	The remaining portion of the present Electoral Division of Kilsyth lying to the east of the line above described.

3. A County Councillor shall be assigned to each of the said two Electoral Divisions of the Parish of Kilsyth.

Education (Scotland) Act, 1908.

PROPOSED ORDER BY THE SCOTCH EDUCATION DEPARTMENT.

SCHOOL BOARD OF GIRTHON. SCHOOL BOARD OF ANWOTH.

WHEREAS by subsection (1) of section 22 of the Education (Scotland) Act, 1908 (8 Edward VII., cap. 63), it is enacted that where it is represented to the Department by a School Board that it would be expedient that the district or part of a district of the said school board should be united with the adjacent district or part of district of another school board, so as for all purposes to constitute a district under one school board, the Department shall consult with the authorities concerned and may cause a local inquiry to be held, and, if they are of opinion that the districts should be united, may by order provide for uniting the said districts as aforesaid:

And whereas it has been represented to the Department by the School Board of Girthon that it would be expedient that the district of the said School Board should be united with the adjacent district of the School Board of Anwoth so as for all purposes to constitute a district

under one school board:

And whereas the Department, after consulting with the authorities concerned and causing a local inquiry to be held, are of opinion that the said districts should be united as aforesaid:

And whereas it is expedient that the said

districts should be united as aforesaid:

Now therefore the Department, in virtue of the powers in that behalf conferred upon them by the enactment above recited, do hereby order as follows: videlicet;

- 1. The district of the School Board of Girthon shall, from and after the date at which this order shall commence to have effect, be united with the district of the School Board of Anwoth so as for all purposes to constitute a district under one School Board.
- 2. The existing school boards shall cease to exist, and there shall be established in their room for the districts united as aforesaid one school board to be called "The School Board of Girthon and Anwoth."
- 3. The said School Board of Girthon and Anwoth (hereinafter referred to as "the School Board") shall consist of the ten members who at the date hereof constitute the existing school boards. The said members shall hold office until the school board election to be held in the year 1911 in terms of section 27, subsection (1) of the Education (Scotland) Act, 1908, after which date the number of members of the School Board shall be five.
- 4. The whole property heritable and moveable, real and personal, including the respective school funds and any funds held in trust, belonging to the existing school boards, shall be transferred to and vested in the School Board; and all teachers, janitors, officers, and other employees in the service of the existing school boards shall be transferred to, and become teachers, janitors, officers, and employees in the service of the School Board.
- 5. The whole debts and liabilities of the existing school boards shall be taken over by, and become debts and liabilities of, the School Board.
- 6. For a period of five years commencing with the 16th day of May 1911, the annual deficiency are duly qualified in other respects.

in the school fund of the School Board requiring to be provided by means of a local rate shall be provided in the manner following, that is to say, a special rate shall be levied upon the district of the existing School Board of Girthon of the amount of one penny in the pound. The remainder of the sum required in each year shall be provided by a uniform rate upon the whole of the School Board district constituted by this Order.

7. From and after the 16th day of May 1916, the arrangement provided for in the immediately preceding clause shall cease to have effect, and thereafter the deficiency in the School Fund of the School Board shall be provided by means of a rate levied upon the district of the said School

8. The whole expenses of the proceedings in connection with this Order shall be defrayed out of the school fund of the School Board.

9. In this Order the expression "the Department" means the Scotch Education Department.
