CIVIL SERVICE COMMISSION,

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz. :—

SPECIAL REGULATIONS respecting Open Competitive Examinations for the situation of Cartographer in the Hydrographic Department of the Admiralty. (Supplementary to the General Regulations respecting Open Competitive Examinations for situations in the Civil Service included in Schedule A of the Order in Council of the 10th January 1910.)

N.B.—These Regulations are liable to alteration from time to time.

1. The limits of age for this situation are 17 and 25, and Candidates must be of the prescribed age on the first day of the Examination.

2. The Examination will be in the following subjects, viz. :—

	Marks.
1. English	100
2. Mathematics	300
3. Map and Chart Projection... ..	300
4. Hydrographical Plan Drawing	300
5. French or German	100
6. Any second Continental European language or Japanese	100
7. Physical Geography	100
8. History or Chemistry or Physics	100

Candidates must pass to the satisfaction of the Civil Service Commissioners in each of the first five subjects.

3. Application for permission to attend an Examination must be made at such times and in such manner as the Civil Service Commissioners may appoint.

4. A fee of £5 will be required from each Candidate attending the Examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination for the situation of Cartographer in the Hydrographic Department of the Admiralty will be held in London, under the foregoing Regulations, commencing on the 8th December 1910.

The number of situations to be filled will be not fewer than three.

No person will be admitted to the Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 10th November, an application, in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.

ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 13TH SEPTEMBER 1910.)

EXPORTATION OF HORSES ORDER OF
1910 (No. 2).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1910, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Exemption from Veterinary Examination.

1. Section one of the Diseases of Animals Act, 1910 (in this order referred to as "the Act"), shall not apply to—

- (a) any horse, ass, or mule shipped to any port which is not in Europe; or
- (b) any horse, ass, or mule intended for breeding, racing, or exhibition, or of which the Board are satisfied, regard being had to its value and the purpose for which it is exported, that a veterinary examination is unnecessary; provided that, in every case to which this paragraph (b) applies, a permit signed by an Inspector or other officer of the Board authorising the shipment of the animal shall be obtained before its shipment.

Production of Permits.

2. A permit under this Order authorising shipment of an animal shall be delivered at the time of shipment to the master of the vessel on which the animal is shipped, who shall on demand produce the same to any constable or any Inspector or other officer of the Board or the Local Authority and allow such person to take a copy of, or extract from, the permit, and if the master fails to do so, or allows the animal to be shipped without delivery of the permit, he shall be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Fees for Examination under the Act.

3. The fee payable for the examination of an animal under the Act by a Veterinary Inspector shall be the sum of two shillings and sixpence for each animal, and such fee shall be paid before the examination takes place to the Veterinary Inspector, unless he is satisfied that it has been paid to the Board.

Marking of Certified Animals.

4. A Veterinary Inspector may for the purposes of identification mark an animal certified by him under the Act by affixing a label with the letter P together with a date, a number, or any other matter.

Horses rejected on Examination.

5. A Veterinary Inspector may for the purpose of enforcing the Act and this Order by notice in writing served on the person in charge of an animal rejected by him on examination under the Act direct him to remove it out of the wharf or other place from which it was intended to be shipped and to separate the animal from other horses, asses, or mules intended for shipment for such time as the notice may direct,

and if the person in charge fails to comply with any such direction he shall be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Enforcement by Local Authorities.

6. A Local Authority of a District in which is situate a port from which horses, asses, or mules are shipped to any port in Europe and outside the British Islands shall, subject to any exemptions sanctioned by licence granted by the Board, appoint such officers as may be required to supervise the shipment of horses, asses, and mules from that port, and to execute and enforce the Act.

Revocation of Order.

7. The Exportation of Horses Order of 1910 is hereby revoked as from the first day of October nineteen hundred and ten.

Interpretation.

8. In this Order—

"The Board" means the Board of Agriculture and Fisheries:

"Local Authority" means the Local Authority for the purposes of the Diseases of Animals Act, 1894:

"Port" includes place:

"Master" includes every person (except a pilot) having command or charge of a vessel.

Short Title.

9. This Order may be cited as the EXPORTATION OF HORSES ORDER OF 1910 (No. 2).
