The King's Most Excellent Majesty in Council.

WHEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation that he has received a copy of an Interlocutor of the Sheriff of Fife and Kinross at Kinross, dated the 9th August 1910, finding that the Burial Ground of the Parish of Cleish, in the County of Kinross, is offensive to decency and dangerous to health:

And whereas in the said Representation it is recommended that the said Burial Ground should be closed except in the case of a Heritor's family Burial Ground, where, in the opinion of the Parish Council, the ground is not overcrowded, and subject to the further conditions as regards all interments in the said Burial Ground after the date of the Order in Council directing the closing of the same (1) that the exercise of the right of burial shall not be injurious to public health; and (2) that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin:

Now, therefore, His Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of His Majesty's Most Honourable Privy Council on the 23rd day of November next.

And His Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or notice thereof, be affixed as required by the above-mentioned Act on the doors of the church of, or on some other conspictous places within, the parish affected by such Representation one month before such Representation is so considered.

<sup>\*</sup> Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
