#### TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of H.M. #### FACTORY AND WORKSHOP ACT, 1901.

In pursuance of section 1 of the Rules Publication Act, 1893, notice is hereby given that the Secretary of State for the Home Department proposes, at the expiration of 40 days from the publication of this notice, to make Orders applying the provisions of section 116 of the Factory and Workshop Act, 1901, with modifications, to—

(a) Non-textile Factories and Workshops or parts thereof in which the undermentioned classes of work, or any of them, are carried on, and to out-workers employed in those classes of work, and the occupiers and contractors by whom they are employed:—

(1) The making up, ornamenting, and repairing of table linen, bed linen, or other household linen (including in the term linen articles of cotton or cotton and linen mixtures);

(2) The making of curtains and furniture hangings and any processes incidental thereto;

(3) Processes incidental to the making of lace;

(b) Factories and Workshops or parts thereof in which the making of files is carried on:

(c) Factories and Workshops or parts thereof
in which the manufacture of toy balloons,
pouches, and footballs from indiarubber is
carried on;

(d) Factories and Workshops which are laundries;

(e) Factories and Workshops or parts thereof in which the making of iron safes is carried on.

#### FACTORY AND WORKSHOP ACT, 1901.

In pursuance of section I of the Rules Publication Act, 1893, notice is hereby given that the Secretary of State for the Home Department proposes, at the expiration of 40 days from the publication of this notice, to make an Order under sections 107, 108, and 110 of the Factory and Workshop Act, 1901, repealing and reenacting the Home Work Order of the 23rd May 1907, with the following extensions:—

(1) The application of the provisions of section 107 (relating to lists of out-workers), section 108 (relating to employment in unwholesome premises), and section 110 (relating to the prohibition of home-work in places where there is infectious disease), to the following classes of work:—

The making up, ornamenting, and repairing of table linen, bed linen, or other household linen (including in the term linen articles of cotton or cotton and linen mixtures);

The making of curtains and furniture hangings and any processes incidental thereto.

(2) The application of the provisions of sections 107 and 108 to—

The mixing, casting, and manufacture of brass, and of any articles or parts of articles of brass, and the electro-depositing of brass (including in the term brass any alloy or compound of copper with zinc or tin).
