SCOTTISH OFFICE, WHITEHALL, July 31, 1911.

NOTICE is hereby given that the Secretary for Scotland has confirmed the following byelaw passed by the Fishery Board for Scotland, viz.:—

Byelaw (No. 24) by the Fishery Board for Scotland, dated 16th June 1911, altering Byelaw No. 17 made by the Board under the Sea Fisheries (Scotland) Amendment Act, 1885.

Whereas Byelaw No. 20 (altering Byelaw No. 17) has expired, and whereas the question of its renewal, in so far as it applied to the Firth of Forth, has recently formed the subject of inquiry by the Fishery Board for Scotland:

Now, therefore, the Board, in virtue of the powers conferred upon them by section 4 of the Sea Fisheries (Scotland) Amendment Act, 1885, do hereby make the following Byelaw (No. 24) to replace the expired Byelaw (No. 20) in so far as the Firth of Forth is concerned:—

1. It shall be lawful to use a seine net, or a flounder net with a bag, in the capture of white fish during July, August, September, October, and November of each year, in the waters lying within three miles of low-water mark between a straight line drawn due north (magnetic) from Prestongrange House and a straight line drawn north-west (magnetic) from Gullane Ness, in the county of Haddington, respectively, provided (1) that, in the working of the net, only one boat shall be employed; (2) that the net shall be hauled in as soon as its ends have been brought together, and shall not be otherwise dragged or trailed along the bottom of the sea; (3) that the size of each mesh of the net so employed, and of any bag attached thereto, shall be such that a

square gauge of  $2\frac{1}{2}$  inches measured across each side of the square, or 10 inches measured round the four sides, will pass without pressure when the net is wet; (4) that the boat from which the net is used shall not exceed 30 feet of keel, and shall be propelled by means of sails or oars and not by any mechanical power; and (5) that no otter boards shall be used.

Except in so far as it is altered by this Byelaw, Byelaw No. 17 shall remain in force.

3. This Byelaw shall come into force from and after the date of its confirmation by the Secretary for Scotland, and shall remain in force for five years thereafter, unless it is sooner revoked or altered.
