<sup>\*</sup> Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

#### CIVIL SERVICE COMMISSION,

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, to come into force for any Examination which may be held during or after the autumn of 1912, viz.:—

SPECIAL REGULATIONS respecting Open Competitive Examinations for Clerkships in the Second Division of the Civil Service.

(Supplementary to the General Regulations respecting Open Competitive Examinations for situations in the Civil Service included in Schedule A of the Order in Council of 10th January 1910.)

### N.B.—These Regulations are liable to alteration from time to time.

- 1. The limits of age are 17 and 20. If an examination begins in one of the first six months of any year, candidates must be of the prescribed age on the first day of March in that year. If an examination begins in one of the last six months of any year, candidates must be of the prescribed age on the first day of September in that year.
- 2. The subjects of Examination will be as follows:—
  - 1. Handwriting.
  - 2. Copying Manuscript.
  - 3. English.
  - 4. Arithmetic.
  - 5. Elementary Mathematics.
  - 6. One of the languages—Latin, French, German.
  - A second language selected from Latin, French, and German, and not offered as subject 6.
  - 8. Bookkeeping and Stenography.
  - 9. History and Geography.
  - 10. Further Mathematics.
  - 11. Science.

Not more than two of the subjects numbered 7 to 11 may be offered.

3. Service marks for each full period of three calendar months of actual approved service, subject to a maximum of twelve of such periods, may be allowed to candidates attending an

examination who are serving or have served as Registered Boy Clerks or Boy Copyists, and have entered the service by the Competition of September 22nd, 1908, or any previous competition. To candidates who shall have been registered as Temporary Boy Clerks on the result of any competition subsequent to that of September 22nd, 1908, and shall have rendered not less than six months' approved service in that capacity, service marks may be allowed for each full period of three calendar months subject to a maximum of eight such periods.

- 4. Application for permission to attend an examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.
- 5. A fee of £2 will be required from every candidate attending an Examination.
