TRADE BOARDS ACT, 1909.

LACE FINISHING.

In accordance with Regulations made, under section 18 of the Trade Boards Act, 1909, by the Board of Trade, and dated 27th April 1910, the Trade Board established under the above Act for that branch of the Lace Finishing Trade which is engaged in Machine-made Lace and Net Finishing other than the finishing of the product of Plain Net Machines, have given notice, as

required by section 4 (3) of the above Act, that they have fixed a minimum time-rate of 2½d. an hour covering all processes in the above trade, special rates for learners, and also general minimum piece-rates for certain processes in the trade.

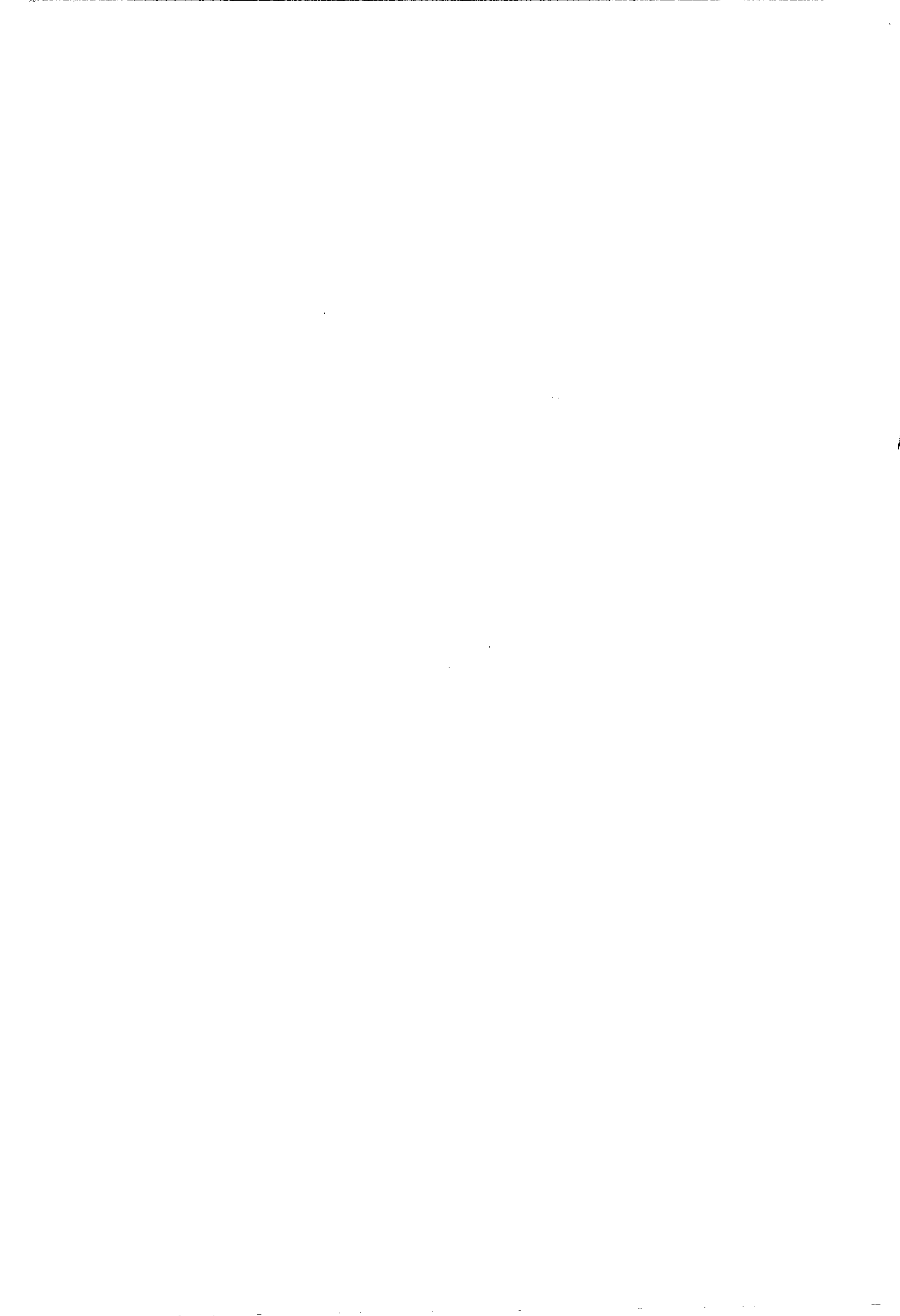
