ORDER by the Secretary for Scotland under section 17 (1) of the Prevention of Crime Act,

WHEREAS by section 17 (1) of the Prevention of Crime Act 1995 tion of Crime Act, 1908, it is provided that Part I. of the Act shall apply to Scotland (with the substitution of an institution under any name prescribed by the Secretary for Scotland for a Borstal Institution) on and after such date as may be determined by the Secretary for Scotland by Order issued under his hand and seal and published in the Edinburgh Gazette, which Order shall indicate the date on and after which such an institution will be established in Scotland.

And whereas on and after the 1st day of October 1911 Institutions under Part I. of the Prevention of Crime Act, 1908, will be established in Scotland: for males at Polmont, Stirlingshire, under the name of the Polmont Institution, and for females at Jessiefield, Dumfries, under the name of the Jessiefield Institution, Dumfries,

Now therefore I, the Right Honourable John, Baron Pentland, do, in virtue of the said provision, hereby determine that on and after the said 1st day of October 1911, Part I. of the Prevention of Crime Act, 1908, shall apply to Scotland.
