**THE PUBLIC HEALTH (FOREIGN MEAT)
AMENDING REGULATIONS (SCOT-
LAND), 1909.**

WE, THE LOCAL GOVERNMENT BOARD FOR SCOTLAND, in pursuance of the Public Health (Foreign Meat) Amending Regulations (Scotland), 1909, hereby give notice that, for the purposes of those Regulations, the Official Certificates of which the details are set forth in the representation or design in the schedule appended to and forming part of this Notice is, subject to the instructions given therein, hereby declared to be admissible, in the case of the Commonwealth of Australia, from the date of the publication of this Notice, in the manner, to the extent, and subject to the rules and conditions prescribed in this Notice, as evidence that the pig from which any foreign meat is derived has been certified by a competent authority in the place of origin to be free from disease at the time of slaughter, and that the meat has been certified by the like authority to have been dressed or prepared, and packed with the needful observance of all requirements for the prevention of danger arising to public health from the meat as an article of food:

AND FURTHER, with respect to the manner, to the extent, and to the rules and conditions in, to,

and subject to which every Official Certificate is admissible as evidence for any such purpose as is hereinbefore described, We hereby prescribe as follows, that is to say:—

(i) An Official Certificate used in relation to foreign meat, or in relation to a box, case, receptacle or package containing foreign meat shall be admissible as aforesaid only where the meat is derived from a pig.

(ii) An Official Certificate in the form of a label shall be admissible as aforesaid only where the label is securely affixed or attached to any foreign meat, or to any box, case, receptacle or package containing foreign meat; and where the label so affixed or attached has not, in any other circumstances, or on any other occasion, been used as an Official Certificate.

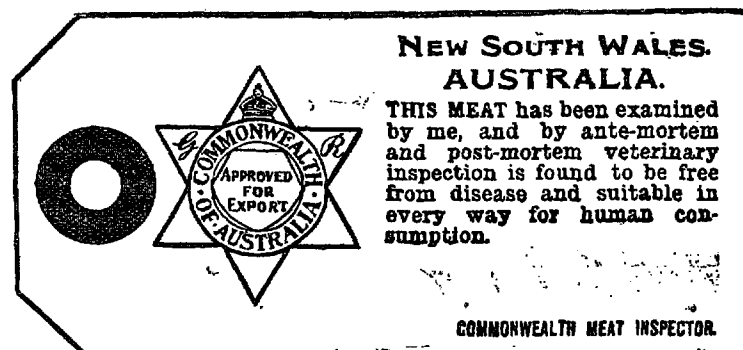
(iii) In this Notice, any word or expression to which a special meaning is assigned by the Public Health (Foreign Meat) Amending Regulations (Scotland), 1909, has the same meaning as in those Regulations.

AND FURTHER, We hereby declare that the Official Certificates hitherto admitted in the case of the States of Queensland, Victoria, and New South Wales, shall, from the date of the publication of this Notice, cease to be admissible.

SCHEDULE.

COMMONWEALTH OF AUSTRALIA.

A label, in the form of a combined certificate and stamp, having on it the subjoined representation or design, but subject to the condition that for the words "New South Wales" may be substituted the name of any other State comprised within the Commonwealth of Australia. Above the words "Commonwealth Meat Inspector" will appear the signature of the Inspector.

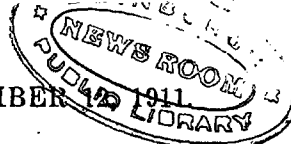

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 2ND SEPTEMBER 1911.)

SWINE-FEVER ORDER OF 1911.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered as follows :—

Revocation of provisions requiring Carting in certain cases.

1. So much of Article 5 of the Swine-Fever (Regulation of Movement) Order of 1908 as requires conveyance in a float, cart, or van, of swine which are being moved with a licence (Form D) is hereby revoked, and any other Order of the Board which incorporates such provision shall be modified accordingly.

Extension of duration of Movement Licences.

2. Any Order of the Board relating to swine-fever which provides that movement licences granted under the Order shall be available for six days, including the day of the date thereof, shall be read as if "eight" were substituted for "six."

Modification of Forms.

3. Forms prescribed by any Order of the Board relating to swine-fever shall be modified in accordance with the preceding Articles.

Keeping of Registers by Pig Dealers, Castrators, and Owners of Boars.

4.—(1) Every pig dealer shall keep a register in which there shall be correctly entered the following particulars, so far as they are known to the dealer, that is to say :—

- (i.) the date of each purchase of swine ;
- (ii.) the name and address of the persons from whom the swine were purchased ;
- (iii.) the number and description thereof ;
- (iv.) the date of the delivery of the swine to the dealer or to some person by his direction ;
- (v.) the date of each sale of swine ;
- (vi.) the name and address of the person to whom the swine were sold ;
- (vii.) the number and description thereof ;
- (viii.) the date of the delivery thereof to the purchaser or to some person by his direction ; and

(ix.) particulars of the death, or slaughter, or disposal by the dealer otherwise than by sale, of any swine in the possession of the dealer.

(2) Every castrator of swine shall keep a register in which there shall be correctly entered the following particulars, that is to say :—

- (i.) the date of each castration ;
- (ii.) the name and address of the owner, or person in charge, of the swine ; and
- (iii.) the number and description of swine castrated.

(3) Every owner of a boar used for the service of sows other than his own shall keep a register in which there shall be correctly entered the following particulars as regards each service, so far as the particulars are known to him, that is to say :—

- (i.) the date of each service ;
- (ii.) the description of the sow served ; and
- (iii.) the name and address of the owner of the sow.

(4) Every entry in a register shall be made in ink or indelible pencil within forty-eight hours after the purchase, delivery, sale, death, slaughter, disposal, castration, or service, as the case may be.

(5) Every register required by this Order to be kept by any person shall be produced by him for inspection at all reasonable times to any Inspector of the Board of Agriculture and Fisheries or of a Local Authority who so requires, and the Inspector shall be entitled to make copies of any entries therein.

(6) A Local Authority may supply registers for the purposes of this Order to any pig dealer, castrator, or owner of a boar who applies for the same and resides or carries on his business in the District of the Local Authority.

Cleansing and Disinfection by Castrators of Swine.

5.—(1) Any instrument used by a castrator of swine for the purpose of castrating swine shall forthwith after being used for such purpose and before being again so used for the purpose of castrating swine on other premises be thoroughly washed with soap and water, and shall then be disinfected with a solution of carbolic acid or other suitable disinfectant.

(2) Every castrator upon leaving any premises upon which he has castrated swine shall thoroughly wash his hands with soap and water, and his boots with a solution of carbolic acid or other suitable disinfectant.

Cleansing and Disinfection of Vehicles, Crates, &c., used for conveyance of Swine.

6.—(1) The floor of any van, cart, or other vehicle used in connection with the conveyance of swine along any highway or thoroughfare to

a market-place, fairground, or saleyard, and all other parts of any such vehicle with which any pig or its droppings have come in contact, and any crate, box, hamper, net, rope, or other thing used for such conveyance shall be cleansed and disinfected by the Local Authority of the District wherein the market-place, fairground, or saleyard is situate immediately after the removal of the swine from the vehicle and before it is moved from the market-place, fairground, or saleyard.

(2) The floor of any van, cart, or other vehicle used in connection with the conveyance of swine along any highway or thoroughfare to any place other than a market-place, fairground, or saleyard, and all other parts of any such vehicle with which any pig or its droppings have come in contact, and any crate, box, hamper, net, rope, or other thing used for such conveyance shall forthwith be cleansed and disinfected, by and at the expense of the person using the same for such purpose, upon the receipt of a notice in writing served by an Inspector of the Board of Agriculture and Fisheries or of a Local Authority requiring such cleansing and disinfection.

(3) The cleansing and disinfection required by this Article or by a notice served thereunder shall be carried out in the manner prescribed by Article 13 of the Swine-Fever Order of 1908.

(4) Articles 11 and 12 of the Swine-Fever Order of 1908 shall cease to apply where the conveyance is along a highway or thoroughfare to a market-place, fairground, or saleyard.

Straying of Swine from Infected Place.

7. Swine in a swine-fever infected place shall not be allowed by the owner or person in charge thereof to stray thereout.

Local Authority to enforce Order.

8. The provisions of this Order, except where it is otherwise provided, shall be executed and enforced by the Local Authority.

Offences.

9.—(1) If any person fail to keep a register as required by this Order, or makes any false entry therein, he shall be deemed guilty of an offence against the Act of 1894.

(2) If any person fail to cleanse and disinfect anything required by this Order to be cleansed and disinfected by him he shall be deemed guilty of an offence against the Act of 1894.

(3) If an owner or person in charge of a pig in a swine-fever infected place allows it to stray thereout he shall be deemed guilty of an offence against the Act of 1894.

Interpretation.

10. In this Order, unless the context otherwise requires—

“The Board” means the Board of Agriculture and Fisheries;

“The Act of 1894” means the Diseases of Animals Act, 1894;

“Inspector” includes Veterinary Inspector;

“Pig Dealer” means a person habitually engaged in the trade or business of selling swine (other than swine bred by him), but does not include a person who as auctioneer sells swine which are the property of another person.

“Castrator” means a person who castrates for reward.

Other terms have the same meaning as in the Act of 1894.

Revocation.

11.—(1) Article 16 (*Regulations of Local Authorities as to Keeping of Registers by Owners of Boars and by Pig Dealers*) of the Swine-Fever Order of 1908 is hereby revoked.

(2) All Regulations made or continued in force under the Swine-Fever Order of 1908, except Regulations as to entry of swine into markets, sales, &c., made under Article 15 of that Order, are hereby revoked.

Extent.

12. This Order extends to England and Wales and Scotland.

Commencement.

13. This Order shall come into operation on the first day of October nineteen hundred and eleven.

Short Title.

14. This Order may be cited as the SWINE-FEVER ORDER OF 1911.

ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 2ND SEPTEMBER 1911.)

SWINE-FEVER (SPECIAL AREAS)
ORDER OF 1911.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :—

Application of Swine-Fever (Regulation of Movement) Order of 1908, with Modifications.

1. The provisions of the Swine-Fever (Regulation of Movement) Order of 1908 (hereinafter referred to as "the principal Order"), and any Order amending that Order, shall apply to each of the Scheduled Areas described in the First Schedule hereto, but subject to the modifications hereinafter contained. Provided that the provisions of the principal Order relating to an Infected Area shall not apply to any part of any such Scheduled Area, unless such part is for the time being declared by Order of the Board to be, or form part of, a Swine-Fever Infected Area.

Restriction of Movement Facilities in certain Cases.

2.—(1) A licence (Form A) authorising movement to premises in a Scheduled Area described in the First Schedule hereto from premises not in any Area therein described shall be granted only in the case of swine which in the opinion of the Local Authority of the place of destination are required for breeding stock, and any licence so granted shall be granted by the Clerk of the Local Authority instead of being granted by an Inspector as provided by the principal Order.

(2) No such licence shall be granted for movement to a market, fairground, or saleyard.

Regulation of Movement of Swine from Markets.

3.—(1) The movement of swine from any market, fairground, or saleyard in a Scheduled Area described in the First Schedule hereto shall be subject to the following provisions of this Order.

(2) In the case of swine moved into the market, fairground, or saleyard from premises outside the Scheduled Area with a licence (Form A), the provisions of Article 4 of the principal Order shall apply to the subsequent movement of the swine :

(3) But if the market or saleyard is specially authorised by the Local Authority under the principal Order or the Swine-Fever (Movement from Ireland) Order of 1904, the movement of swine from the market or saleyard shall be subject to the provisions of Article 5 of the principal Order, except that the swine shall not be required to be conveyed in a float, cart or van.

(4) In the case of any other movement of swine from a market, fairground, or saleyard the movement shall be subject to the following conditions :—

(i.) The swine shall be accompanied by a licence (Form C) granted by an Inspector of the Local Authority of the District in which the market, fairground, or saleyard is situate.

(ii.) If the place of destination is outside the Scheduled Area it must be a bacon factory or slaughterhouse.

(iii.) The swine shall not, for a period of twenty-eight days after arrival at the place of destination specified in the licence, be moved from such place of destination except to a bacon factory or slaughterhouse, and only if accompanied by a licence (Form C) authorising such movement granted by an Inspector of the Local Authority of the District in which the swine are detained.

(iv.) Swine moved with a licence under this Article to a bacon factory or slaughterhouse shall be there detained until they are slaughtered.

(v.) Swine while detained under this Article shall be kept separate from all other swine.

Regulation of Markets, &c., in Scheduled Area.

4. No sale of swine shall be held in any market fairground, or saleyard in a Scheduled Area described in the First Schedule hereto unless it is authorised by the Local Authority of the District under this Order (which authority the Local Authority are hereby empowered to grant), or is specially authorised under the principal Order or the Swine-Fever (Movement from Ireland) Order of 1904.

Effect of Licences granted under this Order.

5. No licence shall be required under the principal Order for the movement into a Scheduled Area, or along, over, or across a highway or thoroughfare in a Swine-Fever Infected Area, of swine which are being moved under and in accordance with a licence granted under this Order.

Forms.

6. The Forms referred to in this Order are the Forms set forth in the First Schedule to the principal Order.

Saving of certain existing Local Orders.

7. Nothing in this Order shall affect the operation of any existing local Order not hereby revoked which modifies the provisions of the Swine-Fever (Regulation of Movement) Order of 1908 in relation to movement of swine in a float, cart or van, in any part of a Scheduled Area described in the First Schedule hereto.

Revocation.

8. The Orders described in the Second Schedule hereto, to the extent described in that Schedule, are hereby revoked as from the commencement of this Order.

Commencement.

9. This Order shall come into operation on the first day of October nineteen hundred and eleven.

Short Title.

10. This Order may be cited as the SWINE-FEVER (SPECIAL AREAS) ORDER OF 1911, and shall in relation to each of the Scheduled Areas described in the First Schedule hereto be read as part of the principal Order.

FIRST SCHEDULE.

*Scheduled Areas.**Scotland.*

(1) An Area comprising the counties of *Aberdeen, Argyll, Banff, Bute, Caithness, Clackmannan, Elgin, Fife, Forfar, Inverness, Kincairdine, Kinross, Nairn, Orkney, Perth, Ross and Cromarty, Stirling, Sutherland, and Zeland*, and the detached part of the county of *Dumbarton*; the cities of *Aberdeen, Dundee, and Perth*; and the burghs of *Peterhead, Campbeltown, Elgin, Dunfermline, Kirkcaldy, Arbroath, Brechin, Forfar, Montrose, Inverness, Falkirk, and Stirling*.

(2) An Area comprising the counties of *Dumbarton* (except its detached part), *Lanark, Peebles, and Renfrew*, and the burghs of *Airdrie, Dumbarton, Greenock, Hamilton, Paisley, Port Glasgow, and Rutherglen*, and the city of *Glasgow*.

(3) An Area comprising the counties of *Linlithgow* and *Midlothian* (except the parish of *Stow*), the burghs of *Leith and Musselburgh*, and the city of *Edinburgh*.

(4) An Area comprising the county of *Haddington*.

(5) An Area comprising the county of *Ayr*, and the burghs of *Ayr, Irvine, and Kilmarnock*.

(6) An Area comprising the county of *Wigtown*.

(7) An Area comprising the counties of *Dumfries* and *Kirkcudbright*, and the burgh of *Dumfries*.

(8) An Area comprising the counties of *Berwick, Roxburgh, and Selkirk*, and the burghs of *Hawick and Galashiels*, and also comprising the parish of *Stow*, in the county of *Midlothian*.

England and Wales.

(9) An Area comprising the administrative county of *Northumberland* (including the borough of *Berwick-upon-Tweed*), and the county borough of *Tynemouth*, the administrative counties of *Cumberland* and *Westmorland*, the petty sessional divisions of *North Lonsdale* and *Hawkshead* (including its detached part) in the administrative county of *Lancaster*, and the county borough of *Barrow-in-Furness*.

(10) An Area comprising the administrative counties of *Anglesey, Brecon, Cardigan, Carmarthen, Carnarvon, Denbigh* (excluding the petty sessional division of *Upper Chirk*—except such parts of the parish of *Llangadwaladr* as lie to the north of a line commencing at the boundary of that parish at *Tomen y Gwyddel* and proceeding westward along the fence, following the watershed by *Llyn Gloywbach* and *Pen Llyn Gloyw* to the boundary between the parishes of *Llangadwaladr* and *Llanarmon Dyffryn Ceiriog* on *Bryn Du*—and also excluding that part of the parish of *Glyn Traian* which lies to the south of the *River Ceiriog*), *Flint* (excluding the petty sessional division of *Overton*), *Glamorgan, Hereford, Merioneth, Monmouth, Montgomery* [excluding the borough of *Llanfyllin* and the parishes of *Hyssington, Snead, Aston, Castlewright, Llangynog, Hirnant, Pennant, Llanrhaidr-yn-Mochnant, Llanfechain, Llansaintffraid Pool, Llansaintffraid Deythur, Careghofa, Llandrinio, Llandysilio, Criggion, Bausley, Llanwddyn, Llanfihangel-yng-ngwynfa, and Meifod* (except the portion which lies to the south of that part of the *River Vyrnwy* between the *Broniarth Bridge* and *New Bridge Mechain*)], *Pembroke, and Radnor*, and the county boroughs of *Cardiff, Newport, Merthyr Tydfil, and Swansea*, and also comprising the parish of *Brompton and Rhiston*, and such parts of the parish of *Chirbury* as lie to the west of the *River Camlad*, in the administrative county of *Salop*, and the petty sessional division of *Newent* (except the parish of *Corse*), and the parishes of *Hewelsfield, Lancut, St. Briavels, Tidenham, Woolaston, and Staunton*, in the administrative county of *Gloucester*.

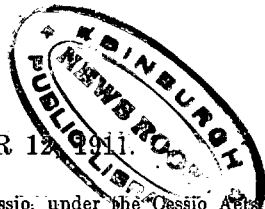
