## MOTOR CAR (INTERNATIONAL CIRCU-LATION) ORDER, 1910.

ORDER UNDER ARTICLE I. (2).

To the Scottish Automobile Club;

To the Automobile Association and Motor Union; And to all others whom it may concern.

WHEREAS by sub-division 1 of Article I. of the Motor Car (International Circulation) Order, 1910 (hereinafter referred to as "the Order "), it is provided as follows:—

" ARTICLE I.—(1) The Local Government "Board shall be the competent authority, and "they are hereby empowered to carry out in "accordance with, and subject to the provisions "of, this Order, the following duties, that is to "say—

"(a) To examine any motor car registered in "any part of the United Kingdom under "the provisions of the Motor Car Act, "1903, which is submitted for examina-"tion, and, if satisfied, after such ex-"amination

"(i.) that the motor car is suitable "for use on the highway in a foreign "country, and that it fulfils the con-"ditions specified in sub-divisions (1), "(2), (3), and (4) of Article 1 of the "First Schedule to this Order, or in "the case of a motor cycle, the said "conditions as modified by the para-"graph numbered (1) in Article 6 of "that Schedule; or

"(ii.) that the motor car is of a type "which is suitable for the purpose "aforesaid, and which complies with "the specified conditions;

- "to issue a Certificate of Fitness in the "Form A in the Second Schedule to "this Order, or in a form to the like "effect;
- "(b) To examine any person submitting him-"self for examination, and, if upon ex-"amination he is found to be competent, "to issue to him a Driver's Certificate of "Competence in the Form B in the "Second Schedule to this Order, or in a "form to the like effect: provided that "a Certificate of Competence shall not be "granted to any person who is under "eighteen years of age, or who does not "hold a licence to drive issued in pur-"suance of the Motor Car Act, 1903;
- " (c) To issue, subject to the conditions of "Article II. of this Order, to the owner " of any motor car registered as aforesaid, " an International Travelling Pass under " the seal of the Local Government " Board;
- "(d) To prescribe the type or types of motor "cars for the purposes of sub-division (ii.) "in paragraph (a) of sub-division (1) of "this Article."

And whereas sub-division (2) of Article I. of the Order empowers the Local Government Board, under such conditions as they think fit, to authorise by Order one or more Associations to perform all or any of the duties specified in sub-division (1) of that Article:

And whereas by Article VII. of the Order it is provided that in the application of the Order to Scotland there shall be submitted for a reference to the Local Government Board a reference to the Secretary for Scotland.

Now therefore I, the undersigned, His Majesty's Secretary for Scotland, in pursuance of the powers given to me in that behalf, and subject to any day of July 1911, notice of such Representa-Order which the Secretary for Scotland may hereafter issue, do hereby authorise should be taken into consideration by the Privy

to perform in Scotland all the duties specified in the hereinbefore recited sub-division (1) of Article I. of the Order.

The Order of the Secretary for Scotland, dated the fourth day of May 1910, is hereby revoked.

## The King's Most Excellent Majesty in Council.

HEREAS by "The Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it is provided that it shall be lawful for His Majesty from time to time, by Order in Council, upon the Repre-sentation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland as in the said first-named Act provided has been received by him, in pursuance thereof to order that no new burial ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland or (as the case may require) that after a time mentioned in the Order burials within certain limits, or in certain burial grounds or places of burial shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said first-named Act: provided always, that notice of such Representation and of the time it shall please His Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation, one month before such Representation is so considered:

And whereas the Secretary for Scotland has made a Representation that he has received a copy of an Interlocutor by the Sheriff-Substitute of Fife and Kinross at Dunfermline, finding that the Torryburn Churchyard, in the County of Fife, is so crowded with bodies that when graves are opened scenes occur which are offensive and contrary to decency.

And whereas in the said Representation it is recommended that the said Burial Ground should be closed as hereinafter directed.

And whereas by Order in Council of the 5th | At

day of July 1911, notice of such Representation was given, and it was ordered that the same should be taken into consideration by the Privy Council on the 14th day of August 1911, and that the said Order in Council or notice thereof should be published in the Edinburgh Gazette, and that copies of the said Order in Council or notice thereof should be fixed on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation one month before the said 14th day of August 1911.

And whereas notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and has been fixed in the manner required by the said Order in Council.

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, as it is hereby ordered, as follows, viz. :---

That from and after the 3rd day of April 1912 the said Torryburn Churchyard, in the County of Fife, be closed as a place of sepulture except for the burial of any person whose husband or wife has already been buried there.

Provided always as regards all interments in the said burial ground after the said 3rd day of April 1912 that the following conditions be observed: (1) that the exercise of the right of burial shall not be injurious to the public health or offensive or contrary to decency; (2) that notice shall be given to the Clerk to the Parish Council of Torryburn on the day preceding that on which a grave is to be opened; (3) that no interment shall, be made unless the coffin can be laid at a depth of three feet at least, and where possible at a depth of four feet, from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.

#### FOREIGN OFFICE, October 3, 1911.

His Majesty's Principal Secretary of State for Foreign Affairs has received from His Majesty's Ambassador at Rome a communication to the following effect :----

The Italian Government has notified the establishment of an effective blockade from September 29th by Italian Ships of War of the coast of Cyrenaica and Tripoli, from the frontier of Egypt to that of Tunis, between 11° 32' and 27° 54' longitude east of Greenwich.

"Turkish Government has notified Embassy that all Ottoman lighthouses from Cape Nagara, Dardanelles, as well as those of Adriatic and Red Sea, will be extinguished."

#### Therapia, October 2nd, 1911. 12.30 а.м.

" Porte has issued notice that vessels will not be allowed to pass Dardanells between lights of Siddil Bar and Koum Kale after sundown, and lights will be extinguished.

" Interested consulates informed."

#### FOREIGN OFFICE, October 6, 1911.

His Majesty's Secretary of State for Foreign Affairs has received from His Majesty's Ambassador at Rome a telegram stating that the Italian Government have issued a Declaration with respect to articles deemed by them to be Contraband of War during the existing hostilities between Italy and Turkey.

This Declaration, it is stated, specifies cannon, firearms, and sidearms of all descriptions, munitions of war, military tools of all kinds, and generally everything which without manipulation can be put to immediate use in connection with maritime or land warfare.

As soon as the actual text of the Declaration is received by His Majesty's Government it will be published in the London Gazette.
