THE MOTOR CARS REGULATION (COUNTY OF ABERDEEN) ORDER, 1912. Dated 22nd February 1912.

In pursuance of the powers vested in me by section 9, as read with section 18 of the Motor Car Act, 1903, I, the Right Honourable John, Baron Pentland, His Majesty's Secretary for Scotland, on the application of the County Council of the County of Aberdeen, being the local authority of the said County, do hereby make the following regulations:—

1. This Order may be cited as "The Motor Cars Regulation (County of Aberdeen) Order, 1912," and the regulations hereby

prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.

A person shall not drive a motor car at a speed exceeding ten miles per hour within the limits or places specified in the schedule to this Order.

TRADE BOARDS ACT, 1909.

In accordance with Regulations made under section 18 of the above Act, by the Board of Trade, and dated 27th April 1910, the Trade Board established under the above Act for that branch of the Box Trade in Great Britain which is engaged in the making of Boxes or parts thereof made wholly or partially of Paper, Cardboard, Chip, or similar material, have given notice, as required by section 4 (3) of the above Act, that they have fixed

MINIMUM TIME-RATES for the trade of making Boxes or parts thereof made wholly or partially of Paper, Cardboard, Chip, or similar material as follows:—

- (a) For female workers in a factory or workshop, not being a domestic workshop, 3d. an hour.
- (b) For female home-workers, including workers in a domestic workshop, 3d. an hour.

The above rates are to come into force on 11th March 1912, and are to apply to all female workers in the respective classes as specified above (excepting all female learners as defined by the Trade Board) who are during the whole or part of their time employed in the making of boxes or parts thereof as aforesaid, or in any branch or process thereof, but shall not apply to any female workers who are merely employed in work incidental or ancillary thereto.

The minimum (or lowest) time-rate for Learners under 14 years of age shall be 4s. a week, and on reaching the age of 14 they shall be entitled to the amounts shown in column 1 above as if they had commenced at 14.

The above rates are weekly rates based on a week of 52 hours, but they shall be subject to a proportionate deduction or increase according as

the number of hours actually spent in any week by the learner in the factory or workshop is less or more than 52.
