#### PRESENT,

The King's Most Excellent Majesty in Council.

THEREAS by section 45 of the Patents and Designs Act, 1907, it is provided as follows :-

(1) The exhibition of an invention at an industrial or international exhibition, certified as such by the Board of Trade, or the publication of any description of the invention during the period of the holding of the exhibition, or the use of the invention for the purpose of the exhibition in the place where the exhibition is held, or the use of the invention during the period of the holding of the exhibition by any person elsewhere, without the privity or consent of the inventor, shall not prejudice the right of the inventor to apply for and obtain a patent in respect of the invention or the validity of any patent granted on the application, provided that

(a) The exhibitor before exhibiting the invention gives the Comptroller the prescribed notice of his intention to do so; and

(b) The application for a patent is made before or within six months from the date of the opening of the exhibition.

(2) His Majesty may, by Order in Council, apply this section to any exhibition mentioned in the Order in like manner as if it were an industrial or international exhibitior certified as such by the Board of Trade, and any such Order may provide that the exhibitor shall be relieved from the condition of giving notice to the Comptroller of his intention to exhibit, and shall be so relieved either absolutely or upon

And whereas by section 59 of the said Act it is provided as follows :-

(1) The exhibition at an industrial or international exhibition certified as such by the Board of Trade, or the exhibition elsewhere during the period of the holding of the exhibition, without the privity or consent of the proprietor, of a design, or of any article to which a design is applied, or the publication, during the holding of any such exhibition, of a description of a design, shall not prevent the design from being registered, or invalidate the registration thereof, provided that

(a) The exhibitor before exhibiting the design or article, or publishing a description of the design, gives the Comptroller the prescribed notice of his intention to do so; and

(b) The application for registration is made before or within six months from the date of the opening of the exhibition:

(2) His Majesty may, by Order in Council, apply this section to any exhibition mentioned in the Order in like manner as if it were an industrial or international exhibition certified as such by the Board of Trade, and any such Order may provide that the exhibitor shall be relieved from the condition of giving notice to the Comptroller of his intention to exhibit, and shall be so relieved either absolutely or upon such terms and conditions as may be stated in

Now, therefore, His Majesty, in exercise of the powers conferred upon Him by the aboverecited sections, and by and with the advice of His Privy Council, doth order that the provisions of the foregoing sections of the said Act shall

apply to the International Exhibition to be held at Ghent in the year 1913, and doth further order that the exhibitor of an invention or of a design, or of any article to which a design is applied, shall be relieved from the condition of giving notice to the Comptroller of his intention to exhibit such invention or design, or article to which a design is applied.

The King's Most Excellent Majesty in Council.

WHEREAS by "The Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it is provided that it shall be lawful for His Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland as in the said first-named Act provided has been received by him, in pursuance thereof to order that no new burial ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland or (as the case may require) that after a time mentioned in the Order burials within certain limits, or in certain burial grounds or places of burial shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said first-named Act: provided always, that notice of such Representation and of the time it shall please His Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation, one month before such Representation is so considered:

And whereas the Secretary for Scotland has made a Representation that he has received a copy of an Interlocutor of the Sheriff-Substitute of the County of Kinross, dated the 21st November 1911, finding that the Burial Ground known as Old Fossoway Churchyard, in the Parish of Fossoway, in the County of Kinross, is offensive and contrary to decency:

And whereas in the said Representation it is recommended that the said Burial Ground should be closed as hereinafter directed.

And whereas by Order in Council of the 14th day of May 1912, notice of such Representation was given, and it was ordered that the same should be taken into consideration by the Privy Council on the 24th day of June 1912, and that the said Order in Council or notice thereof should be published in the Edinburgh Gazette, and that copies of the said Order in Council or notice thereof should be fixed on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation

one month before the said 24th day of June 1912

And whereas notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and has been fixed in the manner required by the said Order in Council.

And whereas the Lords of the Council have taken the said Representation into consideration, and also a Petition of the Heritors of the said Parish of Fossoway in opposition to the proposed reservations of right of interment in the said Burial Ground, and a further Petition of the surviving sons and daughters of the late James Anderson, Carnbo, in support of the proposed reservations in their favour.

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, as it is hereby ordered, as follows, viz.:—

That burials be forthwith discontinued in the Burial Ground known as Old Fossoway Churchyard, in the Parish of Fossoway, in the County of Kinross, subject to reservation of the right of interment, at decease, in the family lair or burying place of the Anderson family in the said Churchyard, for the five persons hereinafter named (being the surviving sons and daughters of the late James Anderson, Carnbo), viz., John Anderson, Robert Anderson, and James R. Anderson, and Margaret Anderson and Euphemia H. Anderson, with a further reservation of the right of interment at decease for William Mercer, The Moss, Muckhart. Subject to the usual provisions as regards all interments in the said burial ground after the date of this Order that the exercise of the right of burial shall not be injurious to the public health or offensive or contrary to decency, and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.

<sup>\*</sup> Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

Aberdeenshire, &c.—An Area comprising the Counties of Aberdeen, Argyll, Banff, Bute, Caithness, Clackmannan, Elgin, Fife, Forfar, Inverness, Kincardine, Kinross, Nairn, Orkney, Perth, Ross and Cromarty, Stirling, Sutherland, and Zetland, and the detached part of the County of Dumbarton; the Cities of Aberdeen, Dundee, and Perth; and the Burghs of Peterhead, Campbeltown, Elgin, Dunfermline, Kirkcaldy, Arbroath, Brechin, Forfar, Montrose, Inverness, Falkirk, and Stirling (1st October 1911).—See also under Dumbartonshire, &c.
