WHEREAS His Majesty, by virtue of the authority conferred on Him by the Copyright Act, 1911, and having regard to the provisions of the Berlin Copyright Convention, was pleased to make an Order in Council, dated the 24th day of June 1912 (hereinafter called the Principal Order), extending the protection of the said Act to certain classes of works to which protection is guaranteed by the said Convention;

And whereas the Kingdom of Denmark has ratified the said Convention subject to the reservation mentioned in the Schedule attached to this Order.

And whereas it is expedient that Article (2) Provisio (iii) (a) of the Principal Order should be extended so as to apply to newspaper articles (not being serial stories or tales) of which the country of origin is Japan.

Now, therefore, His Majesty, by and with

the advice of His Privy Council and by virtue of the authority conferred upon Him by the Copyright Act, 1911, is pleased to order, and it is hereby ordered as follows:—

(1) The Provisions of Article (2) Proviso (1), Article (2) Proviso (iii) (c), Article (2) Proviso (iii) (d), and Article (2) Proviso (iii) (e) of the Principal Order are hereby revoked so far as they relate to works of which the country of origin is Denmark, and the authors of all such works shall enjoy the same rights as if the said provisions had never related thereto.

(2) In the application of the provisions of Article (3) of the Principal Order to works of which the country of origin is Denmark, the date of this Order shall be substituted for the commencement of the Act and for the com-

mencement of the Principal Order.

(3) Where any person has, before the date of this Order, taken any action whereby he has incurred any expenditure or liability in connec-

tion with the reproduction or performance of any work at a time when such reproduction or performance would but for the making of this Order have been lawful, nothing in this Order shall diminish or prejudice any rights or interest arising from, or in connection with, such action which are subsisting or valuable at the said date unless the person who, by virtue of this Order, becomes entitled to restrain such reproduction or performance agrees to pay such compensation as, failing agreement, may be determined in accordance with the provisions of the Copyright Act, 1911.

(4) The Provisions of Article (2) Proviso (iii) (a) of the Principal Order shall apply as if Japan were included amongst the foreign coun-

tries named in those provisions.

And the Lords Commissioners of the Treasury are to give the necessary orders accordingly.

WHEREAS His Majesty, by virtue of the authority conferred on Him by the Copyright Act, 1911, and having regard to the provisions of the Berlin Copyright Convention, was pleased to make an Order in Council, dated the 24th day of June 1912 (hereinafter called the Principal Order), extending the protection of the said Act to certain classes of works to which protection is guaranteed by the said Convention:

And whereas the Kingdom of the Netherlands has acceded to the said Convention, subject to the reservations mentioned in the Schedule to this Order.

Now, therefore, His Majesty, by and with the advice of His Privy Council, and by virtue of the authority conferred upon Him by the Copyright Act, 1911, is pleased to order, and it is hereby ordered, as follows:—

The Principal Order shall extend to the Nether-

lands, as if that country were amongst the foreign countries of the Copyright Union therein named, subject to the following modifications:-

(a) The provisions of Article (2) Proviso (iii) (b) and of Article (2) Proviso (iii) (c) of the Principal Order shall apply as if the Netherlands were included amongst the foreign countries named in those provisions.

(b) In the application to works of which the country of origin is the Netherlands of section 1 (2) (d) and 19 of the Copyright Act, 1911, the date of this Order shall be substituted for the commencement of the Act in sections 19 (7) and 19 (8) wherever that expression occurs, and the 1st November 1912 for the passing of the Act.

(c) In the application to such works of the provisions of section 24 of the Copyright Act, 1911, the date of this Order shall be substituted for the commencement of the Act wherever that expression occurs in subsection (1) (a) and for the 26th July 1910 in sub-

section (1) (b).

(d) In the application to such works of the provisions of Article 3 of the Principal Order the date of this Order shall be substituted for the commencement of the Principal Order.

And the Lords Commissioners of His Majesty's Treasury are to give the necessary orders accordingly.

WHITEHALL, March 13, 1913.

His Majesty the King has been graciously pleased to award the Edward Medal of the Second Class to Albert Benstead under the following circumstances:—

On the 14th January 1913, Charles Jex was cleaning the roof over the smelting furnaces at Messrs. Bolckow, Vaughan, and Co.'s steel works, and, while he was making his way along an iron beam thirty-two feet from the ground and immediately above a fifty-ton ladle, which was being filled with molten metal, a column of flame and smoke shot up from the ladle to a height of thirty or forty feet. The flames enveloped Jex, burning him so badly that he was rendered helpless and barely able to retain his foothold on the beam. Had he slipped, he would have fallen into the ladle. Benstead was standing near the foot of an iron ladder twenty-five feet long, leading to the beam, and immediately climbed up and took hold of Jex, whose hands were so badly burnt that he could not assist himself in descending the ladder. Benstead placed him across his back and carried him down to the floor, the iron ladder being so hot that he had to use his cap to take hold of it, and so steady himself as he came down. There is no doubt that Benstead saved Jex from falling into the ladle, and that he ran a very serious risk of falling in himself.

WHITEHALL, March 13, 1913.

His Majesty the King has been graciously pleased to award the Edward Medal of the Second Class to Robert Ward and James Jones under the following circumstances:—

On the 21st November 1912, two workmen, named John Lloyd and Morris Edwards, were employed in excavating a deep sewer trench at Old Colwyn, when the sides of the trench suddenly gave way. There was a heavy fall of earth and timbering, and both men were buried at the bottom. Robert Ward and

them. The trench was fourteen feet deep, and the two men had been working separate sections seven feet long by three and a half wide. Soil and timber fell in to the depth of about four feet, and Ward and Jones had to begin their work of rescue at a depth of about ten feet. They had to remove practically all the fallen material in order to reach the two men. The soil was sand and gravel, and the danger of working was largely increased by the presence of water at the bottom, and, as they dug further down, the risk increased. They persisted in their efforts for three and a quarter hours, and though John Lloyd was dead when they reached his body, they succeeded in saving the life of Morris Edwards. There is no doubt that the two men ran a great risk of a further fall of earth and timber, and of being buried themselves.

CIVIL SERVICE COMMISSION, March 18, 1913.

GENERAL REGULATIONS respecting Open Competitive Examinations for situations in the Civil Service, included in Schedule A of the Order in Council of 10th January 1910.

N.B.—These Regulations are liable to alteration at any time.

1. Competitive examinations of Candidates for situations in the different public Departments will be held at such times and at such

places as may be deemed expedient. Before every such Examination Special Regulations will be issued, in which the particular conditions of the competition will be specified.

2. These Examinations are open to all naturalborn or naturalised British subjects, being of the requisite age, health, and character, subject to such restrictions as are herein contained, and to Special Regulations affecting the particular situations.

(i.) The following persons are ineligible, viz.:—

Members of the Royal Irish Constabulary of less than five years' service.

- (ii.) The following classes of persons are eligible under certain conditions only, that is to say:—
 - (a) Persons actually serving in the Army.
 - (b) Persons actually serving in the Navy.
 - (c) Persons holding situations in the Civil Service.
 - (d) Members of the Royal Irish Constabulary of more than five years' service.
 - (e) Aprentices in His Majesty's Dockyards.
 - (f) Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer.

No person actually serving in the Army will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the Examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Army Council.

No person actually serving in the Navy will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the Examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Lords Commissioners of the Admiralty.

Persons comprised in the classes (c), (d), (e) must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.

Persons comprised in class (f) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

To transfer to, take over, and vest in the Town Council of the extended Burgh, and thereafter to manage and maintain out of their assessments, revenues, and funds, or otherwise, as the Order may prescribe, the streets and roads, foot pavements and footpaths, public or private bridges, or some one or any of them, within the districts annexed, and the sewers, drains, mains, and pipes therein or thereunder, or some or any of them, or within any special district within the districts annexed, and to apply all or some of the powers of the Town Council of the extended Burgh, or the powers of the Town Council of the existing Burgh, to all public or private sewers and drains within the districts annexed, and to separate all such roads, sewers, drains, mains, and pipes from the jurisdiction and authority of any County Council, District Committee, or of any Road Board, Trust, or other authority, or any Committees thereof, and to relieve such respective authorities from the future management and maintenance thereof, and to sanction and confirm any agreement which may be made with respect to the said matters, and to make such other provision with respect thereto as the Order may prescribe.

To confer upon the Town Council of the extended Burgh, as well as in their corporate municipal capacity, as in all other capacities whatsoever presently existing for executing the local Acts, or any of them, or any of the public and other Acts and Orders with reference to and within the districts annexed, all or some of the powers which they now have within the existing Burgh, or such other similar or other powers as the Order may define, and particularly powers to impose, levy, and collect within the districts annexed the same rents, tolls, rates, guarantee rates, duties, and assessments and charges as they now or may impose, assess, levy, and collect within the existing Burgh, with such alterations, additions and exceptions, variations and abatements, or such other rents,

tolls, rates, guarantee rates, duties, and assessments, all as the Order may provide, or as may be provided and required by any existing or future Act, whereby any alteration is or may be made as to the apportionment and collection of rates and assessments, and to confer, vary, extinguish exemptions from the payment of rents, tolls, rates, guarantee rates, duties, assessments, and charges, and to continue exemptions in favour of any body or person, or description of property, or to vary and alter or extend any existing exemption from rates and assessments, either in the existing Burgh or within the districts annexed, or any part thereof, and also to make such allowances, rebates, abatements, and deductions and exemptions from rents, tolls, rates, guarantee rates, duties and assessments leviable within the existing Burgh and the districts annexed, and the extended Burgh, or some part or parts thereof, either permanently or for limited periods, and for such purposes and considerations, and to such ratepayers, and to make agreements thereanent, all as may be specified in the Order, or agreed before the passing or the granting of the Order.

To provide for the water supply of the districts annexed, and to withdraw the said districts from the area of the water supply of the County Council, or any District Committee of the County of Lanark, and to add the districts annexed to the compulsory water supply area of the existing Burgh, and to include the same therein, or otherwise as the Order may prescribe.

To provide for the inclusion of the whole of the existing Burgh within the compulsory water supply area of the Town Council, as the local authority therein, and to withdraw such parts of the existing Burgh as are within the water supply area of the County Council of the County of Lanark, and of the District Committee of the Middle Ward of that County, from the area and jurisdiction for water supply, and from the rating powers of the County Council and the Middle Ward District Committee, and to amend and extend the provisions of the Motherwell Burgh Extension and Sewage Purification Act, 1908, accordingly, and to confer on the Town Council the powers, rights, and jurisdiction with respect to the supply of water to such area, and to repeal Section 24 of the said last-mentioned

To amend Sections 26, 28, and 29 of the Motherwell Water (Additional Supply) Act, 1900, and to make it imperative on, and to require the District Committee of the Upper Ward of the County of Lanark, and the County Council of the County of Lanark, or either of them, to take from the Town Council, and to pay for the quantity of water which, under the said Section 26 of the said last-mentioned Act, the Town Council are bound as therein mentioned to furnish, and in like manner to make it imperative on, and to require the District Committee of the Middle Ward of the County of Lanark, and the County Council of the County of Lanark, or either of them, to take from the Town Council, and to pay for the quantity of water which, under Section 28 of the said lastmentioned Act, the Town Council are bound as therein mentioned to furnish, and to provide for the ascertainment of the price to be paid for such respective supplies of water, and to make

ing the said District Committees respectively, | and the said County Council, the supplies of water which they may be required under the Order to take from the Town Council.

To provide for, and to extend the supply of gas and electricity of the Town Council for all purposes within the districts annexed, and to provide for the levying of assessments and recovery of rates and assessments and charges in respect of water, and gas, and electricity within the extended Burgh, as well as for the levying and recovery therein of any guarantee rate leviable by the Town Council within the existing Burgh.

To repeal all or some of the existing powers of imposing, levying, and collecting tolls, rates, duties, cess, assessments, and charges within the districts annexed, or some part or parts thereof, and to confer further and other powers on the

Town Council of the extended Burgh.

To make all necessary and requisite provisions with regard to certificates and licenses under the Licensing (Scotland) Acts presently in force, or which shall or may come into force, within the extended Burgh, and with respect to existing certificates or licenses under the said Acts in the districts annexed, and to provide for the exercise within the extended Burgh of all powers of licensing and granting certificates and re-newals by the Magistrates of the extended Burgh within the districts annexed, and with respect to the Court of Quarter Sessions, Licensing Appeal Courts, or others, and to make such provisions with respect to the exercise of such powers and jurisdictions as will enable the Magistrates of the extended Burgh to exercise the same over the districts annexed, in the same manner and to the same effect as the Magistrates of the existing Burgh may or do exercise such functions or jurisdictions over the existing Burgh.

To retain, abolish, or alter, all offices now held under any local authorities or bodies within the districts annexed, or within the existing Burgh, and to provide that all or any Acts or Orders, public, local, or private, as are now in force, or are applicable within the districts annexed, or within the existing Burgh, or any part thereof, shall or may cease to be applicable thereto, or

otherwise as the Order may prescribe.

To enable the Town Council of the extended Burgh to alter, vary, and rescind bye-laws, rules, orders, regulations, and resolutions now in force within the districts annexed, or the existing Burgh, and to provide for the continuance of the same therein until cancelled by the Town Council of the extended Burgh, and to provide for the existing bye-laws of the existing Burgh being applicable to the extended Burgh, and to make all such further bye-laws and others as aforesaid as may be necessary, or may be required for any of the purposes of the Order, and to prescribe penalties for breach or non-observance of byelaws, and to provide for the recovery of penalties.

To authorise the Town Council of the existing Burgh and of the extended Burgh to make agreements with the County Council, or with any County Authority or Local Authority, Company, or person having jurisdiction over the districts annexed, as to any payments to be made, and also in respect of any matters arising in connection with the extension of the existing Burgh, and to confer on the Town Council of the extended Burgh, and on such authorities, or any

such provisions as may be necessary for afford-! of them, all such powers as may be necessary or expedient or arising out of the provisions and purposes of the Order for carrying the same into effect.

To authorise the Town Council to purchase, feu, lease, or acquire by compulsion or by agreement, and to hold, use, and apply lands and other property for sewage purification works aftermentioned, and for the purposes of sewage purification and purposes incidental thereto, and to appropriate and use such lands respectively for those or any other purposes, and to construct and maintain all necessary works therein for sewage purification, and to exempt such lands from the provisions of the Lands Clauses Acts with respect to the sale of superfluous lands. The lands intended to be so acquired for the purification works and purposes incidental thereto are the following:-

- (1) A piece of land in the Parish of Dalziel and County of Lanark being the enclosures numbered 548 and 549 on the Ord-nance Survey Map of the said Parish (1-2500) scale marked edition of 1912.
- (2) A piece of land in the Parish of Dalziel and County of Lanark being the enclosure numbered 444 and parts of the enclosures numbered 443 and 445 on the Ordnance Survey Map of the said Parish (1-2500 scale) marked edition of 1912, and lying within the following boundaries, namely, commencing at the north-west corner of the said enclosure numbered 444, thence south-westward and generally southward along the boundaries of the said enclosure numbered 444 for a distance of 387 yards or thereby, thence southward for a distance of 67 yards or thereby in the said enclosure numbered 445, thence eastwards for a distance of 143 yards or thereby in the said enclosures numbered 445 and 443, thence northwards for a distance of 262 yards or thereby in the said enclosure numbered 443 to join the north-east boundary of the said enclosure numbered 444, thence along the said north-east boundary of the said enclosure numbered 444 for a distance of 207 yards or thereby to the point of commencement.

- (4) A sewer (Work No. 4) situated wholly in the Parish of Dalziel and County of Lanark, commencing by a junction with the existing sewer 165 yards or thereby west from the west side of Kethers Bridge continuing generally in a north-westerly direction, and terminating in the enclosure numbered 443 on the Ordnance Survey Map (1-2500 scale) marked edition of 1912.
- (5) A sewer (Work No. 5) situated wholly in the Parish of Dalziel and County of Lanark, commencing by a junction with the existing sewer in Ladywell Road at a point ten yards or thereby north-east of the point where the Burgh Boundary of the Burgh of Motherwell intersects the said road, continuing generally in a south-westerly and north-westerly direction, and terminating by a junction with Work No. 6 at a point 61 yards or thereby measured in a north-easterly direction from the north-west corner of enclosure numbered 413 on the Ordnance Survey Map (1-2500 scale) marked edition of 1912.
- (6) A sewer (Work No. 6) situated wholly in the Parish of Dalziel and County of Lanark, commencing by a junction with the existing sewer at a point 107 yards or thereby west of the west side of the bridge carrying the roadway of Muir Street over the line of the Caledonian Railway from Motherwell to Buchanan Street, Glasgow, and the North, continuing generally in a south-westerly direction and terminating in the enclosure numbered 443 on the Ordnance Survey Map (1-2500 scale) marked edition of 1912.

To authorise and empower the Town Council on the said lands hereinbefore described, intended for the purposes of sewage purification, or on any part or parts thereof, to carry out the treatment and purification of the sewage and other discharges from the main and branch sewers and drains constructed and to be con-

structed, and to prevent the sewage and refuse of the existing or the extended Burgh and the discharges from the works and manufactories therein being discharged into the rivers Clyde and Calder, or either of them, or the tributaries thereof, and to authorise the Town Council to discharge the effluents from the purification works into the said rivers, or any of them.

To empower the Town Council to enlarge the existing sewers anid drains, and to make said alterations in the positions of existing sewers or drains, and to construct, lay down, and maintain all necessary and proper drains, channels, conduits, cuts, tunnels, sluices, bye-washe, upstands, man-holes, offlets, overflows, cleaning-shafts, entrances, culverts, ventilators, and settling and depositing tanks or places, work, and conveniences necessary to be used in connection with any existing main and brank sewers, or for any of the other objects and purposes of the sewage purification part of the Order.

To authorise the Town Council, notwith standing anything contained in the Land Clauses Consolidation (Scotland) Act, 1845, to acquire portions only of lands and other property.

To authorise the Town Council in the construction of the several works hereinbeford described to deviate from the lines, situation, and levels thereof, as delineated on the plant and sections hereinafter mentioned to the extended fined thereon respectively, or provided by the Order.

To enable the Town Council to cross, alter stop up, or divert, whether temporarily of permanently, all roads, footpaths, towing path foreshore, railways, rails, tramways, riest navigations, streams, sewers, and other work and to alter or remove any telephonic, electric or telegraphic wires, posts, tubes, or apparate gas pipes, water pipes, and hydrants, as may be necessary or convenient in constructing of maintaining the said sewers and works here before described.

To authorise the Town Council to horow,

and, from time to time, to re-borrow money for all or any purposes of the Order and of the Burgh, and to exercise all such powers over the extended Burgh as they now have or may exercise within the existing Burgh, together with any extension of such powers under the Order, and under any local or public general Acts in force for the time. To provide for the repayment of money already borrowed for any of the purposes of the Town Council already authorised, and of money to be borrowed under the Order, and to extend and define the period for repayment of such money already borrowed and to be borrowed for all or any of such purposes for which money may be borrowed by the Town Council, under any Act or Order, public or private, and the Order.

To repeal, vary, or extinguish all rights, powers, authorities, jurisdictions, privileges, and exemptions which may in any way interfere with any of the objects and purposes of the Order, and to confer. vary, or extinguish other rights, powers, authorities, jurisdictions, privileges, and exemptions.

To alter, vary, amend, and extend, or repeal or, if necessary or expedient, to make applicable to the Order, all or some of the provisions of the following Acts and Orders, with such amendments or variations as the Order may provide, that is to say, the Burgh Police (Scotland) Acts, 1892 to 1911; the Town Councils (Scotland) Acts, 1900 and 1903; the Burgh Sewerage, Drainage, and Water Supply (Scotland) Act, 1901; the Motherwell Electric Lighting Order, 1895, and any Acts relating or applicable to the existing burgh or the districts annexed; the Roads and Bridges (Scotland) Act, 1878; the Roads and Bridges (Scotland)
Act, 1878, Amendment Act, 1888; the Roads
and Bridges in Police Burghs (Scotland) Act,

other Acts or Orders relating to the existing Burgh, or some of them.
